1. 1.2 Background: Will you let us know if the utilities will be installed by May 1st? Should we quote both ways: 1. With utilities provided by client, and 2. Us providing all utilities

A. Contractor should provide all utilities NLT 1 May.

2. Will there be an additional site visit to survey the site to determine site prep work? If so, when?

A. Due to time requirement constraints, there shall be no additional site visits conducted

3. Is the ground level? Has flooding been an issue?

A. The ground is partially level, but the back half of the parade field sits low and has dips. There has been issues in the past with flooding when it rains. Raised flooring is recommended as stated in the PWS.

4. 3.3.1 – Single Point of Access for Water and Power – Will there be only one access point for water for all assets.

A. Yes, the source is located on the parade field.

5. Can we park a fuel truck, potable water truck, and vacuum truck on-site to service the equipment?

A. Yes

6. Do the truck drivers need to take the Anti-terrorism course to deliver and service

the assets?

A. Yes within 30-days prior to executing the service.

7. Will you identify the 150 remaining cadets that will stay for the second month of training? Will we be able to construct separate living quarters for them so we can demobilize our assets once the first month is complete (the 550 cadets leave)?

A. Yes the 150 cadets that will stay will be identified.

8. What is the approximate distance from Buckner Field to Range 3?

A. Approximately 2 miles

9. 1.6.8 Post Award Conference- does this need to be in person, or can it be done via Zoom or Teams?

A. Winning offeror MUST be present at the West Point contracting office for the Post Award Conference.

10. Does the Diesel need to be Red Dye or clear?

A. Red Dye

11. Can our regular drivers for services be given a pass to gain entry to West Point (propane, cleaning, etc.) if they are going to remain the same for the duration of the contract?

A. Drivers do not need to access West Point installation. All contract requirements are located in the training areas.

12. Will another size floor be acceptable to the USA ACC MICC? – We are meaning the height of the floor. We have a less expensive Dura-track that is commonly used for this application and is normal usage in the field -- these are interlocking plastic 4' x 4' 1.5 height (elevated). The total square feet will be the same--we just want to know if the commercial application will be acceptable and we can provide specifications.

A. Yes the commercial application is acceptable as long as the height requirement is met.

13. Para. 3.3.1. Para. 4.2.6. Did we get the government furnished utilities operational in time for last few years performances? In other words did we have the contractor or government provide the power source as tentatively planned here prior to start of contract/exercise (we understand this year may be different); The Government is processing plan to install NLT 01 MAY, stepped down power,

ending at wire of 370A for the 150kVA @ 120/208VAC, 3PH, 4W AND 900A for the 750kVA @ 277/480VAC, 3PH, 4W. Point of demarcation is at the service box on Buckner Parade Field... then If the Government cannot complete utilities installation, the contractor shall provide equipment and services for adequate power generation, water, and waste-water removal daily and/or as needed.

A. Yes, City Power and Light will provide electrical support

If for some reason Power is not able to be supported by the Government, then the secondary option would be to have Generator support.

14. Between 18 Jun 2023 and 01 Jul 2023 will there be there any functions with the remaining tents and contractor provided facilities while in the down time between exercises?

A. No.

15. Para. 4.2.1. BPT reduce COVID schematic design requirement to 30 square feet per person. We are not really clear on this statement --Does this affect the mandatory 50 SF per person requirement?

A. No this does not affect the 50 SF per person requirement.

16. How much of the contract price was reduced the past few years for not meeting the PRS in the PWS?

A. In 2022 the contract price increased from 2021's contract price.

17. Will a PDF proposal be adequate for this proposal or will you require the hard (paper) copies to be received by the deadline?

A. Please adhere to the solicitation instructions for submitting a proposal

18. how many hand washing stations will be required?

A. I'd recommend 8 x trailers (4 x latrine w/face bowl and 4 x showers). The number of trailers does not matter as long as the requirement is met:

Contractor shall provide temporary shower trailers and all necessary equipment to operate and service minimum two (2) 7-minute showers per person, per day, for **700 personnel from 12 MAY to 18 JUN 2023 and reduce structures ISO of 700 personnel to support 150 personnel from 01 JUL to 07 AUG 2023. Structures not used by the government that are left in place by the contractor will be at no cost to the government.**
