QUESTIONS AND ANSWERS

QUESTION 1: THE DRAWINGS ARE SIZED IN PDF AT 8.5 X 11". CAN THERE BE ACCESS TO FULL SIZED DRAWINGS?

ANSWER 1: THE PDF ONLINE CAN BE "ZOOMED IN" FOR EASIER VIEWING. VENDOR MAY PRINT DRAWINGS/SPECIFICATIONS LARGER THAN 8.5 X 11" FOR THEMSELVES.

QUESTION 2: Will electrical permits with the local electrical utility company be required?

ANSWER 2: Contractor will be required to coordinate with the local electric utility company and adhere to their permitting requirements

QUESTION 3: Will electrical permits with the local municipality be required?

ANSWER 3: Unless required by the local electric company, no permits with the local municipality will be required.

QUESTION 4: Specification Section #9 states that all subcontractors performing work shall be licensed for their respective disciplines. Do contractors need to be licensed in the state of Connecticut? We carry electrical licenses for Massachusetts, Vermont, New Hampshire, and Maine.

ANSWER 4: Yes, licensure in Connecticut is required.

QUESTION 5: Please provide clarification: Per Specification section 9: Licensed Contractor. The Contractor shall be licensed as a General Contractor. Does the prime contractor need to be licensed in the State of Connecticut?

ANSWER 5: The Contractor shall be licensed as a general contractor in the state where work is to be performed and they shall adhere to all local, state and federal requirements.

QUESTION 6: On the bid templet you have \$5000 set aside for the electrical work allowance. It appears that the electrical work could be more than that. Will there be any other allowances for electrical if it is more than the \$5000?

ANSWER 6: The \$5000 allowance is for utility work as documented in line item 002. Eversource is the electrical provider for the site. Coordination must be with the provider for disconnection This amount may not be changed during the quote

submission process. Once the Purchase Order is awarded and final coordination can occur with the utility provider, the awarded contractor must provide final verification of the cost for the disconnection to the Technical Point of Contact.
