STATEMENT OF OBJECTIVE

1.0 BACKGROUND

The U.S. Army Corps of Engineers (USACE) St. Louis District currently occupies approximately 100,388 usable square feet (USF) in the Robert A. Young (RAY) Federal Building in St. Louis, Missouri. USACE occupies 1,999 USF of the 3rd floor, as well as the entire 4th floor, which is approximately 98,398.00 USF. In 2018 USACE awarded contract that covered a complete furniture renovation using Knoll brand systems furniture. The renovation replaced all cubicles and furniture in USACE occupied space on the 3rd and 4th floor of the RAY building. USACE seeks high performance workplace Knoll furniture solutions that allow for continuation of collaboration, communication, acoustical considerations, privacy, and passive solar daylighting to match existing systems furniture.

2.0 SCOPE

The purpose of this procurement is to reconfigure, add, and/or replace existing Knoll brand systems furniture. It also covers delivery and installation services for space occupied by the US Army Corps of Engineers in the Robert A. Young Federal Building. Completed reconfiguration projects will be up to 6 projects per year and ranging from 1 cubicle to up to 10 cubicles per office.

Under the Comprehensive Procurement Guidelines (CPG) program, the Environmental Protection Agency (EPA) designates products that are or can be made with recovered materials, and recommends practices for buying these products. Any designated product that is being offered or supplied under this BPA shall meet the minimum recommended content levels as identified under the CPG program. Visit <http://www.epa.gov/epawaste/conservation/cpg/products> for a complete list of designated products and the associated recommended content levels. Offerors must be able to demonstrate that each offered product meets minimum content levels upon request.

No other areas can be used for staging product during the installation phases. It is up to the contractor to coordinate with the agency POCs to determine the staging areas within the work spaces, as well as, to provide an adequate work force to ensure that the required installation schedule is met.

The client agency Point of Contact (POC), also noted as the Customer Agency Project Manager (PM), will be the liaison at all times between the Furniture Contractor and the Building Manager. The Furniture Contractor will be required to comply with the requirements set forth by the building Manager and Agency Security Officer.

3.0 PERIOD OF PERFORMANCE

The period of performance is for five years from contract award.

OBJECTIVES

4.0 GENERAL CONDITIONS

4.1 For any furniture procurement and installation, the contractor shall be responsible for assessing, evaluating, verifying, and confirming the conditions of the building, accessibility, site restrictions, parking, deliveries, loading dock, elevator, storage, installation and staging, hours of availability/accessibility of all the above and any other conditions associated with, and which may affect cost of delivery and installation.

4.2 All products, work and installation drawings and documents shall meet any and all federal, state, local jurisdictions and governing authorities including but not limited to codes, laws, ordinances, and regulations applicable to this project including the Americans with Disabilities Act (ADA) and/or FED-STD 795. It will be the responsibility of the contractor to ensure that applicable regulations and codes are followed.

4.3 The Contractor shall coordinate access to Customer Agency space 72 hours in advance with the Customer Agency PM, giving all names of personnel planning to enter the RAY building and shall comply with all Customer Agency security regulations. All items must be ordered together so that furniture is available within the same time frame.

4.4. The contractor shall prepare the office space for occupancy and immediate (“Turn-Key” of Systems Furniture) use.

4.5 Contractor shall store furniture components remaining after a project in labeled boxes at the Service Base Logistics Warehouse, 100 Arsenal Street St. Louis MO 63118. Furniture components should be covered and stored to prevent damage of any kind.

5. BUILDING CONDITIONS

5.1 Particular attention shall be given to the protection of existing structure and finishes to prevent any damage of existing finishes. Any accidental damage incurred to existing conditions will be responsibility of the contractor to repair or correct.

5.2 All exterior walls are window walls. The Contractor shall minimize blocking windows with cubicle furniture and maximizing natural daylighting through the interior of the building.

6.0 DOCUMENTING CONDITIONS

6.1 The contractor shall provide 2 copies of each of the following with their proposal:

- a. Product Warranties
- b. Copies of proposed layout drawings with part and product numbers
- c. Installation instructions and plan
- d. Proof of Sound and Fire Ratings

6.2 The Contractor shall comply with all applicable technical documents, performance, test standards, and furniture standards defined in the schedule. All products shall be on Federal Supply Schedule by the due date for the submission of quote.

6.3 Any request to modify design/installation documents or pricing must be negotiated and approved, IN WRITING, by the Contracting Officer. NO PERFORMANCE ON A REQUESTED CHANGE ORDER SHALL BE PERFORMED UNTIL A SIGNED MODIFICATION HAS BEEN RECEIVED BY THE CONTRACTOR.

6.4 The Contractor shall inventory existing furniture components located at the Service Base Logistics Warehouse, 100 Arsenal Street St. Louis MO 63118 before and after each completed reconfiguration project. A product listing sheet for inventory should be provided to PM.

6.5 Updated final drawings and floor layouts WITH changes along with updated square footage numbers shall be submitted after completion of all work.

7. DELIVERY

7.1 Contractors must provide a 48–72-hour notice of delivery

7.2 All product should be transported to the Service Base Logistics Warehouse from the Robert A. Young Federal Building upon full completion of furniture installation.

7.3 All work shall be completed during regular business hours unless alternate pre-approved arrangements have been made.

7.4 Drivers of the delivery vehicles shall not attempt to deliver any items before the scheduled delivery date. In the event the delivery date falls on a Saturday, Sunday, or federally recognized holiday, the delivery date shall be the next workday after the Saturday, Sunday, or holiday, unless alternate arrangements are pre-approved.

7.5 For any project specific furniture procurement, the contractor shall be responsible for managing the delivery and installation of the product on schedule.

8. PRODUCTS

8.1 Manufacturer: Knoll brand furniture shall be used for all items within a workstation or within an office to allow all workstation, desking/case goods finishes, veneers, colors and details to match. The drawing typical on specification sheets are for representational purposes of customer’s preference of design intent and style. Manufacturer variances apply to all dimensions provided on workstation specifications and private office specifications.

8.2 Necessary Components: The contractor shall provide all components, hardware, and parts necessary for proper assembly, installation, and operation, even though certain items may not be specifically described in the specifications. This includes all fittings, couplers, brackets, adapters, panel connectors, etc. Contractors shall include the cost of such components, hardware, and parts in the quotation price.

8.3 New and Unused: All goods shall be new, unused, produced from current production components, and shall be delivered ready for use. No components may be used that are not contained in the

manufacturer's current parts catalog.

8.4 Standard Components: Unless superseded by parts description specifications, goods shall include all components and accessories listed by the manufacturer as standard.

8.5 Delivery: All shipping and handling charges shall be paid by the contractor. Responsibility and liability for loss or damage shall remain with the contractor until final inspection and acceptance by the customer agency.

8.6 Materials:

8.7 Upholstery Fabric: Upholstery fabric shall be installed in the same direction with patterns aligned. (All fabric offered shall be manufacturer's standard grade unless otherwise specified.)

8.8 Locks: Locks provided are to be keyed alike within each workstation or office separately from other workstations or offices. Key each group of files alike, separately from other groups of files, but with master keying. Provide keying schedule and master keys to Government's representative at the time of acceptance by the Customer Agency PM. All locks shall be removable core supporting the ability to remove or replace lock plugs as necessary in the field.

8.9 Fabrication:

a. General: Methods of manufacturing, fabrication, and installation of General Furnishings and structural components thereof shall meet industry's highest standards. General Furnishings shall have proper support, stability and fault-free performance.

b. Nameplates: Do not place manufacturer's nameplates, stamped or printed markings on exposed surfaces.

8.10 Non-Obsolescence Manufacturer shall make good faith effort to maintain product compatibility within product lines to provide cohesive product parts for the office environment. This will allow the ability to integrate different product generations into existing purchased moveable wall system. Manufacturer shall provide products of equal or similar appearance and operational characteristics in terms of form, fit, and function for the period of ten (10) years from the date of any new product purchase. For the first two (2) years from the purchase date, fabric will be supplied at standard times and at agreed discounted price. Fabric and finishes will be available for a period of one (1) year from the date of the obsolescence announcement.

9. SERVICES

9.1 Design and Layout Services: The Government will supply a proposed/preliminary furniture plan to the contractor. The contractor, working with the Customer Agency PM, Agency representatives and the A/E shall convert Government supplied furniture/floor plans into fully coordinated, product specific, installation drawings within 10 business days of request. The typical design standards supplied by the Government may vary in size, quantity, configuration and/or components on the final installation drawings in order to meet the building conditions per an on-site meeting / information gathering visit to the building. All final working drawings, installation drawings and bill of material shall be coordinated with the Customer Agency PM prior to furniture production and prior to installation.

9.2 Data line installation: All data line work will be provided by the contractor. Data lines will be added or rerouted appropriately to fit the reconfigured spaces.

10. INSTALLATION: Installation shall be as per the manufacturer's instructions. General duties and requirements to be fulfilled by the contractor are as follows:

a. Complete installation of all furnishings in accordance with the Contracting Officer approved manufacturer specific drawings and specifications. For any missing or damaged products, the appropriate products must be replaced.

b. The contractor shall clean and dust furniture surfaces inside and out with a spray cleaner upon completion of installation of each floor. Use only approved non-toxic cleaners.

c. The contractor shall reimburse the Ordering Agency for costs associated with damage caused by the installers and any repairs due to the installation effort. The contractor will be responsible for any damage to the building or surrounding area which occurs during delivery and installation. It is incumbent upon the selected contractor to identify any existing damage to the building or surrounding area by means of a pre-installation and delivery walk-through, and daily submissions of checklists to the designated Customer Agency PM Representative on site. Proper measures (protective runner, pads, etc.) will be utilized by the selected contractor to protect the building (elevators, walls, floors etc.).

- d. **Clean up of Waste Materials:** The contractor shall clean up and dispose of waste materials or trash in accordance with this paragraph and full applicable federal, state, and local regulations, standards, codes, and laws. The selected contractor shall always keep the job site clean, including staging and storage areas used by the contractor, free from accumulations of waste material or trash. This material must be removed daily as to deter accumulation of debris. Prior to completion of the work, the selected contractor shall remove from the vicinity of the work, all shipping containers, packing, trash, unused materials and other like material, belonging to the selected contractor or used under the selected contractor's direction.
- e. **Disposal of Waste Material:** Waste material shall be disposed of by removal from job site. Waste materials removed from the job site shall be disposed of in accordance with the above paragraph. The selected contractor shall make any necessary arrangements with private parties and with local jurisdictions pertinent to locations and regulations of such disposal. Any fees or charges to be paid for disposal of materials shall be paid by the contractor. It is the contractor's option to furnish a dumpster on site to contain their debris. This dumpster shall be emptied regularly, and location of the dumpster must be coordinated with the Customer Agency PM and the building manager or building owner representative. The contractor shall dispose of recyclables, trash, and packing materials away from the installation site. No recyclables, trash, or packing materials will be disposed of or discarded in facility-provided recycling or trash containers or dumpsters.

11. SYSTEMS FURNITURE

This specification establishes the minimum requirements for the acquisition and installation of system furniture workstation components consisting of interconnecting panels, panel supported components, and accessories. Panels, furniture, components, and hardware shall be provided by a single manufacturer. The contractor shall coordinate the work of this section with that to be performed under others. Typical workstations represent the types of workstations to be used for the project. Additional workstation designs may be required to meet project or building conditions. Minor variations in design based on manufacturer's product lines are expected and are acceptable. Every effort should be made to stay as close to the designs as possible. The selected contractor may not increase the footprint of the workstations. Utilize standard products that are on the Federal Supply Schedule. Propose alternatives that meet the intent of the design when absolutely necessary. All workstations shall be constructed of parts and pieces that are interchangeable to allow for easy and cost-effective reconfiguration. Furnishings required are defined by size, finish, and required features.

12. SYSTEM FINISHES

12.1 System finishes are:

- a. **Metal and Trim:** Baked enamel finish all sides, for steel construction to match the workstations.
- b. **Worksurface:** Laminate.
- c. **Panel Fabric:** Panel fabric meetings ASTM E-84 (Tunnel Test) Class A or 1 for Flammability and the Lightfastness is 40 hours.

12.2 Panel and Frame Structures: The modular wall system shall be composed of demountable panels which fasten together with a universal attachment device. Every panel shall be acoustical or acoustical with a tack board applied. Panel system shall stack. The panel system shall integrate with manufactures other products with color consistency and styling. Panels shall be composed on a single metal frame for stackable tiles outside and monolithic appearances on the inside.

- a. All panels shall be frame and skin or frame and tile system consisting of an open core frame and removable skins/tiles.
- b. All frames shall be of steel frame construction, being made either non-dedicated, re-configurable horizontal beams and vertical posts or a fixed frame of horizontal and vertical structural elements.
- c. Panel system shall allow off-module location of components supported by the panel, including work surfaces, storage units and accessories.
- d. Panels can house electrical, data and communication cable. Electrical, data, and

communication cables will be run directly to current data and electrical outlets from workstation equipment.

- e. Panels shall be available in various widths.
- f. The standard acoustical panel shall meet the minimum NRC rating of .80 and STC rating of 24. Provide proof of NRC and STC ratings with bid submission.
- g. The panel frame system shall provide precise alignment of adjacent panels and shall have leveling glides.
- h. Panel system may allow off module location of components that does not deface the panel surfaces where the connection occurs.
- i. Panels shall be composed on a single metal frame for both tiled and monolithic appearances.
- j. Standard panel shall accommodate the addition of stack-on sections of glass, fabric, perforated steel, painted solid steel, open weave fabric screens and communication white boards.
- k. Panel frame shall be easily converted from the standard base raceway to open base or tile to floor for functional need changes.
- l. Panel connection hardware shall be universal to allow for set up of any panel configuration. Universal to: Straight, 2-way, 3-way, 4-way and Hi-Lo connections.
- m. Panels shall be capable of structurally supporting more than one fully loaded component load per panel, per side.
- n. It is preferred that panels be no less than 2" thick nor more than 3" thick.

12.3 Panel Trim

- a. All exposed ends of panels shall be covered with finished trim pieces.
- b. All top caps, base covers and exposed trims shall be painted metal.
- c. Worksurface trim profile shall be selected from manufacturer's available product line.

12.4 Panel Tile/Skins

- a. The panel skins shall be replaceable in the field as monolithic, tiled, glazed, fabric, wood, slatwall/accessory tile, marker board, perforated steel, painted solid steel and beltway and shall be removable without tools to allow for internal access to the panel frame.
- b. The removal of surfaces shall be accomplished without necessitating tearing down of the panel run.
- c. Panel skins shall not be location specific meaning they can be placed anywhere along the panel frame and can be easily changed as needs change.
- d. Tiles shall match frame width.
- e. Tackable skins shall be available.
- f. Skins/tiles shall be available as monolithic and segmented on panel frame.

12.5 Panel Electrical and Data: Power, data, and communications shall be able to enter the workspaces from the floor without the use of power poles, and without utilizing the system furniture panels for power, data, or communications distribution. However, cable pathways located beneath the worksurface should be utilized for wire management within each cubicle.

12.6 Worksurfaces

- a. Standard work surface shall have all exposed sides finished (no existing flake board or MDF board exposed).
- b. Undersides of work surfaces shall be pre-drilled to accept panel-hung and freestanding supports. Metal screws must be used.
- c. Core material to be minimum 45lb. density, furniture grade particleboard 1 1/4" - 1 3/4" thick.
- d. Worksurfaces shall be available with laminate surfaces. A minimum of three species of woodgrain laminates shall be offered.
- e. Laminate worksurface with selected edge shall create a clean protective finish. Self-edge is not acceptable.
- f. Worksurfaces cut-in-the-field to accommodate unforeseen conditions shall have field applied finish.
- g. Cable management shall be accomplished either via grommets or openings in the rear of the worksurface. Grommets or openings shall allow for a standard 3-prong plug to pass through.

12.7 Storage

- a. General

- i. All storage units shall have compatible dimensions, similar aesthetics, matching hardware and matching finishes.
- ii. All storage units shall be supplied with locks. See Section 4.6b of for lock requirements.
- iii. All storage units shall be fabricated with 18–22-gauge metal, as long as ANSI/BIFMA standards for heavy duty shelving are met.
- iv. All drawers (pedestals, lateral files, etc.) shall include the necessary hardware for hanging files both letter and legal.
- v. Full extension, ball bearing drawer slides for all drawers. Box drawers shall be rated at 50 pounds, file drawers rated at 150 pounds.
- vi. All backs, tops and sides of all storage units shall be finished.
- vii. Storage units shall be baked enamel finish all sides, for steel construction to match the workstations in at least five color selections.
- viii. Leveling glides, counterweights, inset or integral pulls, back-to-back ganging capabilities and locking capabilities shall be included.
- b. Wardrobes
 - i. Wardrobe cabinets shall be full panel height.
 - ii. Wardrobe cabinets shall be fabricated with 18 +/- gauge steel.
 - iii. Wardrobe cabinets shall be supplied with locks. See Section 4.6b of for lock requirements.
 - iv. Wardrobe shall accommodate hanging coats storage. Contractor to provide two coat hooks with coat hangers for every wardrobe.
- c. Overhead Cabinets
 - i. Overhead cabinets shall be fabricated with 18 +/- gauge steel.
 - ii. Overhead cabinets shall be supplied with locks. See Section 4.6b of for lock requirements.
 - iii. Overhead cabinets shall have a backstop or shall be fully enclosed as to protect the panel finish.
 - iv. Overhead unit doors shall open up and over the top of the unit.
 - v. Overhead units shall be provided with a hydraulic lift assist/closer as part of the hinge system.
 - vi. Doors shall allow for assisted opening from any point along the door.
 - vii. Overhead cabinets shall be available for off module panel mounting.
 - viii. Overhead cabinets shall accommodate an upright 3 ring binder.
 - ix. Overhead cabinets shall be offered as panel mounted, station mounted on the worksurface, or offered with other worksurface mounted structural support.
 - x. Overhead cabinets shall be quoted as metal parts. The metal parts shall be baked enamel finished with a durable VOC- free finish which is applied in a process that generates low levels of recyclable waste to match the workstation in at least five color selections.
- d. Pedestal Files
 - i. All storage/ pedestal files shall be supplied with locks. See Section 4.6b of for lock requirements.
 - ii. File drawers shall have full extension ball bearing drawer slides. Box drawers shall extend only 3/4 full.
 - iii. Drawers shall stay securely closed when in the closed position. Each drawer shall contain a safety catch to prevent accidental removal when the drawer is fully extended (open).
 - iv. Pedestal shall be available as box/box/file configurations. One box drawer shall include one plastic pencil tray in the box, box configuration.
 - v. All pedestal drawers shall be replaceable from the drawer case.
 - vi. Pedestal files shall have fully enclosed finished back.
 - vii. Pedestal drawer fronts shall have the ability to be removed and changed in the field.
 - viii. Drawer pedestals shall be available as freestanding and mobile units,
 - ix. Drawer fronts, outer wrapper, pedestal back and inner frame shall be a minimum of 18 gauge steel.
 - x. Pedestal Files finish shall be coordinated with the Systems Furniture.
- e. Lateral Files
 - i. All Lateral File units shall be supplied with locks. See Section 4.6b of for lock

requirements.

- ii. File drawers shall have full suspension, full extension, ball bearing slides to allow for filing of letter-sized or legal sized hanging folders and hanging rails for front to back filing.
- iii. All drawers shall have safety catches to prevent accidental removal and a safety lock mechanism to prevent more than one drawer from being opened at a time.
- iv. All lateral files shall be equipped with counterweights and drawer label holders.
- v. It is preferred that the lateral file cabinets shall be available as low profiled drawers in which the top or fifth drawer is a file drawer.
- vi. Drawer fronts, outer wrapper, pedestal back and inner frame shall be 18 +/- gauge.
- vii. Lateral files shall include leveling glides.
- viii. Lateral files finish shall be coordinated with the Systems Furniture

This is a sample task order to evaluate price only. This Task Order will not be awarded.

Please provide a quote for this sample Task Order. A single award task order contract will be issued to the contractor with the lowest quote for this sample Task Order that is determined to be fair and reasonable.

Scope of Work

Work associated with this project is for the USACE Planning and Environmental Division in the Ray Building at 1222 Spruce Street St. Louis, MO 63103.

This project is to reconfigure existing Knoll furniture to meet new requirements of additional standard and Supervisory type cubicles. All components, dimensions, and descriptions needed to complete these projects are shown on the product data sheets. Areas of attention have been circled on the attached drawing and should include the following:

- Convert W6 cubicle into a W5 cubicle nearest column Q12.
- Add (1) W1 cubicle and (1) W5 cubicle nearest column P11 area.

Notes:

- Would like to keep break area items but ok with merging into same space as. (To the left).
- Ok to shift two cubicles between column O11 and column O12 inside the rectangle so that they are NOT in the middle of the break area for both offices.
- All walkways and opening should remain ADA compliant especially around structural pillars.

The Government will supply a proposed/preliminary furniture plan to the contractor. The contractor, working with the Customer Agency PM will convert the Government supplied furniture/floor plans into fully coordinated, product specific, CAD installation drawings. The typical design standards supplied by the Government may vary in size, quantity, configuration and/or components on the final installation drawings to meet the building conditions per an on-site meeting.

All final working CAD drawings, installation CAD drawings and bill of material shall be coordinated with the Customer Agency PM prior to furniture production and prior to installation.

Products should match existing standard cubicle dimensions and furniture finishes to remain in compliance with provided product pages.

Product can be delivered and staged in our locked basement cage area. Trash, debris, and any excess furniture components should be removed from tenant space daily.

Installers must use the freight elevator when transporting components.

Empty boxes and packaging debris must be cleared from cage area daily.

Installer should have their own moving dollies/carts.

All remaining furniture components should be labeled. Remaining components will need to be transported and stored at the Service Base (SB) Building 14 located at 100 Arsenal Street St. Louis MO 63118 for possible future use upon installation completion. Deviations from this process must be coordinated with District Logistics Manager (DLM) and is only permissible if there is another project pending installation within the next 30 days. Installer will also be responsible for providing data line work. This work entails installing/relocating new data lines under the raised floor for reconfigured workspaces.

52.204-24 REPRESENTATION REGARDING CERTAIN TELECOMMUNICATIONS AND VIDEO SURVEILLANCE SERVICES OR EQUIPMENT (NOV 2021)

The Offeror shall not complete the representation at paragraph (d)(1) of this provision if the Offeror has represented that it "does not provide covered telecommunications equipment or services as a part of its offered products or services to the Government in the performance of any contract, subcontract, or other contractual instrument" in

paragraph (c)(1) in the provision at 52.204-26, Covered Telecommunications Equipment or Services-- Representation, or in paragraph (v)(2)(i) of the provision at 52.212-3, Offeror Representations and Certifications- Commercial Products and Commercial Services. The Offeror shall not complete the representation in paragraph (d)(2) of this provision if the Offeror has represented that it "does not use covered telecommunications equipment or services, or any equipment, system, or service that uses covered telecommunications equipment or services" in paragraph (c)(2) of the provision at 52.204-26, or in paragraph (v)(2)(ii) of the provision at 52.212-3.

"Place of manufacture" means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

"Predecessor" means an entity that is replaced by a successor and includes any predecessors of the predecessor.

(a) Inspection/Acceptance. The Contractor shall only tender for acceptance those items that conform to the requirements of this contract. The Government reserves the right to inspect or test any supplies or services that have been tendered for acceptance. The Government may require repair or replacement of nonconforming supplies or reperformance of nonconforming services at no increase in contract price. If repair/replacement or reperformance will not correct the defects or is not possible, the Government may seek an equitable price reduction or adequate consideration for acceptance of nonconforming supplies or services. The Government must exercise its post-acceptance rights-

(1) Within a reasonable time after the defect was discovered or should have been discovered; and

(2) Before any substantial change occurs in the condition of the item, unless the change is due to the defect in the item.

(b) Assignment. The Contractor or its assignee may assign its rights to receive payment due as a result of performance of this contract to a bank, trust company, or other financing institution, including any Federal lending agency in accordance with the Assignment of Claims Act (31 U.S.C. 3727). However, when a third party makes payment (e.g., use of the Governmentwide commercial purchase card), the Contractor may not assign its rights to receive payment under this contract.

(c) Changes. Changes in the terms and conditions of this contract may be made only by written agreement of the parties.

(d) Disputes. This contract is subject to 41 U.S.C. chapter 71, Contract Disputes. Failure of the parties to this contract to reach agreement on any request for equitable adjustment, claim, appeal or action arising under or relating

to this contract shall be a dispute to be resolved in accordance with the clause at Federal Acquisition Regulation (FAR) 52.233-1, Disputes, which is incorporated herein by reference. The Contractor shall proceed diligently with performance of this contract, pending final resolution of any dispute arising under the contract.

(e) Definitions. The clause at FAR 52.202-1, Definitions, is incorporated herein by reference.

(f) Excusable delays. The Contractor shall be liable for default unless nonperformance is caused by an occurrence beyond the reasonable control of the Contractor and without its fault or negligence such as, acts of God or the public enemy, acts of the Government in either its sovereign or contractual capacity, fires, floods, epidemics, quarantine restrictions, strikes, unusually severe weather, and delays of common carriers. (i) Payment.--

(1) Items accepted. Payment shall be made for items accepted by the Government that have been delivered to the delivery destinations set forth in this contract.

The Contractor shall not be required to comply with the cost accounting standards or contract cost principles for this purpose. This paragraph does not give the Government any right to audit the Contractor's records. The Contractor shall not be paid for any work performed or costs incurred which reasonably could have been avoided.

(m) Termination for cause. For items that are serialized within the part, lot, or batch number within the enterprise identifier, the unique item identifier shall include the data elements of the enterprise identifier; the original part, lot, or batch number; and the serial number.

Enterprise means the entity (e.g., a manufacturer or vendor) responsible for assigning unique item identifiers to items.

Enterprise identifier means a code that is uniquely assigned to an enterprise by an issuing agency.

Government's unit acquisition cost means--

(1) For fixed-price type line, subline, or exhibit line items, the unit price identified in the contract at the time of delivery;

(2) For cost-type or undefinitized line, subline, or exhibit line items, the Contractor's estimated fully burdened unit cost to the Government at the time of delivery; and

(3) For items produced under a time-and-materials contract, the Contractor's estimated fully burdened unit cost to the Government at the time of delivery.

Issuing agency means an organization responsible for assigning a globally unique identifier to an enterprise, as indicated in the Register of Issuing Agency Codes for ISO/IEC 15459, located at http://www.aimglobal.org/?Reg_Authority15459.

Issuing agency code means a code that designates the registration (or controlling) authority for the enterprise identifier.

Item means a single hardware article or a single unit formed by a grouping of subassemblies, components, or constituent parts.

Lot or batch number means an identifying number assigned by the enterprise to a designated group of items, usually referred to as either a lot or a batch, all of which were manufactured under identical conditions.

Machine-readable means an automatic identification technology media, such as bar codes, contact memory buttons, radio frequency identification, or optical memory cards.

Original part number means a combination of numbers or letters assigned by the enterprise at item creation to a class of items with the same form, fit, function, and interface.

Parent item means the item assembly, intermediate component, or subassembly that has an embedded item with a unique item identifier or DoD recognized unique identification equivalent.

Serial number within the enterprise identifier means a combination of numbers, letters, or symbols assigned by the enterprise to an item that provides for the differentiation of that item from any other like and unlike item and is never used again within the enterprise.

Serial number within the part, lot, or batch number means a combination of numbers or letters assigned by the enterprise to an item that provides for the differentiation of that item from any other like item within a part, lot, or batch number assignment.

Serialization within the enterprise identifier means each item produced is assigned a serial number that is unique among all the tangible items produced by the enterprise and is never used again. The enterprise is responsible for ensuring unique serialization within the enterprise identifier.

Serialization within the part, lot, or batch number means each item of a particular part, lot, or batch number is assigned a unique serial number within that part, lot, or batch number assignment. The enterprise is responsible for ensuring unique serialization within the part, lot, or batch number within the enterprise identifier.

Type designation means a combination of letters and numerals assigned by the Government to a major end item, assembly or subassembly, as appropriate, to provide a convenient means of differentiating between items having the same basic name and to indicate modifications and changes thereto.

Unique item identifier means a set of data elements marked on items that is globally unique and unambiguous. The term includes a concatenated unique item identifier or a DoD recognized unique identification equivalent.

Unique item identifier type means a designator to indicate which method of uniquely identifying a part has been used. The current list of accepted unique item identifier types is maintained at <https://www.acq.osd.mil/asda/dpc/cc/ds/unique-id.html>.

(b) The Contractor shall deliver all items under a contract line, subline, or exhibit line item.

(c) Unique item identifier. (1) The Contractor shall provide a unique item identifier for the following:

(i) Delivered items for which the Government's unit acquisition cost is \$5,000 or more, except for the following line items:

(ii) Items for which the Government's unit acquisition cost is less than \$5,000 that are identified in the Schedule or the following table:

(If items are identified in the Schedule, insert "See Schedule" in this table.)

(iii) Subassemblies, components, and parts embedded within delivered items, items with warranty requirements, DoD serially managed repairables and DoD serially managed nonrepairables as specified in Attachment Number ----.

(iv) Any item of special tooling or special test equipment as defined in FAR 2.101 that have been designated for preservation and storage for a Major Defense Acquisition Program as specified in Attachment Number ----.

(v) Any item not included in paragraphs (c)(1)(i), (ii), (iii), or

(iv) of this clause for which the contractor creates and marks a unique item identifier for traceability.

(2) The unique item identifier assignment and its component data element combination shall not be duplicated on any other item marked or registered in the DoD Item Unique Identification Registry by the contractor.

(3) The unique item identifier component data elements shall be marked on an item using two dimensional data matrix symbology that complies with ISO/IEC International Standard 16022, Information technology--International symbology specification--Data matrix; ECC200 data matrix specification.

(4) Data syntax and semantics of unique item identifiers. The Contractor shall ensure that--

(i) The data elements (except issuing agency code) of the unique item identifier are encoded within the data matrix symbol that is marked on the item using one of the following three types of data qualifiers, as determined by the Contractor:

(A) Application Identifiers (AIs) (Format Indicator 05 of ISO/IEC International Standard 15434), in accordance with ISO/IEC International Standard 15418, Information Technology--EAN/UCC Application Identifiers and Fact Data Identifiers and Maintenance and ANSI MH 10.8.2 Data Identifier and Application Identifier Standard.

(B) Data Identifiers (DIs) (Format Indicator 06 of ISO/IEC International Standard 15434), in accordance with ISO/IEC International Standard 15418, Information Technology--EAN/UCC Application Identifiers and Fact Data Identifiers and Maintenance and ANSI MH 10.8.2 Data Identifier and Application Identifier Standard.

(C) Text Element Identifiers (TEIs) (Format Indicator 12 of ISO/IEC International Standard 15434), in accordance with the Air Transport Association Common Support Data Dictionary; and

(ii) The encoded data elements of the unique item identifier conform to the transfer structure, syntax, and coding of messages and data formats specified for Format Indicators 05, 06, and 12 in ISO/IEC International Standard 15434, Information Technology-Transfer Syntax for High Capacity Automatic Data Capture Media.

(5) Unique item identifier.

(i) The Contractor shall--

(A) Determine whether to--

- (1) Serialize within the enterprise identifier;
- (2) Serialize within the part, lot, or batch number; or
- (3) Use a DoD recognized unique identification equivalent (e.g. Vehicle Identification Number); and

(B) Place the data elements of the unique item identifier (enterprise identifier; serial number; DoD recognized unique identification equivalent; and for serialization within the part, lot, or batch number only: Original part, lot, or batch number) on items requiring marking by paragraph (c)(1) of this clause, based on the criteria provided in MIL-STD-130, Identification Marking of U.S. Military Property, latest version;

(C) Label shipments, storage containers and packages that contain uniquely identified items in accordance with the requirements of MIL-STD-129, Military Marking for Shipment and Storage, latest version; and

(D) Verify that the marks on items and labels on shipments, storage containers, and packages are machine readable and conform to the applicable standards. The contractor shall use an automatic identification technology device for this verification that has been programmed to the requirements of Appendix A, MIL-STD-130, latest version.

(ii) The issuing agency code--

(A) Shall not be placed on the item; and

(B) Shall be derived from the data qualifier for the enterprise identifier.

(d) For each item that requires item unique identification under paragraph (c)(1)(i), (ii), or (iv) of this clause or when item unique identification is provided under paragraph (c)(1)(v), in addition to the information provided as part of the Material Inspection and Receiving Report specified elsewhere in this contract, the Contractor shall report at the time of delivery, as part of the Material Inspection and Receiving Report, the following information:

- (1) Unique item identifier.
- (2) Unique item identifier type.
- (3) Issuing agency code (if concatenated unique item identifier is used).
- (4) Enterprise identifier (if concatenated unique item identifier is used).
- (5) Original part number (if there is serialization within the original part number).
- (6) Lot or batch number (if there is serialization within the lot or batch number).
- (7) Current part number (optional and only if not the same as the original part number).
- (8) Current part number effective date (optional and only if current part number is used).
- (9) Serial number (if concatenated unique item identifier is used).
- (10) Government's unit acquisition cost.
- (11) Unit of measure.
- (12) Type designation of the item as specified in the contract schedule, if any.

(13) Whether the item is an item of Special Tooling or Special Test Equipment.

(14) Whether the item is covered by a warranty.

(e) For embedded subassemblies, components, and parts that require DoD unique item identification under paragraph (c)(1)(iii) of this clause, the Contractor shall report as part of, or associated with, the Material Inspection and Receiving Report specified elsewhere in this contract, the following information:

(1) Unique item identifier of the parent item under paragraph (c)(1) of this clause that contains the embedded subassembly, component, or part.

(2) Unique item identifier of the embedded subassembly, component, or part.

(3) Unique item identifier type.**

(4) Issuing agency code (if concatenated unique item identifier is used).**

(5) Enterprise identifier (if concatenated unique item identifier is used).**

(6) Original part number (if there is serialization within the original part number).**

(7) Lot or batch number (if there is serialization within the lot or batch number).**

(8) Current part number (optional and only if not the same as the original part number).**

(9) Current part number effective date (optional and only if current part number is used).**

(10) Serial number (if concatenated unique item identifier is used).**

(11) Description.

** Once per item.

(f) The Contractor shall submit the information required by paragraphs (d) and (e) of this clause as follows:

(1) End items shall be reported using the receiving report capability in Wide Area WorkFlow (WAWF) in accordance with the clause at 252.232-7003. If WAWF is not required by this contract, and the contractor is not using WAWF, follow the procedures at <http://dodprocurementtoolbox.com/site/uidregistry/>.

(2) Embedded items shall be reported by one of the following methods--

(i) Use of the embedded items capability in WAWF;

(ii) Direct data submission to the IUID Registry following the procedures and formats at <http://dodprocurementtoolbox.com/site/uidregistry/>; or

(iii) Via WAWF as a deliverable attachment for exhibit line item number (fill in) ----, Unique Item Identifier Report for Embedded Items, Contract Data Requirements List, DD Form 1423.

(g) Subcontracts. If the Contractor acquires by subcontract any item(s) for which item unique identification is required in accordance with paragraph (c)(1) of this clause, the Contractor shall include this clause, including this paragraph (g), in the applicable subcontract(s), including subcontracts for commercial products or commercial services.
