CLAUSES INCORPORATED BY FULL TEXT

52.204-24 REPRESENTATION REGARDING CERTAIN TELECOMMUNICATIONS AND VIDEO SURVEILLANCE SERVICES OR EQUIPMENT (NOV 2021)

The Offeror shall not complete the representation at paragraph (d)(1) of this provision if the Offeror has represented that it "does not provide covered telecommunications equipment or services as a part of its offered products or services to the Government in the performance of any contract, subcontract, or other contractual instrument" in paragraph (c)(1) in the provision at 52.204-26, Covered Telecommunications Equipment or Services-- Representation, or in paragraph (v)(2)(i) of the provision at 52.212-3, Offeror Representations and Certifications- Commercial Products and Commercial Services. The Offeror shall not complete the representation in paragraph (d)(2) of this provision if the Offeror has represented that it "does not use covered telecommunications equipment or services, or any equipment, system, or service that uses covered telecommunications equipment or services" in paragraph (c)(2) of the provision at 52.204-26, or in paragraph (v)(2)(ii) of the provision at 52.212-3.

(a) Definitions. As used in this provision-

Backhaul, covered telecommunications equipment or services, critical technology, interconnection arrangements, reasonable inquiry, roaming, and substantial or essential component have the meanings provided in the clause 52.204-25, Prohibition on Contracting for Certain Telecommunications and Video Surveillance Services or Equipment.

(b) Prohibition.

(1) Section 889(a)(1)(A) of the John S. McCain National Defense Authorization Act for Fiscal Year 2019 (Pub. L. 115-232) prohibits the head of an executive agency on or after August 13, 2019, from procuring or obtaining, or extending or renewing a contract to procure or obtain, any equipment, system, or service that uses covered telecommunications equipment or services as a substantial or essential component of any system, or as critical technology as part of any system. Nothing in the prohibition shall be construed to--

(i) Prohibit the head of an executive agency from procuring with an entity to provide a service that connects to the facilities of a third-party, such as backhaul, roaming, or interconnection arrangements; or

(ii) Cover telecommunications equipment that cannot route or redirect user data traffic or cannot permit visibility into any user data or packets that such equipment transmits or otherwise handles.

(2) Section 889(a)(1)(B) of the John S. McCain National Defense Authorization Act for Fiscal Year 2019 (Pub. L. 115-232) prohibits the head of an executive agency on or after August 13, 2020, from entering into a contract or extending or renewing a contract with an entity that uses any equipment, system, or service that uses covered telecommunications equipment or services as a substantial or essential component of any system, or as critical technology as part of any system. This prohibition applies to the use of covered telecommunications equipment or services, regardless of whether that use is in performance of work under a Federal contract. Nothing in the prohibition shall be construed to--

(i) Prohibit the head of an executive agency from procuring with an entity to provide a service that connects to the facilities of a third-party, such as backhaul, roaming, or interconnection arrangements; or

(ii) Cover telecommunications equipment that cannot route or redirect user data traffic or cannot permit visibility into any user data or packets that such equipment transmits or otherwise handles.

(c) Procedures. The Offeror shall review the list of excluded parties in the System for Award Management (SAM) (<https://www.sam.gov>) for entities excluded from receiving federal awards for "covered telecommunications equipment or services."

(d) Representations. The Offeror represents that--

The Offeror shall provide the additional disclosure information required at paragraph (e)(1) of this section if the Offeror responds "will" in paragraph (d)(1) of this section; and

(2) After conducting a reasonable inquiry, for purposes of this representation, the Offeror represents that--

(B) A description of all covered telecommunications equipment offered (include brand; model number, such as OEM number, manufacturer part number, or wholesaler number; and item description, as applicable); and

(C) Explanation of the proposed use of covered telecommunications equipment and any factors relevant to determining if such use would be permissible under the prohibition in paragraph (b)(1) of this provision.

(ii) For covered services--

(A) If the service is related to item maintenance: A description of all covered telecommunications services offered (include on the item being maintained: Brand; model number, such as OEM number, manufacturer part number, or wholesaler number; and item description, as applicable); or

(B) If not associated with maintenance, the Product Service Code (PSC) of the service being provided; and explanation of the proposed use of covered telecommunications services and any factors relevant to determining if such use would be permissible under the prohibition in paragraph (b)(1) of this provision.

(2) Disclosure for the representation in paragraph (d)(2) of this provision. If the Offeror has responded "does" in the representation in paragraph (d)(2) of this provision, the Offeror shall provide the following information as part of the offer:

(i) For covered equipment--

(B) If not associated with maintenance, the PSC of the service being provided; and explanation of the proposed use of covered telecommunications services and any factors relevant to determining if such use would be permissible under the prohibition in paragraph (b)(2) of this provision.

STATEMENT OF WORK**STATEMENT OF WORK**Document Destruction Services (DDS)  
for Controlled Unclassified Information (CUI)**1. SCOPE:**

- 1.1. This Statement of work (SOW) identifies the Governments requirement for a qualified contractor to provide the equipment and materials necessary to provide on-site DDS to support the Fleet Readiness Center Southwest (FRCSW), NAS North Island P.O. Box 357051, San Diego, CA 92135- 7051.
- 1.2. The Government requires services for a Base Year Period of Performance (POP) and four one-year option periods. Options are a unilateral right of the Government. The inclusion of option CLIN's in any resultant contract does not constitute any commitment to the contractor that the Government will exercise the option(s).

**2. APPLICABLE DOCUMENTS:**

- 2.1. DoD Information Security Program: Controlled Unclassified Information (CUI), DoD Manual 5200.01 Volume 4 dated 24 Feb 2012 (or latest revision)
- 2.2. DoD Directive 5400.11 dated 29 Oct 2014 (or latest revision)
- 2.3. SECNAV Manual 5510.36 dated June 2006 (or latest revision)
- 2.4. NAVAIR Instruction 5211.5A dated 10 Nov 2016 (or latest revision)
- 2.5. COMFRC Instruction 5211.1A dated 12 Jun 2011 (or latest revision)
- 2.6. FRCSW Instruction 5211.1 dated 24 Sep 2014 (or latest revision)
- 2.7. Dept. of the Navy Local Population ID Card/Base Access Pass Registration, SECNAV Form 5512/1 (April 2014)

**3. GENERAL REQUIREMENTS:**

The contractor is required to provide all labor, supervision, facilities, equipment, tools and any other items and materials necessary to provide DDS for FRCSW.

**4. SPECIFIC REQUIREMENTS:**

- 4.1 Collection Containers:

The contractor is required to provide forty five (45), 64 gallon, rolling bins, which have locks and a locking mechanism with the associated keys for each bin. The containers will be used to collect paper documents only. The containers are required to have locks and protective slots to prevent unauthorized access prior to destruction. The Contractor is required to deliver the containers within (14) days of contract award and provide the FRCSW Security Office (Code 7.4) all keys once the containers are delivered.

NOTE: The Government will inspect the rolling bins upon delivery to ensure that the bins meet all required specifications per para 4.1.1 of this SOW. If the bins do not meet the specified criteria the bins will not be accepted. The contractor will be required to furnish the proper type of bin within 3-5 days and an additional inspection will be performed to ensure compliance.

#### 4.2 Frequency:

The Government requires DDS be performed once a month.

The contractor is required to coordinate with the FRCSW Security office to deliver initial bins/containers to specific, prearranged locations. All regularly scheduled pickup locations are to be coordinated with the FRCSW Security Office prior to arrival, unless directed by the Security office to do so otherwise.

#### Onsite DDS:

The contractor is required to accomplish all shredding on-site at FRCSW. The contractor is to ensure the documents are rendered unrecognizable and beyond reconstruction. The Government will coordinate and bring all (45) bins to the contractor's DDS truck at the designated DDS location. DDS location to be determined upon award of a contract. Services to be performed monthly.

- 4.3 The contractor is required to notify the FRCSW Security Office at the start of each scheduled pickup.
- 4.4 All contractor drivers servicing FRCSW will be required to obtain Naval Base Coronado base access. Contractor drivers are required to adhere to and shall follow all Naval Base Coronado/FRCSW activities on base rules and regulations.
- 4.5 The contractor shall comply with The Privacy Act of 1974, as amended, 5 U.S.C. 552a, and establish appropriate administrative, technical, and physical safeguards to ensure the security and confidentiality of records and to protect against any anticipated threats or hazards to their security or integrity which could result in

substantial harm, embarrassment, inconvenience, or unfairness to any individual on whom information is maintained.

- 4.6 NAID (National Association for Information Destruction) requirement: The contractor is required to hold a current NAID membership/certification and be a certified provider for the duration of the Contract.
- 4.7 Services are to be performed Monday through Friday, excluding Federal holidays, during normal business hours of 7:00 a.m. and 4:30 p.m.
- 4.8 DELIVERABLES: The contractor is required to provide a Certificate of Destruction (COD) that includes the following information:
- (a) weight of shredded material, itemized by bin
  - (b) date of DDS event
  - (c) Total number of bins weighed and total weight of paper shredded.
  - (d) Confirmation that all shredded material was rendered unrecognizable and beyond reconstruction.

A COD is required to be furnished for each service performance (monthly). The COD is required to be filled out by the Contractor Representative (CR), with printed name of CR, signature of CR, and date of the DDS event.

The contractor is required to return the COD to the TPOC via email within (5) business days after completion of the DDS event. The TPOC will review, sign, date and return a copy to the Contractor's Administrative representative within (5) business days after receipt of the COD.

## 5. **INSPECTION AND ACCEPTANCE:**

### 5.1. Inspection

- 5.1.1. The Government will perform periodic and random inspections during the DDS monthly event to ensure that the Contractor is performing all tasks in accordance with the contract.

### 5.2. Acceptance

- 5.2.1. The Contractor is required to demonstrate, in person, the final shred particle results to an FRCSW Security Representative to ensure hard copy documents are rendered unrecognizable and beyond reconstruction.

- 5.2.2. Upon completion of services, the Contractor shall provide the Technical Point of Contact (TPOC) with the COD for the DDS event.

6. **SPECIAL REQUIREMENTS:**

6.2. BASE ACCESS:

- 6.2.1. The Contractor shall complete the Dept. of the Navy Local Population ID Card/Base Access Pass Registration SECNAV Form 5512/1, April 2014, of each person requiring base access in order to facilitate the vetting process required for base access at least ten business (10) days in advance of the scheduled site visit.

- 6.2.2. Upon arrival, all personnel will be required to check-in at the Visitor Control Center (Bldg 610), which is located near the Main Gate to Naval Base Coronado (NBC), NAS North Island, San Diego, CA. Following receipt of a clearance, personnel will then be required to coordinate with the TPOC and obtain visitor badges through the FRCSW Quarterdeck, located in Building 94.

6.3. INSTRUCTION/GUIDANCE FOR ADDITIONAL SUPPLIES/SERVICES

- 6.3.1. Should the Contractor be confronted with uncertainty related to performance, or have knowledge of a necessity that has not been previously identified within the limitations of the scope of work, the Contractor is instructed to immediately notify the cited TPOC of a potential disparity in requirements, which may adversely impact the ability of the Contractor to provide requested and/or identified supplies or services.
- 6.3.2. In the event of the unavailability of the TPOC, wherein modification of this order may either be indicated or implied, the Contractor shall not undertake any additional actions without the receipt of written approval from the Contracting Officer, at COMFRC Procurement Group.

#### 6.4. PACKAGING AND MARKING

##### PACKAGING INSTRUCTIONS:

In the event that any parts, components or material is to be shipped to the US Navy for the performance of services, the contractor can utilize standard commercial packaging/palletizing processes/procedures.

##### MARKING:

(d) WAWF training. The Contractor should follow the training instructions of the WAWF Web-Based Training Course and use the Practice Training Site before submitting payment requests through WAWF. Both can be accessed by selecting the “Web Based Training” link on the WAWF home page at <https://wawf.eb.mil/>.

(e) WAWF methods of document submission. Document submissions may be via web entry, Electronic Data Interchange, or File Transfer Protocol.

(f) WAWF payment instructions. The Contractor shall use the following information when submitting payment requests and receiving reports in WAWF for this contract or task or delivery order:

(1) Document type. The Contractor shall submit payment requests using the following document type(s):

(i) For cost-type line items, including labor-hour or time-and-materials, submit a cost voucher.

(ii) For fixed price line items—

(A) That require shipment of a deliverable, submit the invoice and receiving report specified by the Contracting Officer.

Combo

(Contracting Officer: Insert applicable invoice and receiving report document type(s) for fixed price line items that require shipment of a deliverable.)

(B) For services that do not require shipment of a deliverable, submit either the Invoice 2in1, which meets the requirements for the invoice and receiving report, or the applicable invoice and receiving report, as specified by the Contracting Officer.

Invoice 2in1

(iii) For customary progress payments based on costs incurred, submit a progress payment request.

(2) Fast Pay requests are only permitted when Federal Acquisition Regulation (FAR) 52.213-1 is included in the contract.

"Economically disadvantaged women-owned small business (EDWOSB) concern" means a small business concern that is at least 51 percent directly and unconditionally owned by, and the management and daily business operations of which are controlled by, one or more women who are citizens of the United States and who are economically disadvantaged in accordance with 13 CFR part 127, and the concern is certified by SBA or an approved third-party certifier in accordance with 13 CFR 127.300. - (9) PSC 9620, Minerals, Natural and Synthetic; and
- (10) PSC 9630, Additive Metal Materials.

"Place of manufacture" means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

"Predecessor" means an entity that is replaced by a successor and includes any predecessors of the predecessor.

"Reasonable inquiry" has the meaning provided in the clause 52.204-25, Prohibition on Contracting for Certain Telecommunications and Video Surveillance Services or Equipment.

"Restricted business operations" means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate--

"Service-disabled veteran-owned small business concern"--
