


Lucky Peak Nursery's container program uses growing media to grow all of their container seedlings. It is imperative (to assure our customers a predictable, robust seedling) that we order a blend of 75% Growers grade Peat Moss 12.5 Prop Grade Perlite, 12.5% V2 Vermiculite, , screened for large debris, wetting agent and no fertilizer.

Delivery Location

Product is required to be delivered at the USDA Forest Service, Lucky Peak Nursery, located approximately 17 miles east of Boise, ID on Highway 21. Lucky Peak Nursery 15169 E. Hwy 21 Boise, ID 83716.

General Requirements of Growing Media – Forestry Seedling Mix

- 75% Growers grade Peat Moss
- 12.5% Prop Grade Perlite
- 12.5% V2 Vermiculite
- Wetting Agent
- No Fertilizer

Date(s) and Place(s) of Delivery and Acceptance

- (An **estimated** delivery of 11,016 cubic feet of growing media (four semi-tractor trailer loads) per delivery (four deliveries a year).
 - Depending on vendor, each semi-tractor trailer load carries approximately 2,720 cubic feet of growing media.
- Media totes must be delivered on pallets.

- A minimum of 40 cubic feet of growing media per tote.
- Growing media to be delivered to the USDA Forest Service Lucky Peak Nursery, Monday – Friday; 0800-1500.
