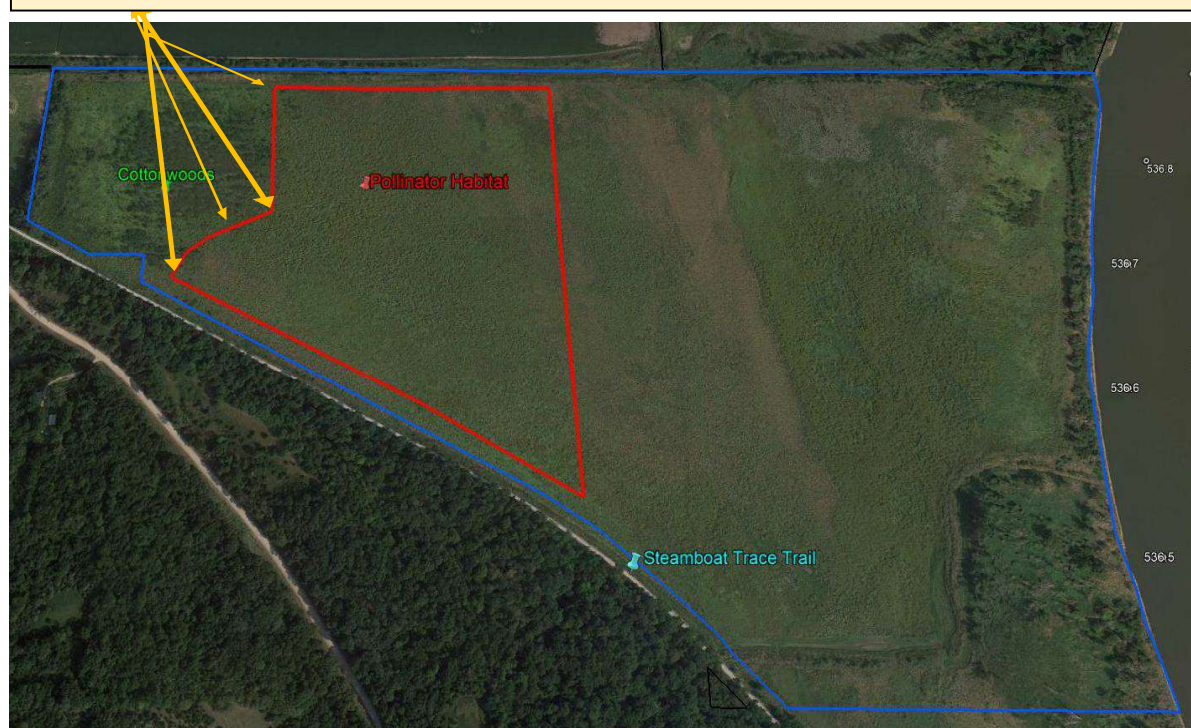
The following have been added by full text:

QUESTION AND ANSWER

Question: We checked the site and even though it is mostly flat, some trees are still present. Are the trees being kept intact for the project or they will need to be cut and removed?

Answer: The larger community of cottonwood saplings that are establishing in the west portion of the site are to REMAIN. However, there will be some small diameter cottonwood saplings that are just outside the perimeter to the east of the larger cottonwood community that will need to be mowed/removed so that there is a clear line/buffer between the larger cottonwood community and the pollinator habitat.

Remove any small cottonwood saplings that are edging outside of the larger cottonwood community towards the east and would be encroaching on the pollinator habitat.
