**Description:**

This is a combined synopsis/solicitation for a commercial items prepared in accordance with the format outlined in FAR Subpart 12.6. Streamlined Procedures for Evaluation and Solicitation for Commercial Items,” as supplemented with additional information included in this notice. This announcement constitutes the only solicitation; Quotes are being requested, and a written solicitation document will not be issued.

The National Park Service, East Buying Office has a requirement to Purchase of a 21'-24' utility boat to enhance resource protection and visitor safety in difficult to patrol areas of Fort Pulaski National Monument. This solicitation is a Request for Quotes (RFQ). The solicitation document and incorporated provisions and clauses are those in effect through Federal Acquisition Circular (FAC) 2023-01.

The associated North American Industrial Classification System (NAICS) code for this procurement is 336612, with a small business size standard of 1,000 employees.

The contractor must have the Representation and Certifications in SAM.gov, completed and updated prior to award.

The Government contemplates the award of a single Firm-Fixed Price Contract using the best value – Lowest Priced Technically Acceptable (LPTA) source selection procedures. All eligible and responsible sources may submit a quote, which if timely received, shall be considered by the Agency. Companies must have valid Unique Entity Identifier (UEI) number and be registered with System for Award Management ([www.sam.gov](http://www.sam.gov)). SAM.gov offers free services. An offeror must ensure that they are self-certified under NAICS Code 336612 in the Representations and Certifications portion of SAM.gov. The basis of award is the responsible offeror whose offer conforming to the solicitation will be most advantageous to the Government, price and other factors considered. Award will be made to the responsible respondent pursuant to FAR subpart 9.1.

All interested companies shall provide quotes for the following:

**Technical/Equipment Specifications:**

**Fort Pulaski National Monument – 21 – 24’ Watercraft**

**1. Background.** Fort Pulaski National Monument (FOPU) is located in Savannah, GA. There is an annual visitation of approximately 400,000 people from around the world that come to view the fort, lighthouse, historic bunkers, cisterns, and trails.

**2. Required Services.** The contractor shall provide a 21’ – 24’ to Fort Pulaski National Monument.

**3. Contractor Responsibilities:**

- Watercraft is to have an overall length of 21’ – 24’
- Watercraft is to have a beam of 96”
- Watercraft is to have a gunnel height of 23”
- Watercraft is to weigh a maximum of 2100 pounds and a maximum of 2695 pounds.
- Watercraft is to have a fuel capacity of 30 gallons
- Draft of the watercraft must be approximately 7”
- Watercraft is to hold no more than 10 persons
- Watercraft is to come equipped with automatic anchoring and one power pole
- Watercraft is to be furnished with electronic equipment including GPS with built-in depth finder, trim tabs, Vhf radio, horn, public address system, and navigation lights
- Watercraft is to have a fiberglass hull
- Watercraft is to come with a trailer that is suited to fit the vessel.
- Watercraft is to have a center console with aluminum T-top with storage.
- Watercraft is to have all safety features per OSHA regulations

This is a best value source selection conducted in accordance with the Federal Acquisition Regulation (FAR) 15.101-2(a). Award will be made on the basis of the lowest evaluated price of quotes meeting or exceeding the acceptability standards for non-cost factors that represents the Best Value – Lowest Price Technically Acceptable (LPTA) offer. The government will evaluate information based on the following evaluation criteria:

(2) The management and daily business operations of which are controlled by one or more veterans.

“Women-owned small business concern” means a small business concern--

(1) That is at least 51 percent owned by one or more women; or, in the case of any publicly owned business, at least 51 percent of the stock of which is owned by one or more women; and

(2) Whose management and daily business operations are controlled by one or more women.

“Women-owned small business (WOSB) concern eligible under the WOSB Program (in accordance with 13 CFR part 127),” means a small business concern that is at least 51 percent directly and unconditionally owned by, and the management and daily business operations of which are controlled by, one or more women who are citizens of the United States.
