**Statement of Work for  
Jet Blast Deflector (JBD) Piston Rod  
13 FEBRUARY 2023**

**1.0 SCOPE**

This Statement of Work (SOW) is for the Firm Fixed Price procurement of 25 each Jet Blast Deflector Piston Rods IAW Naval Air Warfare Center Lakehurst drawing 4950009 Rev C.

The Jet Blast Deflector (JBD) is an essential Aircraft Launch and Recovery Equipment ALRE system on the aircraft carrier associated in the launching of fixed wing aircraft. The Jet Blast Deflector (JBD) system located at catapult station "0" protects the flight deck crew from jet blast during the launching phase of operations. The FRCMA Voyage Repair Team (VRT), a source approved Department of the Navy ALRE ship repair facility has been task overhaul the Jet Blast Deflector (JBD) Hydraulic Cylinders, part number 514762-8 (Cylinder Assembly, Actuating) for fleet use. During disassembly VRT discovered the Piston Rods, P/N 4950009, were unacceptable for continued use and beyond repair. New piston rods are required to be procured and are essential in the reassembly and test of the Cylinder Assembly.

**2.0 REQUIREMENTS****2.1 General**

The Jet Blast Deflector Piston Rods shall be dimensional and manufactured in accordance with (IAW) this SOW; variants, deviations, and departure from specifications are prohibited. The fabrication shall be adhered IAW Naval Air Warfare Center Lakehurst drawing 4950009 Rev C. The manufacture shall incorporate the best engineering practices, and workmanship shall be of the highest quality to meet all applicable published specifications. Vendor will be required to provide a weekly update by email to [charles.k.seader.civ@us.navy.mil](mailto:charles.k.seader.civ@us.navy.mil)

**2.2 Quality Assurance**

The QA system shall be able to ensure that manufactured configuration items are built to print, functional, and reliably made in accordance with controlling technical drawing, specifications and standards. IAW the reference drawing all technical notes are to be adhered to without deviations unless authorized by the VRT Mayport Quality Assurance Representative. Material certifications required upon delivery.

**2.3.1 VRT Mayport Quality Assurance**

VRT Mayport Quality Assurance Representative shall be notified of all issues associated to the technical requirements that are not compliant within the directives of this contract. VRT Mayport Quality Assurance Representative will be the direct liaison between the contractor and Technical Authority (TA). The final acceptance of product in this contract shall be accomplished by the VRT Mayport Quality Assurance (QA) Representative. VRT Mayport Quality Assurance (QA) Representative shall ensure the proper quality of inspections, verification of quality workmanship, and all recordable QA documentation and readings are per established NAWC Lakehurst Engineering technical requirements.

**2.3.2 Certificate of Conformance** The contractor shall provide a Certificate of Conformance (COC), certificate of material used, certificate of the chroming process and dimensional inspections of each manufactured part with shipment of the piston rods certifying that each item is within manufactured conforms to the government drawing package, this SOW, and the requirements of the contract. The COC shall be on company letterhead and signed by management. Each COC shall identify the part number, serial numbers and quantity delivered with shipment. If any parts associated to the Jet Blast Deflector piston rods are found to be non-conforming, they shall be replaced at the Contractor's expense.

**3.0 PACKAGING, PRESERVATION AND SHIPPING**

Packaging and preservation for shipping shall be in accordance with best commercial practices. ## 52.219-28 POST-AWARD SMALL BUSINESS PROGRAM REREPRESENTATION (OCT 2022)

(a) Definitions. As used in this clause--

Long-term contract means a contract of more than five years in duration, including options. However, the term does not include contracts that exceed five years in duration because the period of performance has been extended for a cumulative period not to exceed six months under the clause at 52.217-8, Option to Extend Services, or other appropriate authority.

Small business concern--

(1) Means a concern, including its affiliates, that is independently owned and operated, not dominant in its field of operation, and qualified as a small business under the criteria in 13 CFR part 121 and the size standard in paragraph (d) of this clause.

“Business operations” means engaging in commerce in any form, including by acquiring, developing, maintaining, owning, selling, possessing, leasing, or operating equipment, facilities, personnel, products, services, personal property, real property, or any other apparatus of business or commerce.

“Marginalized populations of Sudan” means--

(1) Adversely affected groups in regions authorized to receive assistance under section 8(c) of the Darfur Peace and Accountability Act (Pub. L. 109-344) (50 U.S.C. 1701 note); and

(2) Marginalized areas in Northern Sudan described in section 4(9) of such Act.

(3) Any successor, subunit, parent company or subsidiary of any entity described in paragraphs (1) or (2) of this definition.

“Restricted business operations” means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate—

(1) Are conducted under contract directly and exclusively with the regional government of southern Sudan;

(2) Are conducted pursuant to specific authorization from the Office of Foreign Assets Control in the Department of the Treasury, or are expressly exempted under Federal law from the requirement to be conducted under such authorization;

(3) Consist of providing goods or services to marginalized populations of Sudan;

(4) Consist of providing goods or services to an internationally recognized peacekeeping force or humanitarian organization;

(5) Consist of providing goods or services that are used only to promote health or education; or

(6) Have been voluntarily suspended.

(b) Certification. By submission of its offer, the offeror certifies that the offeror does not conduct any restricted business operations in Sudan.
