Repair of ramp and anchors attached to Space Saver system located in Pharmacy at 30 MDG. Costs will be related to materials (steel shelving, wood, plastic pieces, flooring) and labor.

**Section C: Justification for Soliciting from a Single Source or Brand Name**

(A) This system has been damaged for 8 months now and presents a work place hazard. One member has already tripped on the damaged ramp of the system, leading to injury and a safety incident.

(B) If a company other than a Spacesaver authorized retailer/installer were to conduct repairs on the system, the Lifetime Warranty covering the entirety of the system would be voided. While this specific work is not covered under the warranty (due to the damage being caused by the VAV Flooding Event), the warranty is key to ensuring potential future repairs are covered. The system was recently installed costing \$175,000.

(C) Spacesaver was contacted regarding a list of authorized retailer/installers and the government point of contact stated McMurray Stern was the only authorized retailer/installer for our area, if an authorized retailer/installer from a different region were to accomplish the work it would incur additional charges and require an agreement with McMurray Stern to conduct the work.

**Section D: Efforts to Obtain Competition**

Multiple companies have been contacted to obtain a quote for service/repair of this system. To date no quotes have been received except from the company that the system was purchased from. If repair was completed by another company the warranty for the system would be voided.



**Section E: Steps to Preclude Future Single Source or Brand Name Awards**

Considering warranty as a factor, all future awards should be considered single source or brand name unless the quote from the single source is of an unreasonable and unjustifiable amount. If the system warranty ever expires then other than single source repairs could be made, but at this time a single source is required.
