Section B: Description of the Supplies/Services Required

2 MXS Transient Alert (TA) program office is requesting a modification to the terms and conditions IAW FAR 52.212-4(c) for contract, [REDACTED]. The extension and subsequent modification will result in the addition of twelve (12) months of service until AF Transient Alert Services (763 ESS) is able to incorporate an additional contract vehicle consisting of one (1) base year and four (4) option years.

Section C: Justification for Soliciting from a Single Source or Brand Name

SAF/AQC has published Mandatory Source Use Policy for United States Transient Alert Services Acquisitions within the Continental United States (See, Attachment 1 - Mandatory Use Policy Letter). The Air Force Installation Contracting Agency (AFICA) and the appropriate Logistics Commodity Council (LGCC) have established eight (8) multiple award indefinite delivery indefinite quantity (IDIQ) contracts to consolidate buying activities for TA Services. The modification will be used as a bridge action to continue coverage of Transient Alert Services until 763 ESS is able to award new IDIQ contracts IAW with published policy. To ensure TA coverage and avoid gaps in service, 2 CONS will extend the contract [REDACTED]. As directed by 763 ESS, an out of scope modification will be executed to ensure zero delay with contract and mission performance (See, Attachment 2 - 763 ESS Guidance). IAW FAR 16.505(b)(2)(C), the Contracting Officer has determined order must be issued on a sole-source basis in the interest of economy and efficiency because it is a logical follow-on to an order already issued under the contract, provided that all awardees were given a fair opportunity to be considered for the original order.

Section D: Efforts to Obtain Competition

This is a mandatory source contracting vehicle. The original solicitation and award were competed to two (2) pools of contractors (Service Disabled Veteran-Owned Businesses and 8(a) Small Businesses) fulfilling Transient Alert services requirements across the Air Force through eight (8) IDIQ contracts. As outlined in the ordering guide Barksdale AFB will continue service with the awardee (T Square Logistics) until the Air Force level contract (FA805917D0009) can be re-competed.

Section E: Steps to Preclude Future Single Source or Brand Name Awards

Upon expiration of services, 2 CONS will compete the requirement IAW SAF/AQC policy guidance and directive. The 763 Enterprise Sourcing Squadron (ESS) has designated Barksdale AFB as an Service-Disabled Veteran-Owned Small Business Pool. Upon termination of this extension, 2 CONS will solicit a new requirement to a pool of six (6) SDVOSB vendors to provide fair opportunity in an effort to not preclude competition, to meet the criteria specified in the SAF/AQC policy letter and TA Ordering Guide (See, Attachment 3 - TA Ordering Guide).
