“In chronological order starting from the most recent, provide name of employer, total period of employment with employer, and a short description of responsibilities and experience relevant to the proposed Key Personnel position for the Northeast Facilities Maintenance and Repair requirements.”

In chronological order starting from the most recent, provide name of employer, total period of employment with employer, and a short description of responsibilities and experience relevant to the proposed Key Personnel position for the Northeast Facilities Maintenance and Repair requirements, including dollar value of contracts you worked on.
