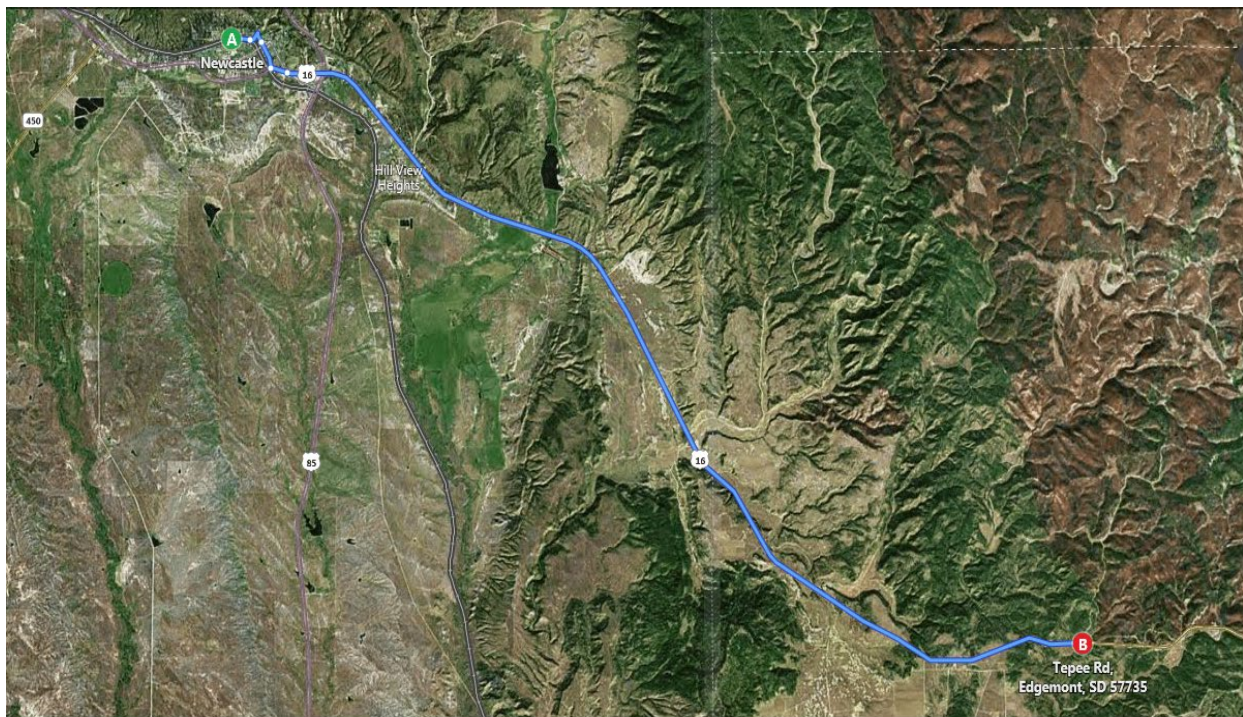

Go approximately .6 miles and you will cross a cattleguard. Take an immediate right at the Forest Service Spearfish Work Center sign. Once you go through the pipe gate, stay left (straight) at the first intersection and right (straight) at the second intersection. This will take you all the way to the back 'boneyard'.

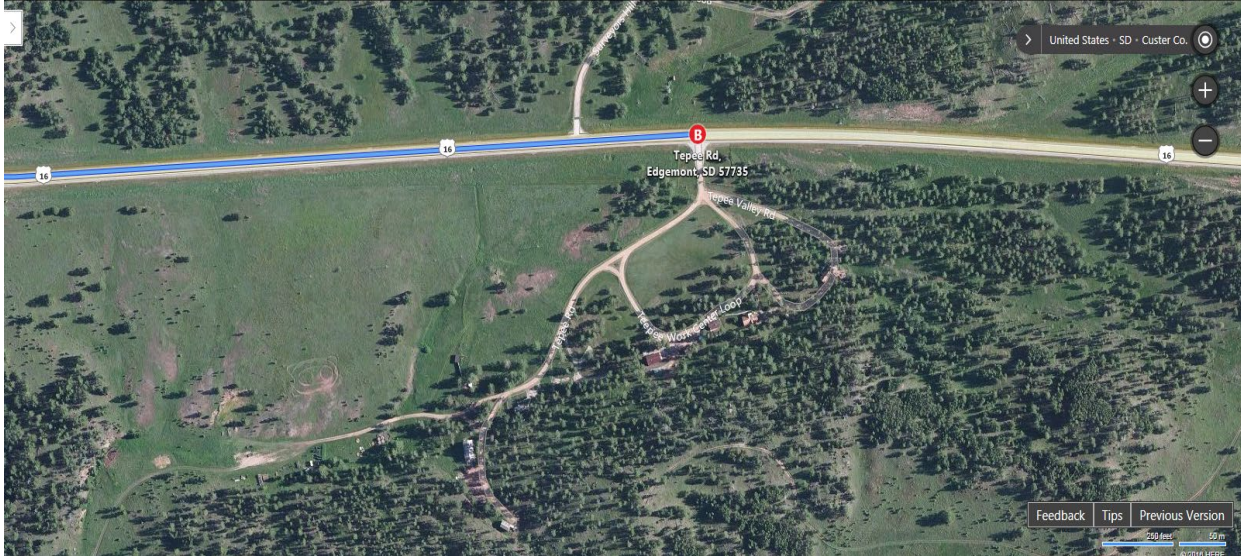
