Amendment 00001 to Solicitation SPE302-23-R-0002/Oahu FF&V for Schools

A. The purpose of this amendment is to response to questions received

Question 1) Some distributors receive a special ocean freight rate due to USDA FF&V box program that other bidders will not be able to utilize. This creates an unfair advantage and may skew the appearance of freight pricing for products not affected or traveling with products for that program. Will this be taken into consideration or measures put in place to ensure that this does not affect the validity of bid freight pricing?

Answer 1) In reference to the USDA Farmers to Families Food Box Program, the Defense Logistics Agency (DLA) Troop Support Indo-Pacific (TS-IP) has determined no advantage exists in correlation due to the following reasons:

- a. This program is not connected to the referenced Hawaii State Department of Education (DoE) school lunch program.
- b. This program has ended as of May 31, 2021.

Question 2) Upon review of the accompanying attachments, the Schedule of Items spreadsheet was missing both NSN numbers as well as quantities. Both of these things, especially the estimated quantities, are necessary in putting together a complete bid. Will there be an amendment issued with a corrected Schedule of Items?

Question 3) The solicitation does not contain the "Offerors Representations and Certificates." Will DLA provide an amended solicitation with this section added?

Answer 3) Amendment to PAGE 57  
Added 52.212-3 Offeror Representations and Certifications—Commercial Products and Commercial Services (May 2022) to section Part 12 Provisions.

Question 4) The date range provided in the solicitation for pricing documentation exists entirely in the past (December). Traditionally, solicitations have included approximately two weeks past and two weeks future from the date of issue. Would DLA consider amending the date range to allow for this as it encourages a more competitive bid and allows for more accurate and complete pricing documentation and invoicing? If a quote must be provided, it would be inaccurate if requested from a date past.

Answer 4) No change. DLA TS-IP has determined that the pricing documentation requested in subject solicitation will suffice.

Question 5) Due to the current economic conditions, with rising costs of labor and transportation, we would kindly request that DLA consider revising the minimum delivery amount from \$75.00 to \$150.00 per drop.
