Libby Dam Penstock Access Platforms  
Libby, MT

1. **MATERIALS REQUIRED:**

Acceptance of Materials:

Materials will be inspected at the jobsite prior to acceptance. Contractor shall be responsible for maintaining product condition as specified until the point of acceptance. Vendors shall supply items in the sizes and quantities specified to satisfy the requirements of this contract. New equipment only, no remanufactured or "gray market" items. All items must be covered by manufacturer's warranty.

2. **DELIVERY LOCATION:**

3. **MATERIALS SPECIFICATIONS:**

Elevated platform equipment including stairs, connecting hardware and concrete anchors shall be constructed from galvanized steel. The equipment must be compatible with attached drawing and must comply with all U.S. Army Corps of Engineers safety regulations manual EM 385-1-1 (<https://www.usace.army.mil/Missions/Safety-and-Occupational-Health/>) and shall meet all OSHA requirements.

4. **DELIVERY:**

Items shall be delivered, disassembled, within 60 days after award to the above government facility.

5. **SYSTEM CHARACTERISTICS:**

- The system shall be designed by a licensed professional engineer who will serve as the designer of record.
- The system shall be designed to carry a minimum of 500 pounds per square foot and a minimum overall load rating of 10,000 pounds for each individual platform. The designer of record shall designate the actual design load ratings for the individual platform on the stamped drawing.
- The system shall be designed such that field assembly is mechanical and does not require cutting or welding.
- The system shall be designed such that each component can fit through an opening which is 55" X 88".
- The system shall be designed such that the hand rails are removable.
- The system shall be designed such that the base mounts to an existing concrete slab.
- The system shall be designed to match the dimensional parameters of the contract drawing.

a) Guardrail Systems

Guardrail systems shall be so surfaced as to prevent injury to a worker from punctures or lacerations and to prevent snagging of clothing.

Guardrail shall consist of:

- Top rails, midrails, and posts, and shall have a vertical height of 42 +/- 3 in (106.6 cm +/- 7.6 cm) from the upper surface of the top rail to the floor, platform, runway, or ramp level;
- Midrails shall be erected halfway between the top rails and the floor, platform, runway, or ramp;
- The ends of the top rails and midrails shall not overhang the terminal posts except where such overhang does not create a projection hazard;
- Toe-boards shall be provided on all open sides/ends at locations where persons are required or permitted to pass or work under the elevated platform or where needed to prevent persons and material from falling from the elevated platform.

b) Strength Requirements:

Top rails and mid-rails shall be designed to meet the following requirements:

- Top rail shall be capable of withstanding, without failure, a force of at least 200 lb. (0.9 kN) applied within 2 in (5 cm) of the top edge, in any outward or downward direction, at any point along the top edge;
- When the force described in (1), above, is applied in a downward direction, the top edge of the top rail shall not deflect more than 3 in (7.6 cm) nor to a height less than 39 in (99 cm) above the walking/working level;
- Midrails, screens, mesh, intermediate vertical members, solid panels, and equivalent structural members shall be capable of withstanding, without failure, a force of at least 150 lb. (666 N) applied in any downward or outward direction at any point along the midrail or other member;

6. **MINIMUM CONSTRUCTION MATERIALS FOR STANDARD GUARDRAIL COMPONENTS.**

The following are minimum requirements used for constructing guardrail systems.

a) Pipe Railings:

- Top rails and midrails: At least 1 ½ in (3.8 cm) nominal diameter (schedule 40 steel pipe); and
- Posts: At least 1 ½ in (3.8 cm) nominal diameter (schedule 40 steel pipe) spaced not more than 8 ft (2.4 m) on centers.
- Top rails and midrails: At least 2-in x 2-in x 3/8 in (5 cm x 5 cm x .9 cm) angles, and,
- Posts: At least 2-in x 2-in x 3/8-in (5 cm x 5 cm x .9 cm) angles spaced not more than 8 ft (2.4 m) on centers.

b) Toe-boards:

- Toe-boards shall be 3½ in (8.75 cm) in vertical height.
- Toe-boards shall be securely fastened in place and have not more than ¼ in (0.6 cm) clearance above floor level.
- Toe-boards shall be made of any galvanized steel, either solid or with openings between adjacent pieces not greater than 1 in (2.5 cm).
- Toe-boards shall be able to withstand, without failure, a force of 50 lbs. (0.22 kN) applied in any outward or downward direction at any point along the toe-board.

**\*\*\*NOTE:** Commercial, off-the-shelf (COTS), engineered systems may be provided instead of constructing a system as long as the system meets these specifications in its entirety.

7. **DRAWINGS:**

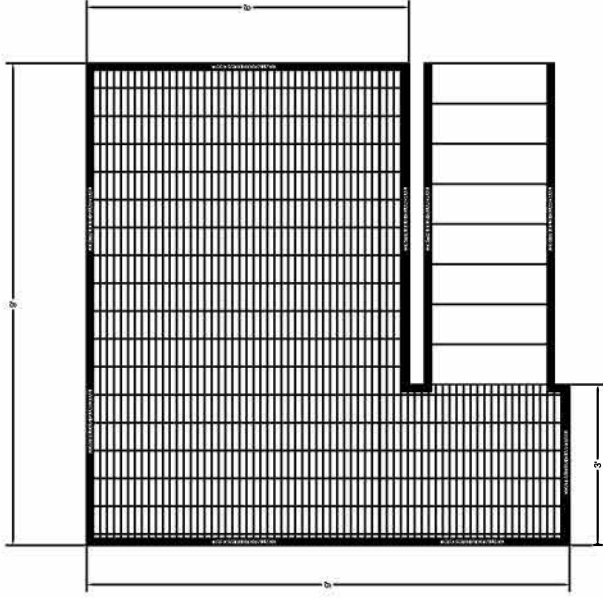
- The contractor shall furnish stamped engineering drawings by the designer of record within 30 days of award. The government shall review and accept or reject submittal within 7 days of receipt. Any proposed modifications to the system after acceptance of the stamped engineering drawings will require written approval from the designer of record.
- The contractor shall furnish 3 (three) copies of shop drawings within 15 days after the acceptance of stamped engineering drawings. The government shall review and accept or reject submittal within 7 days of receipt. Acceptance of shop drawings shall constitute notice to proceed with fabrication.
- The contractor shall furnish field fabrication drawings which, at a minimum, shall graphically identify all components showing details for all field connections including connector sizes.

8. **FIELD FABRICATION:**

Field fabrication shall be performed by government personnel within 1 (one) calendar year of acceptance of delivery. The contractor shall have the following responsibilities during field fabrication:

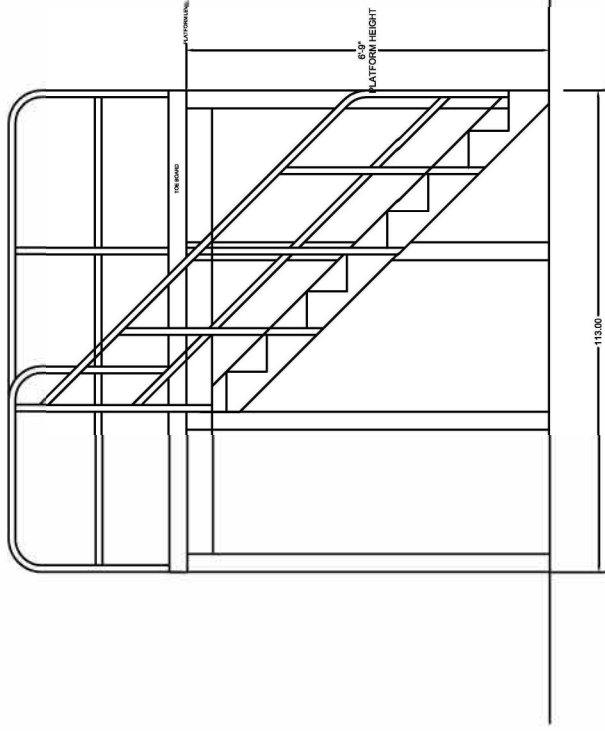
- The contractor shall provide verbal or written guidance to resolve issues where the contractor's product differs from field fabrication drawings provided.

- In the event that verbal or written guidance cannot resolve the issue, the contractor shall perform a site visit at no additional charge to the government to correct the defect.
- In the event that the issue cannot be corrected in the field, the contractor shall be responsible for replacing the defective part(s) in their entirety, at no additional cost to the government.



The section of the OSHA code that applies most directly to guardrail and safety railing is 1910.23. Specifically the following sections are the most relevant to guardrail construction.

- 1910.23(e)(1) – A standard railing shall consist of top rail, intermediate rail, and posts, and shall have a vertical height of 42 inches nominal from upper surface of top rail to floor, platform, runway, or ramp level. The top rail shall be smooth-surfaced throughout the length of the railing. The intermediate rail shall be approximately halfway between the top rail and the floor, platform, runway, or ramp. The ends of the rails shall not overhang the terminal posts except where such overhang does not constitute a projection hazard.
- 1910.23(e)(3)(ii) – For pipe railings, posts and top and intermediate railings shall be at least 1 1/2 inches nominal diameter with posts spaced not more than 8 feet on centers.
- 1910.23(e)(3)(iv) – The anchoring of posts and framing of members for railings of all types shall be of such construction that the completed structure shall be capable of withstanding a load of at least 200 pounds applied in any direction at any point on the top rail.
- 1910.23(e)(4) – A standard toeboard shall be 4 inches nominal in vertical height from its top edge to the level of the floor, platform, runway, or ramp. It shall be securely fastened in place and with not more than 1/4-inch clearance above floor level. It may be made of any substantial material either solid or with openings not over 1 inch in greatest dimension.

#### CLAUSES INCORPORATED BY FULL TEXT

#### 52.204-17 OWNERSHIP OR CONTROL OF OFFEROR (AUG 2020)

(a) Definitions. As used in this provision--

Commercial and Government Entity (CAGE) code means—

(1) An identifier assigned to entities located in the United States or its outlying areas by the Defense Logistics Agency (DLA) Commercial and Government Entity (CAGE) Branch to identify a commercial or government entity by unique location; or

(2) An identifier assigned by a member of the North Atlantic Treaty Organization (NATO) or by the NATO Support and Procurement Agency (NSPA) to entities located outside the United States and its outlying areas that the DLA Commercial and Government Entity (CAGE) Branch records and maintains in the CAGE master file. This type of

code is known as a NATO CAGE (NCAGE) code.

Highest-level owner means the entity that owns or controls an immediate owner of the offeror, or that owns or controls one or more entities that control an immediate owner of the offeror. No entity owns or exercises control of the highest level owner.

Immediate owner means an entity, other than the offeror, that has direct control of the offeror. Indicators of control include, but are not limited to, one or more of the following: Ownership or interlocking management, identity of interests among family members, shared facilities and equipment, and the common use of employees.

  - (4) Construction by special trade contractors, it will not pay more than 75 percent of the amount paid by the Government for contract performance, excluding the cost of materials, to subcontractors that are not similarly situated entities. Any work that a similarly situated entity further subcontracts will count towards the prime contractor's 75 percent subcontract amount that cannot be exceeded.

Issuing agency code means a code that designates the registration (or controlling) authority for the enterprise identifier.

Item means a single hardware article or a single unit formed by a grouping of subassemblies, components, or constituent parts.

Lot or batch number means an identifying number assigned by the enterprise to a designated group of items, usually referred to as either a lot or a batch, all of which were manufactured under identical conditions.

Machine-readable means an automatic identification technology media, such as bar codes, contact memory buttons, radio frequency identification, or optical memory cards.

Original part number means a combination of numbers or letters assigned by the enterprise at item creation to a class of items with the same form, fit, function, and interface.

(a) Definitions. As used in this clause—

“Department of Defense Activity Address Code (DoDAAC)” is a six position code that uniquely identifies a unit, activity, or organization.

“Document type” means the type of payment request or receiving report available for creation in Wide Area WorkFlow (WAWF).

“Local processing office (LPO)” is the office responsible for payment certification when payment certification is done external to the entitlement system.

“Payment request” and “receiving report” are defined in the clause at 252.232-7003, Electronic Submission of Payment Requests and Receiving Reports.

(b) Electronic invoicing. The WAWF system provides the method to electronically process vendor payment requests and receiving reports, as authorized by Defense Federal Acquisition Regulation Supplement (DFARS) 252.232-7003, Electronic Submission of Payment Requests and Receiving Reports.

(c) WAWF access. To access WAWF, the Contractor shall—

(1) Have a designated electronic business point of contact in the System for Award Management at <https://www.sam.gov>; and

(2) Be registered to use WAWF at <https://wawf.eb.mil/> following the step-by-step procedures for self-registration available at this web site.

(d) WAWF training. The Contractor should follow the training instructions of the WAWF Web-Based Training Course and use the Practice Training Site before submitting payment requests through WAWF. Both can be accessed by selecting the “Web Based Training” link on the WAWF home page at <https://wawf.eb.mil/>.



(e) WAWF methods of document submission. Document submissions may be via web entry, Electronic Data Interchange, or File Transfer Protocol.

(f) WAWF payment instructions. The Contractor shall use the following information when submitting payment requests and receiving reports in WAWF for this contract or task or delivery order:

(1) Document type. The Contractor shall submit payment requests using the following document type(s):

(i) For cost-type line items, including labor-hour or time-and-materials, submit a cost voucher.

(ii) For fixed price line items—

(A) That require shipment of a deliverable, submit the invoice and receiving report specified by the Contracting Officer.

“Not Applicable”

(B) For services that do not require shipment of a deliverable, submit either the Invoice 2in1, which meets the requirements for the invoice and receiving report, or the applicable invoice and receiving report, as specified by the Contracting Officer.

(Contracting Officer: Insert either “Invoice 2in1” or the applicable invoice and receiving report document type(s) for fixed price line items for services.)

(iii) For customary progress payments based on costs incurred, submit a progress payment request.

(iv) For performance based payments, submit a performance based payment request.

(v) For commercial item financing, submit a commercial item financing request.

(2) Fast Pay requests are only permitted when Federal Acquisition Regulation (FAR) 52.213-1 is included in the contract.

[Note: The Contractor may use a WAWF “combo” document type to create some combinations of invoice and receiving report in one step.]

(3) Document routing. The Contractor shall use the information in the Routing Data Table below only to fill in applicable fields in WAWF when creating payment requests and receiving reports in the system.
