AFMC AFRL/RW at Eglin AFB is requesting to limit sources to a single source, Allied Universal Technology Services (AUS), to provide and install Lenel Security Systems necessary for the the consolidation of all outlying, stand alone AFRL facility Lenel systems into a single system controlled in total from the Security Office in building 13 on Eglin, AFB. Purchasing from a different company would incur a larger cost to the government from the purchase, training on, installation of new equipment, infrastructure, and software.

**I. Contracting Activity.**

AFRL/RWK at Eglin AFB

**II. Nature and/or description of the action being processed.**

Sole source justification for the consolidation for the Lenel Access Control System for building 13. A new firm fixed price task order to be issued against a GSA schedule, GS-07F-0251N with Allied Universal Technology Services (AUS), Delivery NLT 100 days ARO.

**III. Description of supplies/services required to meet agency needs.**

AUS will provide all the equipment for the consolidation and installation of Lenel Security System.

**IV. Identification of the justification/rationale for limiting sources and demonstration of the contractor's unique qualifications to provide the required supply/service.**

IAW FAR 8.405-6(a)(1)(i)(B), limiting sources to a single one, AUS, is in the best interest and value to the government.

AUS is the only contractor capable of providing this service. Due to the existing badge equipment being supplied by AUS and switching to another provider/contractor would incur additional costs to the government in terms of man hours, additional equipment/infrastructure, and funds to complete. This effort will add new compatible equipment to what is currently being used for AFRL/RW.

**V. Determination by the ordering activity Contracting Officer that the order represents the best value consistent with FAR 8.404(d).**

The ordering activity has concluded that the order represents best value and results in the lowest overall cost alternative, due to the special features, and the administrative cost and delivery schedule. The Contracting Officer will perform a price reasonableness determination as part of the best value determination. Pricing will be compared to pricing found fair and reasonable on previous orders for the same/similar equipment/services.

**VI. Description of the market research conducted and the results, or explain why market research was not conducted.**

AFRL/RW currently has a variety of AUS, Lenel Access Control System badging equipment in use. Additional equipment is needed for additional facilities and to enhance the capability of the existing badging system. Utilizing another system would require additional systems to be purchased replacing what is currently in place and would require additional training for the individuals issuing badges. Buying the equipment from Allied Universal Technology Services is the most economical choice given the equipment currently on hand, the additional cost to replace existing equipment, and additional cost to train on any new system.

**VII. Other facts supporting the justification.**

A sources sought was posted to the SAM.gov on 11 January 2023 and was active on the site for 6 days. No responses were received in relation to the posting.

The Government, when fielding new systems competitively, researches all potential technical and cost effective solutions. It is in the best interest of the government to obtain competition when new or future requirements exist.
