Refresh existing AV hardware components / software runtime related to the CRESTRON A/V system within the Command Post.

Section C: Justification for Soliciting from a Single Source or Brand Name

In order to ensure LRAFB Bldg 314 Command Post gets the exact specialized equipment, configuration, custom software, and on-site local support, and due to the custom software and hardware configurations that are being used in this system that are custom made, the Government requires a Sole Source for this specific contract.

1. I-Tech AV Sole Source for specific Crestron system. Due to the specialized source code, owned by I-Tech AV, that enables system operation and due to service and maintenance for fast accurate work these specifications are listed as a sole source for I-Tech A/V to Little Rock Air Force Base for this contract only. If it does not match up properly with the existing systems in the building, then the new equipment will not work in conjunction with other systems and with existing equipment.

I-TECH AV is the only company that can provide the equipment, and ongoing technical skills for these systems, has the necessary qualifications and has the existing M&S to keep our systems up and running for our necessary missions.

Section D: Efforts to Obtain Competition

This would be extraordinarily cost prohibitive to have another integrator develop a new software that would be able to integrate in an acceptable manner with existing Crestron installation in building 314. Because I-TECH AV owns the original source code at Little Rock AFB, they are the only business that can provide a fiscally responsible upgrade of our existing equipment or modify the existing run time code on CRESTRON AV installations in building 314.

Section E: Steps to Preclude Future Single Source or Brand Name Awards

Due to the nature of the system and custom code developed for LRAFB, this project in particular should only be sourced to I-TECH AV. The Government will continue to look for alternative areas for potential competition on future requirements.
