STATEMENT OF WORK

Project Title: Super 30 DI Tank Rental/Changeout Contract

Location: NIST, Gaithersburg, MD

Work Order No: Building 227 – Advanced Chemical Sciences Building

1.1 Background Information

In the attic of Bldg. 227 there is a US Filter supplied Central Water Purification System. The system consists of duplex pretreatment, two reverse osmosis systems, a CDI unit, and deionizer polishing. The system is designed to provide CAP III purified water quality at 125 gpm measured at the 0.1-micron final filters.

The polishing system consists of two distribution pumps (parallel), four Super 30 vessels (2 sets of 2 in parallel), 185nm ultraviolet sterilizer, and 0.1-micron cartridge filter/housings (parallel). The four (4) Super 30 mixed bed polishing deionizers' function is to polish the water in the recirculation loop. The columns are designed to run two (2) in parallel followed by a second set of (2) in parallel. Although there are no "shut-off/turn-on" interlocking devices, for monitoring purposes, there is a resistivity sensor located before and after each set of two (2) super 30's.

1.2 Objectives.

The objective is to obtain a service contractor to provide rental to NIST, four (4) Super 30 service deionizer vessels (30 cubic feet) for the award period of performance. These units will serve the Evoqua Water Technologies (US Filter) pure water system located in Building 227, Room 400.

PART 2: - CONTRACTOR REQUIREMENTS

2.1 Contractor Scope of Work

- 1.A. Contractor shall provide rental to NIST, four (4) Super 30 service deionizer vessels (30 cubic feet) for the award period of performance. These units will serve the Evoqua Water Technologies (US Filter) pure water system located in Building 227.
- 1.B. Contractor shall provide all labor, equipment and material needed to exchange two (2) mixed bed Super 30 deionizer vessels, 30 cubic feet, type 1 resin, on a semi-annual basis for the awarded period of performance. Two (2) Super 30 deionizer vessels will be changed out within the first two (2) weeks of award. Ever six (6) months after the first exchange, the next two (2) Super 30 deionizer vessels will be

changed. This process of rotating two (2) vessels out every six (6) months will continue until the contract is completed.

1.C. The contractor shall insure there are no leaks in any of the hoses or fittings after the change out.

1.D. The contractor shall check the final quality of the water after a tank has been exchanged. Acceptable levels will be 16 megaohm or higher.

1.E. The contractor shall coordinate delivery of tanks through NIST Pipe Shop, Jeff Smith 301-975- 6943.

2.2 Specifications

2.A. Tank Specifications:

2.A.1. Flow Rate: 100 GPM

2.A.2. Tank Volume: 30 ft³

2.A.3. Size: Tanks shall not be taller than 80" and wider than 40"

2.A.4. Pressure tested at 80psig

2.A.5. 2" flange hose connections

2.A.6. Steel construction

2.B. Resin

2.B.1. Type: Mixed bed

2.B.2. Volume: 30 ft³

PART 3: GOVERNMENT RESPONSIBILITIES

3.1 Project Planning

1.A. The government will arrange for visitor badges at the main entrance and will have escorts available to guide the contractor to the proper location.

1.B. The government will schedule water outage in building 227 and notify lab users.

PART 4: REPORTING REQUIREMENTS AND DELIVERABLES

4.1 Service Documents

1.A. Contractor will provide the Contracting Officer's Representative (COR) with a copy of all service reports generated after Super 30 tanks have been exchanged. Any issues with the change out must be documented.

1.B. Service documents should include final quality of the water after tanks were removed.

1.C. Final water quality reports will be attached to each tank.

4.2 Deliveries

2.A. Contractor will notify NIST, 1 week prior to deliveries.

2.B. Contractor will be responsible for providing the necessary equipment and labor to move tanks from their truck to the penthouse of building 227.

2.C. NIST will be responsible for arranging access to the facility and providing an escort within building 227.

2.D. NIST assigned escorts will assist the contractor in isolating tanks before a switch is made.

2.E. Contractor will replace tanks and make final connections.

PART 5: PROGRAM MANAGEMENT AND CONTROL REQUIREMENTS

5.1 Quality Control

1.A. Contractor will be responsible for quality control of rental tanks.

1.A.1. Ensure the resin used in the tanks meets requirements.

1.A.2. Ensure tanks are properly sized and pressure tested.

1.A.3. Contractor is responsible for safely transporting tanks and delivering them to Room 400 in Bldg. 227 on the NIST campus.

5.2 Period of Performance

2.A. The contractor will provide pricing for a 1-year award with 4 option years.

PART 6: INSPECTION AND ACCEPTANCE CRITERIA

6.1 Inspections

1.A. COR will inspect installation of tanks after the contractor has completed delivery.

1.B. Tanks will be visually inspected for any damage and compliance with specifications.

- 1.C. Final water quality reports for each tank will be evaluated for acceptance by the COR.
