REQUEST FOR PROPOSAL (RFP) # 47QSWC23R0001 Level 1 Armored Utility Vehicle (UV)

A. This is a combined Synopsis/Solicitation for commercial item (Supplies and Services) prepared in accordance with (IAW) the format in FAR Subpart 12.603, as supplemented with additional information included in this notice. This announcement constitutes the only solicitation. This solicitation is issued as an RFP and in accordance with FAR Part 12, the acquisition of Commercial Products and Commercial Services and FAR Part 15, Contracting by Negotiation as a Total Small Business Set-Aside IAW FAR Part 19. The incorporated provisions and clauses are those in effect through Federal Acquisition Circular (FAC) 2023-01

C. Background: This RFP is being issued by GSA on behalf of the U.S. Air Force Life Cycle Management Center (AFLCMC), Support Equipment & Vehicles, located in Robins Air Force Base, GA. to procure NATO Standard STANAG 4569 Level 1 Armored Utility Vehicles (UV). The vehicles must be a retrofitted commercial full-size sport utility vehicle (UV) or pickup truck (with enclosed bed) capable of transporting a four-man crew, plus cargo, with on- and off-road

capabilities. The vehicles must also provide ballistic protection to a four-man crew and is capable of carrying a payload of 1,500 pounds across all surfaces, include primary roads, secondary roads, and cross county. The vehicle shall meet the definition of a modified commercial product as stated in FAR 2.101. The vehicle, at a minimum, shall be the manufacturer's standard commercial product modified as necessary to be in accordance with the requirements specified herein. Additional or complimentary features which are not specifically prohibited by these specifications, but which are part of the manufacturer's standard product, shall be included in the unit being proposed.

D. General Services Administration (GSA) Federal Acquisition Service (FAS) Large Special Order Program (SOP) anticipates awarding a single award, Firm-Fixed Price (FFP) Indefinite Delivery, Indefinite Quantity contract (IDIQ) contract as the result of this RFP. A combined Synopsis/Solicitation will be provided electronically only. The solicitation number is 47QSWC23R0001 and issued as an RFP. The applicable North American Industrial Classification Code System (NAICS) code 336110 Automobile and Light Duty Motor Vehicle Manufacturing and small business size standard is 1,500 employees. The appropriate Product and Service Code (PSC) is 2310 - Passenger Motor Vehicles. E. This is an RFP for the procurement of Level 1 Armored UVs.

F. PHASE II – Oral Presentations:

Offerors who successfully pass Phase I of the technical evaluation will be invited to provide an oral presentation to GSA Contracting personnel, Technical Evaluation Board (TEB) members and AFLCMC representatives. The Government intends to conduct the Oral Presentations between Tuesday May 9th, 2023, and Thursday, May 11th, 2023, in Fort Worth, TX. Offerors who pass Phase I of the technical evaluation shall be notified of the

exact time and location for oral presentations no later than close of business (COB) April 21st, 2023.

- G. Delivery terms: Base Contract: The resulting IDIQ contract will consist of a 12 month base delivery period plus four (4) 12 month optional delivery periods.

Delivery Terms: The client requires the delivery of the first two Level 1 Armored UVs within 270 days after receipt of award (ARO). Offerors will be encouraged to provide their best delivery terms that meet or exceed the required delivery schedule. Any delays or extensions beyond this delivery term shall be coordinated between the Government and Contractor and via bilateral contract modification.

- H. Shipping and handling terms: F.O.B. Destination – CONUS pricing. Inspection and Acceptance at Destination. The Contractor shall coordinate delivery of all UVs with the client designated point of contact (POC) for consolidation, storage, and shipping. The Contractor shall notify the POC when equipment is shipped from the Manufacturer's facility. The Contractor is to notify the POC prior to special delivery if special Material Handling Equipment (MHE) is required to offload the equipment once it arrives at their facility.

Preparation for Delivery: The item(s) shall be packaged and packed to afford adequate protection against physical damage during shipment from the supplier to the first receiving activity. The packaging shall comply with the rules and regulations applicable to the mode of transportation. Requirement for inspection and testing for the Level 1 Armored UV can be found in Attachment 1: CID and Specifications_ Level 1 Armored Utility Vehicle.

- I. This is ONLY a request for pricing. DO NOT SHIP begin production or ship any items based upon the posting of this RFP.
- J. The Government intends to award on initial proposals and advises offerors to submit their best terms and prices in their initial proposal.
- K. STANDARD COMMERCIAL WARRANTY REQUIREMENT. The Government is requiring that all items in any resulting contract have a Standard Commercial Warranty.
- L. Proposals shall be submitted electronically in GSA's ASSIST Electronic Order System. The offeror should allow enough time before the closing date and time to ensure successful and timely submission of proposal. N. Proposal Development Instructions: The contractor must submit the proposal documents/media by the dates and times established in the RFP. (a) Any supplies and services to be furnished under this contract shall be ordered by issuance of delivery orders or task orders by the individuals or activities designated in the Schedule. Such orders may be issued from date of award and no later than 5 years after award date (depending on option(s) exercised)

(b) All delivery orders or task orders are subject to the terms and conditions of this contract. In the event of conflict between a delivery order or task order and this contract, the contract shall control.

(c) A delivery order or task order is considered "issued" when—

- (1) If sent by mail (includes transmittal by U.S. mail or private delivery service), the Government deposits the order in the mail;
- (2) If sent by fax, the Government transmits the order to the Contractor's fax number; or
- (3) If sent electronically, the Government either—
 - (i) Posts a copy of the delivery order or task order to a government document access system, and notice is sent to the Contractor; or
 - (ii) Distributes the delivery order or task order via email to the Contractor's email address.

(c) Orders may be issued by methods other than those enumerated in this clause only if authorized in the contract.

52.216-19 Order Limitations. (Oct 1995)

(a) Minimum order. When the Government requires supplies or services covered by this contract in an amount of less than 2 each, the Government is not obligated to purchase, nor is the Contractor obligated to furnish, those supplies or services under the contract.

(b) Maximum order. The Contractor is not obligated to honor-

(1) Any order for a single item in excess of 60 each;

(2) Any order for a combination of items in excess of 301 each; or

(3) A series of orders from the same ordering office within 270 days that together call for quantities exceeding the limitation in paragraph (b)(1) or (2) of this section.

(c) If this is a requirements contract (i.e., includes the Requirements clause at subsection 52.216-21 of the Federal Acquisition Regulation (FAR)), the Government is not required to order a part of any one requirement from the Contractor if that requirement exceeds the maximum-order limitations in paragraph (b) of this section.

(d) Notwithstanding paragraphs (b) and (c) of this section, the Contractor shall honor any order exceeding the maximum order limitations in paragraph (b), unless that order (or orders) is returned to the ordering office within 10 days after issuance, with written notice stating the Contractor's intent not to ship the item (or items) called for and the reasons. Upon receiving this notice, the Government may acquire the supplies or services from another source.

52.216-22 Indefinite Quantity. (Oct 1995)

(a) This is an indefinite-quantity contract for the supplies or services specified, and effective for the period stated, in the Schedule. The quantities of supplies and services specified in the Schedule are estimates only and are not purchased by this contract.

(b) Delivery or performance shall be made only as authorized by orders issued in accordance with the Ordering clause. The Contractor shall furnish to the Government, when and if ordered, the supplies or services specified in the Schedule up to and including the quantity designated in the Schedule as the "maximum." The Government shall order at least the quantity of supplies or services designated in the Schedule as the "minimum."

(c) Except for any limitations on quantities in the Order Limitations clause or in the Schedule, there is no limit on the number of orders that may be issued. The Government may issue orders requiring delivery to multiple destinations or performance at multiple locations.

(d) Any order issued during the effective period of this contract and not completed within that period shall be completed by the Contractor within the time specified in the order. The contract shall govern the Contractor's and Government's rights and obligations with respect to that order to the same extent as if the order were completed during the contract's effective period; provided, that the Contractor shall not be required to make any deliveries under this contract after final exercised option delivery period ends plus 270 days.

52.217-9 Option to Extend the Term of the Contract. (MAR 2000)

(a) The Government may extend the term of this contract by written notice to the Contractor within 30 days provided that the Government gives the Contractor a preliminary written notice of its intent to extend at least 60 days before the contract expires. The preliminary notice does not commit the Government to an extension.

(b) If the Government exercises this option, the extended contract shall be considered to include this option clause.

(c) The total duration of this contract, including the exercise of any options under this clause, shall not exceed 5 years.

52.246-2 INSPECTION OF SUPPLIES—FIXED-PRICE (AUG 1996)

(a) *Definition.* "Supplies," as used in this clause, includes but is not limited to raw materials, components, intermediate assemblies, end products, and lots of supplies.

(b) The Contractor shall provide and maintain an inspection system acceptable to the Government covering supplies under this contract and shall tender to the Government for acceptance only supplies that have been inspected in accordance with the inspection system and have been found by the Contractor to be in conformity with contract requirements. As part of the system, the Contractor shall prepare records evidencing all inspections made under the system and the outcome. These records shall be kept complete and made available to the Government during contract performance and for as long afterwards as the contract requires. The Government may perform reviews and evaluations as reasonably necessary to ascertain compliance with this paragraph. These reviews and evaluations shall be conducted in a manner that will not unduly delay the contract work. The right of review, whether exercised or not, does not relieve the Contractor of the obligations under the contract.

(c) The Government has the right to inspect and test all supplies called for by the contract, to the extent practicable, at all places and times, including the period of manufacture, and in any event before acceptance. The Government shall perform inspections and tests in a manner that will not unduly delay the work. The Government assumes no contractual obligation to perform any inspection and test for the benefit of the Contractor unless specifically set forth elsewhere in this contract.

(d) If the Government performs inspection or test on the premises of the Contractor or a subcontractor, the Contractor shall furnish, and shall require subcontractors to furnish, at no increase in contract price, all reasonable facilities and assistance for the safe and convenient performance of these duties. Except as otherwise provided in the contract, the Government shall bear the expense of Government inspections or tests made at other than the Contractor's or subcontractor's premises; provided, that in case of rejection, the Government shall not be liable for any reduction in the value of inspection or test samples.

(e)(1) When supplies are not ready at the time specified by the Contractor for inspection or test, the Contracting Officer may charge to the Contractor the additional cost of inspection or test.

(2) The Contracting Officer may also charge the Contractor for any additional cost of inspection or test when prior rejection makes reinspection or retest necessary.

(f) The Government has the right either to reject or to require correction of nonconforming supplies. Supplies are nonconforming when they are defective in material or workmanship or are otherwise not in conformity with contract requirements. The Government may reject nonconforming supplies with or without disposition instructions.

(g) The Contractor shall remove supplies rejected or required to be corrected. However, the Contracting Officer may require or permit correction in place, promptly after notice, by and at the expense of the Contractor. The Contractor shall not tender for acceptance corrected or rejected supplies without disclosing the former rejection or requirement for correction, and, when required, shall disclose the corrective action taken.

(h) If the Contractor fails to promptly remove, replace, or correct rejected supplies that are required to be removed or to be replaced or corrected, the Government may either (1) by contract or otherwise, remove, replace, or correct the supplies and charge the cost to the Contractor or (2) terminate the contract for default. Unless the Contractor corrects or replaces the supplies within the delivery schedule, the Contracting Officer may require their delivery and make an equitable price reduction. Failure to agree to a price reduction shall be a dispute.

(i)(1) If this contract provides for the performance of Government quality assurance at source, and if requested by the Government, the Contractor shall furnish advance notification of the time—

(i) When Contractor inspection or tests will be performed in accordance with the terms and conditions of the contract; and

(ii) When the supplies will be ready for Government inspection.

(2) The Government's request shall specify the period and method of the advance notification and the Government representative to whom it shall be furnished. Requests shall not require more than 2 workdays of advance notification if the Government representative is in residence in the Contractor's plant, nor more than 7 workdays in other instances.

(j) The Government shall accept or reject supplies as promptly as practicable after delivery, unless otherwise provided in the contract. Government failure to inspect and accept or reject the supplies shall not relieve the Contractor from responsibility, nor impose liability on the Government, for nonconforming supplies.

(k) Inspections and tests by the Government do not relieve the Contractor of responsibility for defects or other failures to meet contract requirements discovered before acceptance. Acceptance shall be conclusive, except for latent defects, from, gross mistakes amounting to from, or as otherwise provided in the contract.

(l) If acceptance is not conclusive for any of the reasons in paragraph (k) hereof, the Government, in addition to any other rights and remedies provided by law, or under other provisions of this contract, shall have the right to require the Contractor (1) at no increase in

contract price, to correct or replace the defective or nonconforming supplies at the original point of delivery or at the Contractor's plant at the Contracting Officer's election, and in accordance with a reasonable delivery schedule as may be agreed upon between the Contractor and the Contracting Officer; provided, that the Contracting Officer may require a reduction in contract price if the Contractor fails to meet such delivery schedule, or (2) within a reasonable time after receipt by the Contractor of notice of defects or nonconformance, to repay such portion of the contract as is equitable under the circumstances if the Contracting Officer elects not to require correction or replacement. When supplies are returned to the Contractor, the Contractor shall bear the transportation cost from the original point of delivery to the Contractor's plant and return to the original point when that point is not the Contractor's plant. If the Contractor fails to perform or act as required in paragraph (l)(1) or (l)(2) of this clause and does not cure such failure within a period of 10 days (or such longer period as the Contracting Officer may authorize in writing) after receipt of notice from the Contracting Officer specifying such failure, the Government shall have the right by contract or otherwise to replace or correct such supplies and charge to the Contractor the cost occasioned the Government thereby.

52.232-1 PAYMENTS (APR 1984)

The Government shall pay the Contractor, upon the submission of proper invoices or vouchers, the prices stipulated in this contract for supplies delivered and accepted or services rendered and accepted, less any deductions provided in this contract. Unless otherwise specified in this contract, payment shall be made on partial deliveries accepted by the Government if—

The amount due on the deliveries warrants it; or

The Contractor requests it and the amount due on the deliveries is at least \$1,000 or 50 percent of the total contract price.

(End of Clause)

52.246-16 RESPONSIBILITY FOR SUPPLIES. (APR 1984)

Title to supplies furnished under this contract shall pass to the Government upon formal acceptance, regardless of when or where the Government takes physical possession, unless the contract specifically provides for earlier passage of title.

Unless the contract specifically provides otherwise, risk of loss of or damage to supplies shall remain with the Contractor until, and shall pass to the Government upon—

Delivery of the supplies to a carrier, if transportation is f.o.b. origin; or

Acceptance by the Government or delivery of the supplies to the Government at the destination specified in the contract, whichever is later, if transportation is f.o.b. destination.

Paragraph (b) of this clause shall not apply to supplies that so fail to conform to contract requirements as to give a right of rejection. The risk of loss of or damage to such nonconforming supplies remains with the Contractor until cure or acceptance. After cure or acceptance, paragraph (b) of this clause shall apply.

Under paragraph (b) of this clause, the Contractor shall not be liable for loss of or damage to supplies caused by the negligence of officers, agents, or employees of the Government acting within the scope of their employment.

52.247-34 F.o.b. Destination (NOV 1991)

(a) The term "f.o.b. destination," as used in this clause, means-

(1) Free of expense to the Government, on board the carrier's conveyance, at a specified delivery point where the consignee's facility (plant, warehouse, store, lot, or other location to which shipment can be made) is located; and

(2) Supplies shall be delivered to the destination consignee's wharf (if destination is a port city and supplies are for export), warehouse unloading platform, or receiving dock, at the expense of the Contractor. The Government shall not be liable for any delivery, storage, demurrage, accessorial, or other charges involved before the actual delivery (or "constructive placement" as defined in carrier tariffs) of the supplies to the destination, unless such charges are caused by an act or order of the Government acting in its contractual capacity. If rail carrier is used, supplies shall be delivered to the specified unloading platform of the consignee. If motor carrier (including "piggyback") is used, supplies shall be delivered to truck tailgate at the unloading platform of the consignee, except when the supplies delivered meet the requirements of Item 568 of the National Motor Freight Classification for "heavy or bulky freight." When supplies meeting the requirements of the referenced Item 568 are delivered, unloading (including movement to the tailgate) shall be performed by the consignee, with assistance from the truck driver, if requested. If the contractor uses rail carrier or freight forwarded for less than carload shipments, the contractor shall ensure that the carrier will furnish tailgate delivery, when required, if transfer to truck is required to complete delivery to consignee.

(b) The Contractor shall-

(1) (i) Pack and mark the shipment to comply with contract specifications; or
(ii) In the absence of specifications, prepare the shipment in conformance with carrier requirements;

(2) Prepare and distribute commercial bills of lading;

(3) Deliver the shipment in good order and condition to the point of delivery specified in the contract;

(4) Be responsible for any loss of and/or damage to the goods occurring before receipt of the shipment by the consignee at the delivery point specified in the contract;

(5) Furnish a delivery schedule and designate the mode of delivering carrier; and

(6) Pay and bear all charges to the specified point of delivery.

(End of clause)

552.246-78 Inspection at Destination (JUL 2009)

Inspection of all purchases under this contract will be made at destination by an authorized Government representative.

(End of clause)

The NAICS code(s) and small business size standard(s) for this acquisition appear elsewhere in the solicitation. However, the small business size standard for a concern that submits an offer, other than on a construction or service acquisition, but proposes to furnish an end item that it did not itself manufacture, process, or produce is 500 employees if the acquisition—

(1) Is set aside for small business and has a value above the simplified acquisition threshold;

(c) Period for acceptance of offers. The offeror agrees to hold the prices in its offer firm for 30 calendar days from the date specified for receipt of offers, unless another time period is specified in an addendum to the solicitation.

(d) Product samples. When required by the solicitation, product samples shall be submitted at or prior to the time specified for receipt of offers. Unless otherwise specified in this solicitation, these samples shall be submitted at no expense to the Government, and returned at the sender's request and expense, unless they are destroyed during preaward testing.

(e) Multiple offers. Offerors are encouraged to submit multiple offers presenting alternative terms and conditions, including alternative line items (provided that the alternative line items are consistent with FAR subpart 4.10), or alternative commercial products or commercial services for satisfying the requirements of this solicitation. Each offer submitted will be evaluated separately.

(f) Late submissions, modifications, revisions, and withdrawals of offers. (1) Offerors are responsible for submitting offers, and any modifications, revisions, or withdrawals, so as to reach the Government office designated in the solicitation by the time specified in the solicitation. If no time is specified in the solicitation, the time for receipt is 4:30 p.m., local time, for the designated Government office on the date that offers or revisions are due.

(2) (i) Any offer, modification, revision, or withdrawal of an offer received at the Government office designated in the solicitation after the exact time specified for receipt of offers is "late" and will not be considered unless it is received before award is made, the Contracting Officer determines that accepting the late offer would not unduly delay the acquisition; and-

Oral Presentation – Technical Approach

Oral Presentation Scheduling

The GSA CO will provide the Oral Presentation schedule and location to the point of contact (POC) identified in the Proposal. Offeror's Oral Presentation will be scheduled by the GSA CO after Phase One Evaluations have been completed and only with those offerors who received a "Pass" rating for the "Compliance with Solicitation Minimum Requirements" factor and an "Acceptable" or higher rating for Past Performance and "Satisfactory confidence" or higher rating for Prior Experience.

Oral Presentation/ Participation and Constraints

- The offeror shall identify all authors of the Oral Technical Excellence Presentation by name and association both in the Oral Presentation Slides and at the start of the presentation. Attendance at the presentation and the subsequent oral Q&A session shall be limited to no more than six (6) Offeror Personnel (at least one technical subject matter expert (SME) for application/use of armored vehicle specifications and operation and the project/program manager the offeror would intend to assign to the project if awarded the contract are highly encouraged to attend).

It is the Government's intent to ask clarifying questions only to the extent deemed minimally necessary for the evaluators to sufficiently understand what is being proposed. 52.212-2 Evaluation—Commercial Products and Commercial Services (Nov 2021) Addendum

(a) The Government will award a contract resulting from this solicitation to the responsible offeror whose offer conforming to the solicitation will be most advantageous to the Government, price and other factors considered. The following factors shall be used to evaluate offers:

- Technical Compliance with Solicitation Minimum Requirements
- Prior Experience
- Past Performance
- Technical Approach
- Price

Tradeoff Process:

Non-price factors: All non-price factors are of equal importance. When combined all non-price factors (factors 1 - 4) are significantly more important than Factor 5: Price. As the difference in non-price factors becomes closer, price may become more important. The government will select a Proposal based upon a trade-off determination. Non-price factors will be evaluated first, then price. The Government may award to other than lowest price.

Acceptance of Offer:

A written notice of award or acceptance of an offer, mailed or otherwise furnished to the successful offeror within the time for acceptance specified in the offer, shall result in a binding contract without further action by either party. Before the offer's specified expiration time, the Government may accept an offer (or part of an offer), whether or not there are negotiations after its receipt, unless a written notice of withdrawal is received before award. In the case of an offeror without a record of relevant past performance, for which no past performance questionnaires are received by the Contracting Officer or for whom information on past performance is not available, the offeror may not be evaluated favorably or unfavorably but will receive a rating of "neutral".

Offerors are required to provide Attachment 3 – Past Performance Questionnaire to all the same prior experience references provided for Evaluation Factor #2 – Prior Experience (up to three 3) with a request for them to complete and submit the Past Performance Questionnaire directly to Calvin Blue at calvin.blue@gsa.gov no later than Monday, April 17th, 2023, at 4:00 PM CST. The Past Performance Questionnaire also contains instructions for completion and submission of the questionnaire.

Past Performance (PP) demonstrates relevant performance on how well contractors have managed and complied with contractual requirements in the past. PP evaluation will take into account (a) the currency and relevance of an offeror's PP (within 5 years and for same or similar items); (b) the source of the information; (c) the context of the data; and (d) the quality of an offeror's PP. Instructions for submission of past performance questionnaires (PPQ) are located on the questionnaire (Attachment 3 – Past Performance Questionnaire).

PP Evaluation Standard

It is the Government's intent to review all available past performance reference information to make a determination of the offeror's performance record. During the PP evaluation, the Government will review any past performance questionnaires received from the Offeror's

customers, may review any/all information in the CPARS/PPIRS and may review the following elements:

- Management Controls: Responsiveness, staffing, project management
- Quality of Services/Products: Compliance with contract requirements, technical excellence, and accuracy of reports
- Customer Satisfaction: Reasonable and cooperative behavior and commitment to customer service to include training services, parts & service availability, end user technical support/troubleshooting assistance and overall customer satisfaction.
- Schedule Compliance: Timeliness of delivery/performance compared to the schedule of activities, milestones, and/or deliverables.
- Business Relations: Assess the integration and coordination of all activity needed to execute the contract, specifically the timeliness, completeness and quality of problem identification, corrective action plans, proposal submittals, the contractor's history of reasonable and cooperative behavior (to include timely identification of issues in controversy.
- Cost Control: Assess the contractor's effectiveness in forecasting, managing, and controlling contract cost.

The Government may use one or any combination of the following methods to obtain PP information; Receipt of completed past performance questionnaires; FAPIIS/PPIRS/CPARS systems; any other database; contacting references on PP references received, and/or by any other means permitted by regulatory guidelines in its assessment. A rating of "Acceptable" or "Neutral" must be achieved in order for the offeror to progress to Phase 2 of the evaluation process. A rating of Unacceptable shall render an offeror's proposal as ineligible for further consideration for contract award.

Based on the above criteria each vendor will be assigned a PP adjectival rating Acceptable, Unacceptable or Neutral.

Factor #4: Technical Approach

Factor 4: Technical Approach will not be evaluated until Phase 2 and is contingent upon offerors receiving the minimum ratings described in Phase 1. The Technical Approach considers the extent which the offeror's proposed product solution(s) meets the technical requirements of the RFP and the offeror's technical approach to meeting those requirements are feasible, practical, and appropriate. In support of the evaluation of the Technical Approach factor, each offeror should take into account the following:

1. The Government's General Requirements listed in Section C of the RFP.
2. Technical Approach for meeting the Government's needs.
3. Detailed Project Plan with milestones for how offeror would ensure successful production and delivery for the proposed Level 1 Armored UV(s).
4. Risk Management Methodology.
5. Supply Chain Management.
6. Customer Service Support for end-users.
7. Warranty, to include, but not limited to repairs, preventative maintenance, and availability of replacement parts.

Each offeror will be evaluated on their demonstrated understanding and ability to meet the Government's requirements, the adequacy of the solution/approach, the quality and completeness of their technical project and project plans, and the overall relevance and

comprehensiveness of the offerors proposed product solution(s) and technical approach.

NOTE: An offeror must not simply state that it is willing to provide and/or perform the solicitation requirements. Offerors must demonstrate they are capable of successfully meeting the Government's needs. Simply parroting the Government's requirement and agreeing to provide the required products and support without demonstrating their approach may result in a rating of "Unacceptable". The Technical Approach Factor will be evaluated based on an overall (i.e., taken as a whole) consideration of the following elements (these elements are not sub-factors and will not be individually rated, but will be evaluated as a whole to arrive at the factor-level rating).

Oral Presentation – Technical Approach

- a. A clear and comprehensive understanding of the AFLCMC, Support Equipment & Vehicles mission and the operational and environmental conditions in which the UV's will be operating under.
- b. A comprehensive, effective, and efficient approach/methodology for meeting the Government's requirements in providing new Level 1 Armored UVs, and accomplishing the objectives, conditions, and requirements of the contract.
- c. The degree of effectiveness and comprehensiveness of the offeror's Project Plan methodology for coordinating and collaborating project plan milestones to ensure coordinated delivery of products, build synergies, promote knowledge sharing, and drive efficiencies.
- d. The offeror's methodology and approach to providing comprehensive onsite training upon delivery of the first two UVs.
- e. The degree of relevance, comprehensiveness, and efficiency of the offeror's risk management methodology during contract performance to include the planned actions to mitigate or eliminate risks.
- f. A sound approach to identifying and applying resources to accomplish the requirements in an appropriate and efficient manner.

Technical Approach Evaluation Standard

The standard is met when the offeror has demonstrated understanding of the contract requirements, the adequacy of the solution/approach, the capability of their proposed product solution(s) equipment, the quality and completeness of their technical solutions to meet the Government's needs.

The technical rating reflects the degree to which the proposed product solution(s) and approach meets or does not meet the Government's requirements. Evaluations shall be in accordance with the criteria established in the solicitation.

The offeror's technical solution will be rated in conjunction with the risk associated with its technical approach. Assessment of technical risk, which is manifested by the identification of weakness(es), considers potential for disruption of schedule, increased costs, degradation of performance, the need for increased Government oversight, and/or the likelihood of unsuccessful contract performance. In short, the Technical Approach rating includes consideration of risk in conjunction with the identified strengths, weaknesses, and deficiencies in determining technical ratings.

The following ratings will be given for the Technical Approach Factor: Excellent, Very Good,

Acceptable, Marginal, or Unacceptable.

Factor #5: Price

The Government will consider the offeror's total extended aggregate price for price reasonableness when making the award. In order for GSA to make a fair and reasonable price determination, additional market research may be conducted even if competitive offers are received. The Contracting Officer may also request offerors to submit any available pricing data and/or relevant sales/invoice history in order to further substantiate the price reasonableness of the proposal submitted to the Government. The GSA CO will conduct price analysis not only to determine whether it is fair and reasonable. The Government will also examine pricing outliers to ensure that no offeror is attempting to submit unbalanced pricing. A cost realism analysis will not be conducted.

Price will not be assigned an adjective rating. Non-price factors will be evaluated separately from price. The award will be to the offeror(s) that provides the "best value" to the government.

Offerors shall complete Attachment 6- Pricing Worksheet to submit offered pricing.

Evaluation of Options: IAW FAR 17.206, In awarding the basic contract, the contracting officer shall, evaluate offers for any option quantities or periods contained in a solicitation when it has been determined prior to soliciting offers that the Government is likely to exercise the options. (See 17.208.)

The total aggregate pricing inclusive of the option periods will be evaluated by adding the total price for all options to the total price for the basic requirement prior to contract award.

Price does not have an adjectival rating assigned to it.

SECTION H: PROVISIONS, REPRESENTATIONS & CERTIFICATIONS

Provisions Incorporated by Reference

52.217-5 Evaluation of Options. (July 1990)

Except when it is determined in accordance with FAR 17.206(b) not to be in the Government's best interests, the Government will evaluate offers for award purposes by adding the total price for all options to the total price for the basic requirement. Place of manufacture means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

Predecessor means an entity that is replaced by a successor and includes any predecessors of the predecessor.

Reasonable inquiry has the meaning provided in the clause 52.204-25, Prohibition on Contracting for Certain Telecommunications and Video Surveillance Services or Equipment.

Restricted business operations mean business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174).
