

The 42d Contracting Squadron, Maxwell AFB, AL is seeking sources that can provide Pallet Rack Shelving Units in accordance with the attached Draft Statement of Requirement (SOR) for the Officer Training School at Maxwell AFB. All feedback and information received may be used to determine the appropriate acquisition strategy.

NOTES OF IMPORTANCE:

1. A solicitation does not exist for this requirement. This is only a sources sought synopsis, so please do not submit proposals. The Government does not intend to award a contract on the basis of this sources sought.
2. If the Government decides to pursue a solicitation, portions of your responses to this sources sought may be incorporated into the final solicitation. Respondents are discouraged from submitting any information deemed competition-sensitive or proprietary.
3. Respondents will not be reimbursed for any costs incurred in responding to this sources sought. Information submitted will not be returned to the respective respondents.
4. Oral submissions of information will not be considered in response to this sources sought.

To assist the Government in developing a potential acquisition strategy, please provide the following information:

1. GENERAL INFORMATION:

- a. Company name, address, point of contact, voice and fax telephone numbers and email address.
- b. Type of business, (i.e., small, small disadvantaged, woman-owned, Hub Zone, serviced-disabled veteran-owned small business, large business, etc.), under North American Industry Classification System (NAICS) 337215, which contains a size standard of 500 EMP. CAGE Code and DUNS Number.
- c. Under which NAICS code does your company usually provide the requirements described above. Please provide rationale for your answer if different from NAICS 337215.
- d. Please describe any customary commercial contract terms or conditions that you feel would make any resulting contract more effective if applicable.

2. CAPABILITIES: The Government is seeking qualified, experienced sources interested in providing the requested pallet rack in accordance with the SOR. Please address the following regarding your capabilities in meeting the requirements:

- a. Is your company capable of providing the Pallet Rack Shelving Units in the attached draft SOR? Please respond "Yes or No."
- b. If your response to Question 2.a. above was "Yes", please provide no more than two (2) references for no more than two (2) recent and relevant contracts performed in the last three (3) years. Include name, address, telephone number, and e-mail address for each reference. Also, provide a brief description of the work performed, contract number, total contract value and period of performance. Contracts must be the same or similar to the items.
- c. If your response to Question 2.a. above was "Yes," please provide proof of capability (i.e. Items Listed, Price Estimate, Price Schedule, etc.).
