PERFORMANCE WORK STATEMENTPurpose:

The purpose of the Supply Corps Senior Leadership Symposium (SCSLS) is for all Supply Corps Senior Leadership, including Active Duty and Reserves Flags, O-6s, O-6 (selects), and NAVSUP Senior Executives to convene and discuss the Supply Corps' challenges and opportunities, align with regard to message and vision, and plan the way ahead for the NAVSUP Enterprise and Supply Corps Community. This symposium is intended as a community gathering, for networking and mentorship, so **a self-contained facility that can handle all lodging, food service, and meeting needs is essential** so that all attendees will remain on site for the entire extent of the conference dates.

Dates:

SCSLS will begin on the morning of Wednesday, 01 November 2023 at 0730, and will end on Friday, 03 November 2023 (at 1230 for the larger group, and 1700 for the reservist attendees). Lodging will be available for attendees from 31 October – 03 November 2023. Breakout rooms available from 0800 on 31 October until 1700 03 November 2023.

Estimated number of attendees:

Approximately 250 participants to include military and government civilians are expected to attend the SCSLS event.

Location:

SCSLS will be hosted **in a self-contained facility that can handle all lodging, food service, and meeting needs** by the Chief of Supply Corps within the National Capital Region (NCR). The boundaries of this area are recognized as the District of Columbia; Prince Georges and Montgomery Counties in Maryland; Arlington, Fairfax, Loudoun, and Prince William Counties in Virginia; and all cities and towns included within the outer boundaries of the foregoing counties.

Lodging:

Lodging to accommodate approximately 200 sleeping rooms for out-of-town attendees each night during SCSLS. Attendees will make reservations online or by calling the hotel directly. **The facility is required to provide the government point of contact daily updates of RSVPs to include: Name, Rank or Title, email address and duration of stay per attendee.** Attendees are responsible for all payments for the sleeping room, including no-show fees. Lodging rates must be within the stated federal government per diem rate for the geographic area to include taxes on meals.

- 1) Additional lodging requirements
 - a) Complimentary high speed internet connection
 - b) Smoke free room capability

Training/Conference requirements for SCSLS:

1. Overarching Environment Requirements of Venue:

The **self-contained facility** should feature a pristine physical environment. All furniture and wall fixtures should be presented in the manufactured style, free of rips or tears. All facilities should be fully functional and exceptionally clean.

2. Registration area:

To begin at 7:00 A.M. on Wednesday, 01 November 2023 before the conference. Two (2) tables six (6) feet long with dressing and four (4) chairs set up.

3. Work room:

Near registration area for meeting preparation, storage, to include tables and chairs, available one (1) day prior (31 October 2023) to and throughout the conference. Work room must have telephone and computer hook-ups. Materials may be delivered as early as two (2) days prior to the conference start date.

4. Information/Business center:

Facility to receive incoming messages for conference attendees, provide conference information to attendees, etc. (beginning with advance team arrival one (1) day prior to and throughout the conference), to include a message board, color printer, scanner, data outlets and large working/storage area.

5. Dining Facility:

(Beginning at 1700 on 31 October 2023 through 1300 on 03 November 2023)

A. Dining facility to accommodate breakfast, lunch and dinner for conference attendees staying on-site and to accommodate lunch for up to 250 attendees at one time in an indoor setting and in an hour time frame. Standard mealtimes to support daily conference schedules should be 0600-0800 (Breakfast), 1100-1300 (Lunch), 1700-1900 (Dinner).

However, the dining facility should have the capability to shift meal hours on short notice (1 hour prior to mealtime). In addition, a breakout room close to the main conference area should be set up between 0800-1100 and 1300-1700, for the snack and beverage items that attendees will pay for with their individual registration food fee which must be within the stated federal government per diem rate for the geographic area to include taxes on meals.

6. Conference and Breakout Rooms:

(Beginning at 0700 on 01 November 2023 through 1700 on 03 November 2023)

A. The venue must have the ability to support the following conference requirements: one (1) conference room capable of seating 250 participants on 01-03 November 2023. In addition, we will need five (5) breakout conference rooms to accommodate up to 100 participants simultaneously for community breakout sessions throughout the stay.

1) Conference room requires the following IT requirements:

- a) Standing lectern with wireless microphone
- b) 2 Wireless lavalier microphones
- c) 4 audience microphones
- d) Projector (LCD and overhead)

e) **Screens with Dress Kit sound system screen size must be adequate for the setup of the room for all attendees to see clearly**

f) IT and A/V technician available within 5 minutes from 0800 to 1800 daily

g) Wireless internet capable

h) Four tables at the back of the room with 8 chairs

2) Conference room set-up: The largest conference room must have a raised stage with entry steps on both sides and a podium. Classroom set-up is required with tables and chairs for all attendees.

3) Breakout room set-up: Breakout rooms will be setup in classroom style seating with power receptacles unless otherwise told of a different setup. Breakout rooms will have the following: internet access for a computer, along with LCD projectors and speakers. Breakout rooms must have available seating for all participants.

4) Hospitality room: One (1) executive-level room that comfortably seats 25 senior executives for a private social gathering. The executive-level room should be open for use in the evening hours (after 1800 until 2200). Outside food and beverage should also be permitted in this area. There are no A/V requirements for this space.

5) Social event space: One (1) space that can host 250 conference attendees in the evening hours for a social gathering. The space should be staffed for food and beverage services provided by the venue. The space should be available to our group from 1800 until 2300.

7. Fitness Center:

Venue shall have a 24-hour indoor fitness center to include weight machines, treadmills, lifecycle, basketball court (inside or outside acceptable) from 0530-0730 and 1700-2000.

8. Venue Staff requirements:

The venue shall provide and meet the following requirements:

- A. Assignment of a Convention Service Manager to the training/conference to ensure that all of the meeting and catering arrangements are fulfilled, to provide assistance with group reservations, VIPs and other special requests.
- B. All service staff shall maintain a professional, uniform appearance. Requests by participants shall be handled with urgency. Service staff shall interact with participants in a courteous and respectful manner.
- C. Venue shall have **experience in hosting high level military and civilian officials** or demonstrate a capability of supporting such an event.

9. Parking:

Complimentary conference parking for all attendees.

10. Security:

Flexibility for group to bring in 24-hour onsite security in order of securing the entire venue and surrounding facility grounds. Additionally, an area characterized with a low crime rate and where there has been no indication that DON personnel have been the target of any criminal activity.

11. Transportation:

Shuttle service capability to and from all National Capital Region airports to include Washington Dulles International (IAD), Baltimore-Washington International (BWI), or Ronald Reagan National (DCA) airports.

Ability One

NAVSUP FLCN, Mechanicsburg Detachment may utilize contractor support through the Ability One Program, as needed, to perform contract closeout functions for this acquisition. Information, including business sensitive/confidential or proprietary data, that the offeror provides to the Government or information already in the possession of the Government may be viewed and utilized by the Ability One Program support contractor personnel during the course of its contract performance. The information that may be made available to the support contractor may include, for example, pricing and technical proposals, historical contract, pricing and performance information, Commercial Asset Visibility (CAV) reporting information and similar data/information.

By submission of a proposal in response to this solicitation, the offeror and its subcontractors consent to a release of their business sensitive/confidential or proprietary data to the Government's Ability One Program support contractor personnel in order to perform close out services. Prior to the release of any such information to the support contractor, the support contractor will have in place with the Government a Non-Disclosure/Non-Use Agreement in accordance with the terms of the Ability One Program support contract.

Offerors may execute their own Non-Disclosure Agreement with the Ability One Program (Ability One contact information available from the contracting point of contact). The support contractor must provide copies of the executed agreements to the Contracting Officer and the Contracting Officer's Representative (COR) for the support contract; and the offeror/contractor for this acquisition must provide copies of the executed Agreement to the Contracting Officer for this acquisition. If the offeror/contractor seeks such a Non-Disclosure Agreement with the Ability One Program support contractor, the Agreement must be executed no later than the date of final delivery under the resulting NAVSUP NAVSUP FLCN, Mechanicsburg Detachment contract.

CLAUSES INCORPORATED BY FULL TEXT

52.204-24 REPRESENTATION REGARDING CERTAIN TELECOMMUNICATIONS AND VIDEO SURVEILLANCE SERVICES OR EQUIPMENT (NOV 2021)

The Offeror shall not complete the representation at paragraph (d)(1) of this provision if the Offeror has represented that it "does not provide covered telecommunications equipment or services as a part of its offered products or services to the Government in the performance of any contract, subcontract, or other contractual instrument" in paragraph (c)(1) in the provision at 52.204-26, Covered Telecommunications Equipment or Services--Representation, or in paragraph (v)(2)(i) of the provision at 52.212-3, Offeror Representations and Certifications--Commercial Products and Commercial Services. The Offeror shall not complete the representation in paragraph (d)(2) of this provision if the Offeror has represented that it "does not use covered telecommunications equipment or

services, or any equipment, system, or service that uses covered telecommunications equipment or services" in paragraph (c)(2) of the provision at 52.204-26, or in paragraph (v)(2)(ii) of the provision at 52.212-3.

(a) Definitions. As used in this provision-

Backhaul, covered telecommunications equipment or services, critical technology, interconnection arrangements, reasonable inquiry, roaming, and substantial or essential component have the meanings provided in the clause 52.204-25, Prohibition on Contracting for Certain Telecommunications and Video Surveillance Services or Equipment.

(b) Prohibition.

(1) Section 889(a)(1)(A) of the John S. McCain National Defense Authorization Act for Fiscal Year 2019 (Pub. L. 115-232) prohibits the head of an executive agency on or after August 13, 2019, from procuring or obtaining, or extending or renewing a contract to procure or obtain, any equipment, system, or service that uses covered telecommunications equipment or services as a substantial or essential component of any system, or as critical technology as part of any system. Nothing in the prohibition shall be construed to--

(i) Prohibit the head of an executive agency from procuring with an entity to provide a service that connects to the facilities of a third-party, such as backhaul, roaming, or interconnection arrangements; or

(ii) Cover telecommunications equipment that cannot route or redirect user data traffic or cannot permit visibility into any user data or packets that such equipment transmits or otherwise handles.

(2) Section 889(a)(1)(B) of the John S. McCain National Defense Authorization Act for Fiscal Year 2019 (Pub. L. 115-232) prohibits the head of an executive agency on or after August 13, 2020, from entering into a contract or extending or renewing a contract with an entity that uses any equipment, system, or service that uses covered telecommunications equipment or services as a substantial or essential component of any system, or as critical technology as part of any system. This prohibition applies to the use of covered telecommunications equipment or services, regardless of whether that use is in performance of work under a Federal contract. Nothing in the prohibition shall be construed to--

(i) Prohibit the head of an executive agency from procuring with an entity to provide a service that connects to the facilities of a third-party, such as backhaul, roaming, or interconnection arrangements; or

(ii) Cover telecommunications equipment that cannot route or redirect user data traffic or cannot permit visibility into any user data or packets that such equipment transmits or otherwise handles.

(c) Procedures. The Offeror shall review the list of excluded parties in the System for Award Management (SAM) (<https://www.sam.gov>) for entities excluded from receiving federal awards for "covered telecommunications equipment or services."

(d) Representations. The Offeror represents that--

(1) It [____] will, [____] will not provide covered telecommunications equipment or services to the Government in the performance of any contract, subcontract or other contractual instrument resulting from this solicitation. The Offeror shall provide the additional disclosure information required at paragraph (e)(1) of this section if the Offeror responds "will" in paragraph (d)(1) of this section; and

(2) After conducting a reasonable inquiry, for purposes of this representation, the Offeror represents that--

It [____] does, [____] does not use covered telecommunications equipment or services, or use any equipment, system, or service that uses covered telecommunications equipment or services. The Offeror shall provide the additional disclosure information required at paragraph (e)(2) of this section if the Offeror responds "does" in paragraph (d)(2) of this section.

(e) Disclosures.

(1) Disclosure for the representation in paragraph (d)(1) of this provision. If the Offeror has responded "will" in the representation in paragraph (d)(1) of this provision, the Offeror shall provide the following information as part of the offer:

(i) For covered equipment--

(A) The entity that produced the covered telecommunications equipment (include entity name, unique entity identifier, CAGE code, and whether the entity was the original equipment manufacturer (OEM) or a distributor, if known);

(B) A description of all covered telecommunications equipment offered (include brand; model number, such as OEM number, manufacturer part number, or wholesaler number; and item description, as applicable); and

(C) Explanation of the proposed use of covered telecommunications equipment and any factors relevant to determining if such use would be permissible under the prohibition in paragraph (b)(1) of this provision.

(ii) For covered services--

(A) If the service is related to item maintenance: A description of all covered telecommunications services offered (include on the item being maintained: Brand; model number, such as OEM number, manufacturer part number, or wholesaler number; and item description, as applicable); or

(B) If not associated with maintenance, the Product Service Code (PSC) of the service being provided; and explanation of the proposed use of covered telecommunications services and any factors relevant to determining if such use would be permissible under the prohibition in paragraph (b)(1) of this provision.

(2) Disclosure for the representation in paragraph (d)(2) of this provision. If the Offeror has responded "does" in the representation in paragraph (d)(2) of this provision, the Offeror shall provide the following information as part of the offer:

(i) For covered equipment--

(B) If not associated with maintenance, the PSC of the service being provided; and explanation of the proposed use of covered telecommunications services and any factors relevant to determining if such use would be permissible under the prohibition in paragraph (b)(2) of this provision.

252.204-7017 PROHIBITION ON THE ACQUISITION OF COVERED DEFENSE TELECOMMUNICATIONS EQUIPMENT OR SERVICES--REPRESENTATION (MAY 2021)

The Offeror is not required to complete the representation in this provision if the Offeror has represented in the provision at 252.204-7016, Covered Defense Telecommunications Equipment or Services--Representation, that it “does not provide covered defense telecommunications equipment or services as a part of its offered products or services to the Government in the performance of any contract, subcontract, or other contractual instrument.”

(a) Definitions. (d) Representation. If in its annual representations and certifications in SAM the Offeror has represented in paragraph (c) of the provision at 252.204-7016, Covered Defense Telecommunications Equipment or Services--Representation, that it “does” provide covered defense telecommunications equipment or services as a part of its offered products or services to the Government in the performance of any contract, subcontract, or other contractual instrument, then the Offeror shall complete the following additional representation:

(e) Disclosures. If the Offeror has represented in paragraph (d) of this provision that it “will provide covered defense telecommunications equipment or services,” the Offeror shall provide the following information as part of the offer:

(1) A description of all covered defense telecommunications equipment and services offered (include brand or manufacturer; product, such as model number, original equipment manufacturer (OEM) number, manufacturer part number, or wholesaler number; and item description, as applicable).

(2) An explanation of the proposed use of covered defense telecommunications equipment and services and any factors relevant to determining if such use would be permissible under the prohibition referenced in paragraph (b) of this provision.

(3) For services, the entity providing the covered defense telecommunications services (include entity name, unique entity identifier, and Commercial and Government Entity (CAGE) code, if known).

(4) For equipment, the entity that produced or provided the covered defense telecommunications equipment (include entity name, unique entity identifier, CAGE code, and whether the entity was the OEM or a distributor, if known).

252.232-7006 WIDE AREA WORKFLOW PAYMENT INSTRUCTIONS (DEC 2018)

(a) Definitions. As used in this clause—

“Department of Defense Activity Address Code (DoDAAC)” is a six position code that uniquely identifies a unit, activity, or organization.

“Document type” means the type of payment request or receiving report available for creation in Wide Area WorkFlow (WAWF).

“Local processing office (LPO)” is the office responsible for payment certification when payment certification is done external to the entitlement system.

“Payment request” and “receiving report” are defined in the clause at 252.232-7003, Electronic Submission of Payment Requests and Receiving Reports.

(i) For cost-type line items, including labor-hour or time-and-materials, submit a cost voucher.

(ii) For fixed price line items—

(A) That require shipment of a deliverable, submit the invoice and receiving report specified by the Contracting Officer.

Combo

(B) For services that do not require shipment of a deliverable, submit either the Invoice 2in1, which meets the requirements for the invoice and receiving report, or the applicable invoice and receiving report, as specified by the Contracting Officer.

(Contracting Officer: Insert either “Invoice 2in1” or the applicable invoice and receiving report document type(s) for fixed price line items for services.)

(iii) For customary progress payments based on costs incurred, submit a progress payment request.

(iv) For performance based payments, submit a performance based payment request.

(v) For commercial item financing, submit a commercial item financing request.

(2) Fast Pay requests are only permitted when Federal Acquisition Regulation (FAR) 52.213-1 is included in the contract.
