RESPONSES TO QUESTIONS

1. **Question:** Evaluation Factor 4: Past Performance; Page 121; Section L.7.4.b) The first six pages of Volume I, Evaluation Factor 4, shall be for submission of a maximum of three Past Performance Information Sheets (PPIS), located in Section J, Attachment II: Past Performance Information Sheet. Each PPIS reference consists of two pages, Part I and Part II. If more than three past performance references are provided, only the first three references will be considered. If a PPIS, Part I or Part II, contains more than one page per Part, only the first page of the specific Part of the PPIS reference will be considered. In an effort to provide details to substantiate relevancy, would the government consider increasing the page count for Part 1 and Part 2 of Past Performance?

Response: No, the Government will not consider increasing the page limit; however, the solicitation does not preclude removal of excess white space between the numbered items so long as margin parameters remain in compliance with the solicitation.

2. **Question:** L.6 Proposal Preparation; Page 119, Section L.6.2 Type for graphics, tables and reproductions shall be no smaller than a font size of 10 with a minimum of 1" margins. Would the government please confirm that the size 10 font applies to call-out boxes and figures?

Response: The Government confirms that size 10 font applies to call-out boxes and figures.
