Section B: Description of the Supplies/Services Required

MOC Office require three radio systems screens & three microphones set up in Bldg. 164, Rm 110. Two will be for the Junior Controller's station and one will be at the Senior Controller station. MOC will need contractors support for training controllers on how to operate the systems and functions properly. Each system should be operationally checked upon install to ensure proper functionality.

Section C: Justification for Soliciting from a Single Source or Brand Name

Motorola is the sole LMR/Base Radio provider/contract with CAFB. Will be using existing Rack and Network Equipment utilizing GFE network connectivity from Command Post at Bldg. 790.

The Motorola MCC 7500 dispatch console is connected to the Global Strike Command (GSC)/Space Force Enterprise Land Mobile Radio (ELMR) network via a secure and proprietary protocol that can only be provided by Motorola. The GSC/Space ELMR system is a closed system that maintains a cyber security accreditation. Only the Motorola MCC 7500 dispatch console is certified for use within the GSC/Space ELMR system to maintain the cyber security accreditations for the system. Any other manufacturer's system would negatively impact the cyber security accreditation of the system, and could potentially cause GSC/Space ELMR system failures, which would negatively impact operations and life safety.

Section D: Efforts to Obtain Competition

At this time, Motorola, or an approved/qualified Motorola vendor, is the only suitable source capable of providing this equipment. Multiple Motorola licensed distributors were contacted during the Market Research portion of this requirement. These small businesses will be submitting quotes in response to our solicitation, enabling us to promote competition to the fullest extent possible while still fulfilling this requirement.

Unless USAF as a whole refreshes their entire ELMR system Brand Name Motorola products will continue to provide the seamless integration and interoperability required for day-to-day operations.
