- B. TUG/BARGE UNIT MUST HAVE A CONTAINER HANDLING FORKLIFT WITH MINIMUM LIFTING CAPACITY OF 40,000 LBS FOR POSITIONING CONTAINERS ONBOARD VESSEL DURING LOADING AND DISCHARGE OPERATIONS. FORKLIFT MUST BE APPROVED FOR USE BY THE USCG COTP PRIOR TO ARRIVAL AT LOAD PORT 1.
