3. Description of Services or Supplies: Mosquito Creek Lake is in need of a Supply procurement for the acquisition of a remote-controlled aquatic vegetation harvester (WaterGator) and Eco-Harvester.

A) The remote-controlled aquatic vegetation harvester must have an operational range of at least 1,000 feet from shore, an 8-hour operational life or greater, be battery powered, and remove vegetation via cutting. Further, the cutting action must be auto leveling to ensure no damage to the lake bottom. The harvester must have a minimum operational

depth of 4 inches, and a storage capacity of at least 1,250 pounds. The harvester must have the ability to address various species of concern with special emphasis on the American Lotus. This acquisition includes the purchase of a DOT compliant trailer required to transport the harvester.

B) The riding aquatic vegetation harvester. This harvester must be capable of clearing 1.5 acres per hour, removes the vegetation via pulling, and is capable of skimming the surface of the water for algae and floating debris. Further, the harvester must have the ability to address various species of concern including Eurasian Milfoil, various algae species such as Starry Stonewort. Further, the harvester must have a minimum operational depth of 4 feet. This acquisition includes the purchase of a DOT compliant trailer required to transport the harvester.

5. Reasons for Authority Cited:

(a) Market research for the remote-control harvester was done in searching for vendors that could provide the required item. A total of only one (1) vendor was found. Only one (1) can meet the customers requirement.

Sources sought notice# W911WN23SS0007 was posted to SAM on 23 March 2023. This was to conduct an survey the market of other potential vendors they may be able to provide this item. The closing date of the notice was 06 April 2023. It was posted on SAM for 14 days to conduct a industry survey. No responses were received

Lake Weeder Digest is the vendor able to supply the Water Gator for this contract activity. The CS contracted the vendor by phone to confirm its patented only has one

supplier. Searches in SPS and PCF found no prior history for the purchase of the Water Gator.


(b) Research Market research for riding aquatic harvester conducted, in searching for vendors that could provide the required item. A total of three (3) vendors were found. Only one (1) can meet the customers requirement.

Sources sought notice# W911WN23SS0004 was posted to SAM on 23 March 2023. The closing date of the notice was 06 April 2023. It was posted on SAM for 14 days to conduct an industry survey. Only one (1) vendor responded to the notice. Aquarius Systems. Aquarius Systems does not meet the required specifications that was listed in the notice. The item that they could provide would cut the vegetation. The item that is required must pull the vegetation.

Eco Harvester is the only item can pull vegetation and meet the requirement. This item can only be supplied by Lake Weeders Digest. The Eco Harvester ability to pull the vegetation is patient and can only be supplied by Weeders Digest. This information was confirmed through the supplier when contacted by the CS. Confirmation is filed into PCF. Searches in SPS and PCF found no prior history for the purchase of the Eco Harvester.




