

(i) This is a combined synopsis/solicitation for commercial items prepared in accordance with the format in Federal Acquisition Regulation (FAR) Subpart 12.6, as supplemented with additional information included in this notice. This announcement constitutes the only solicitation; proposals are being requested and a written solicitation will not be issued. The Government intends to award a Firm-Fixed priced task contract to the responsible Offeror whose proposal conforms to this synopsis/solicitation.

(ii) The Request for Quote (RFQ) or Reference Number is 70VT1523Q00011.

(iii) This RFQ and incorporated provisions and clauses are those in effect through Federal Acquisition Circular (FAC) 2020-05.

(iv) This acquisition is not a small business set aside. The associated North American Industry Classification System (NAICS) code for this acquisition is 812930 – Parking Lots and Garages.

(vi) The Contract shall provide for Parking Spaces for The Department of Homeland Security-Office of Inspector General (DHS-OIG), located at or within a 1-block radius of 395 E. Street SW, Washington, DC 20024.

(viii) The provision at Federal Acquisition Regulation (FAR) 52.212-1, Instructions to Offerors-Commercial Items, shall apply to this acquisition. Offerors' submissions shall meet the following specifications:

- Must have 24 hour, seven days a week access
- Secured facility with in and out privileges and self-parking
- Contractors/Attendants will not leave the vehicles unsecured and will not have or require access to vehicle keys
- Lot must be an enclosed (covered) facility
- Parking spaces must be located at, or within a 1-block radius of 395 E. Street S.W., Washington, DC 20024.
