<b>16. REMARKS</b>  Block 4: EDFP shall be marked in accordance with the Statement of Work (SOW). Only one side of the paper shall be used. Each EDFP shall be submitted as a separate file using Adobe Acrobat PDF.  Block 10/12: The initial submission of the EDFP (A009) is due concurrent with the initial submission of Technical Manual (TM) (A006) and initial submission of Provisioning Parts List (PPL) (A008).  Block 10/13: The final submission of the EDFP is due fifteen (15) calendar days after completion of the government Provisioning Conference, concurrent with the final submission of the PPL (A008).  The government shall determine acceptance or rejection of each submission and notify contractor within thirty (30) calendar days of receipt of each submission. If the initial EDFP is rejected, an In-Process Review (IPR) shall be conducted no more than seven (7) calendar days after receipt of rejection by the contractor to discuss those issues. The contractor shall then have fifteen (15) calendar days from the rejection IPR to make necessary corrections/changes and return to the government for subsequent review.  All EDFP shall be submitted as a stand-alone Adobe Acrobat PDF for each Provisioning Line Item Sequence Number (PLISN) that is either "XD" or "P" coded. Items shall not be coded "XB" or any other Source Code unless specifically approved by the government. EDFP for items that have a National Stock Number (NSN) are not required. If multiple PLISNs have the same Cage/Part Number, the first PLISN where the item is used shall be used for EDFP submission. If the EDFP for a particular PLISN has more than one page detailing technical data, then all pages shall be marked IAW the SOW.  All EDFPs submitted must be from the manufacturer/Original Equipment Manufacturer who hold design rights to a particular item. Drawings from non-manufacturers, distributors, cut-sheets, integrators will not be accepted. Per Defense Logistics Agency (DLA) all NSN requests must be accompanied by drawings.  All deliveries must be submitted electronically without restrictions that would prevent the government from reproducing or editing the information. a. Group I. Definition - Data which is not otherwise essential to the contractor's performance of the primary contracted effort (production, development, testing, and administration) but which is required by DD Form 1423.

Estimated Price - Costs to be included under Group I are those applicable to preparing and assembling the data item in conformance with Government requirements, and the administration and other expenses related to reproducing and delivering such data items to the Government.

b. Group II. Definition - Data which is essential to the performance of the primary contracted effort but the contractor is required to perform additional work to conform to Government requirements with regard to depth of content, format, frequency of submittal, preparation, control, or quality of the data item.

Estimated Price - Costs to be included under Group II are those incurred over and above the cost of the essential data item without conforming to Government requirements, and the administrative and other expenses related to reproducing and delivering such data item to the Government.

c. Group III. Definition - Data which the contractor must develop for his internal use in performance of the primary contracted effort and does not require any substantial change to conform to Government requirements with regard to depth of content, format, frequency of submittal, preparation, control, and quality of the data item.

Estimated Price - Costs to be included under Group III are the administrative and other expenses related to reproducing and delivering such data item to the Government.

d. Group IV. Definition - Data which is developed by the contractor as part of his normal operating procedures and his effort in supplying these data to the Government is minimal.

Estimated Price - Group IV items should normally be shown on the DD Form 1423 at no cost.

**Item 18.** For each data item, enter an amount equal to that portion of the total price which is estimated to be attributable to the production or development for the Government of that item of data. These estimated data prices shall be developed only from those costs which will be incurred as a direct result of the requirement to supply the data, over and above those costs which would otherwise be incurred in performance of the contract if no data were required. The estimated data prices shall not include any amount for rights in data. The Government's right to use the data shall be governed by the pertinent provisions of the contract.
