

COMBINED SYNOPSIS/SOLICITATION

(rev 4/7/2023)

(i) This is a combined synopsis/solicitation for commercial items prepared in accordance with the format in [Subpart 12.6](#), as supplemented with additional information included in this notice. This announcement constitutes the only solicitation; quotes are being requested and a written solicitation will not be issued.

(ii) The Request for Quotation (RFQ) number **FA445223Q0008** shall be used to reference any written quote provided under this RFQ.

(iii) The RFQ document and incorporated provisions and clauses are those in effect through Federal Acquisition Circular 2023-02; Effective 3-16-2023.

(iv) This is a 100% set-aside for **Small Business (SB)**. The North American Industry Classification System (NAICS) code for this project is 238330 with a size standard of \$16.5M.

(v) The purpose of this combined synopsis and solicitation is for the procurement of carpet removal and replacement services as described in the Statement of Work (SOW). The magnitude of the requirement in terms of the estimated price range is between \$100K and \$250K. The bid schedule and contract CLIN schedule are below:

(vi) Description of the requirement: The description of the requirement is provided in the attached SOW. Period of performance will be 45-days from contract award.

All companies must be registered in the System for Award Management at <https://www.sam.gov/SAM/pages/public/index.jsf> to be considered for award. The Government will not provide contract financing for this acquisition. Invoice instruction shall be provided at time of award.

Paragraph (c) first sentence revised as follows:

The vendor agrees to hold the prices in its quote firm for **60** calendar days from the date specified for receipt of quotes unless another time period is specified in an addendum to the solicitation.

Paragraph (e) is deleted in its entirety.

(ix) Pursuant to FAR 12.602, contract award will be made using Simplified Acquisition Procedures in accordance with FAR 13.106. Vendor's submissions will be evaluated based upon the following:

(1) Price

(2) Relevant Experience – the Vendor's relevant experience submission will be evaluated and given a confidence rating as defined below.

Basis for Award

1. Price will be evaluated to determine if it is fair and reasonable in accordance with FAR 13.106-3.
2. The Relevant Experience submission will be evaluated and assigned one of three available Confidence Ratings:

High Confidence	The Government has high confidence based on the Vendor's relevant experience that they will be successful in performing contract requirements with little or no Government intervention.
Some Confidence	The Government has some confidence based on the Vendor's relevant experience that they will be successful in performing contract requirements with some Government intervention.
Low Confidence	The Government has low confidence based on the Vendor's relevant experience that they will be successful in performing contract requirements even with Government intervention.

Award will be made on a best value determination, considering price and relevant experience ratings.
