 - a. **Question:** In reference to the drawing series 3329AS100 the information regarding the foam inserts has changed from Cross linked Polyethylene Foam, Black plastazote LD45, Color Black Suggested source of supply: UFP Technologies to Cross Linked Polyethylene foam IAW A-A-59136, Class IV, Grade D, Type II, Color: Black, No reference to a suggested source. A-A-59136 commercial item description does not include the color black. Grade D in A-A-59136 is blue-grey in color provide guidance.
Response: In accordance with (IAW) Note 1 and Revision B notes found on drawing 3329AS1000, the foam inserts are to be IAW A-A-59136, Class IV, Grade D, Type III, Color: Black, the color is “unless otherwise specified by the procuring activity” and is an all-encompassing change throughout the entirety of the Combo 9 Technical Data Package where all references to Black Plastazote LD45 occur and are to be considered replaced by this specification. The cross linked polyethylene foam IAW A-A-59136, Class IV, Grade D, Type III, Color: Black, is the functional equivalent to of the original Plastazote LD45. This can be referenced in A-A-59136, Paragraph 2.1 on pages 1 and 2:
Class 4- Special purpose (skived) sheets, planks, and shapes as specified by the Procuring Activity;
Grade D- Static dissipative and Fire retardant (see 3.5);
Type III- 21 Kg Constant Compression Creep, See 3.10.
2. All other terms and conditions remain in effect.
