1. Defense Logistics Agency (DLA) Troop Support, Subsistence Supply Chain, is the contracting activity.
2. The action being approved is the ability to solicit for DLA requirements on an other than full and open competition basis.
3. The proposed acquisition will be an Indefinite-Delivery, Indefinite-Quantity (IDIQ), fixed price with Economic Price Adjustment (EPA) bridge contract for Prime Vendor support for a period of 393 days. This time period will afford sufficient time to award a competitive follow-on contract and provide coverage during the up to one-hundred twenty (120) day ramp-up period for the awardee of the follow-on competitive procurement. This ramp-up period includes the time necessary for the awardee of the follow-on competitive procurement to reach full operational capability [REDACTED]

The proposed bridge contract SPE300-23-D-3351 encompasses Subsistence Prime Vendor (SPV) support for all authorized DLA customers located in the Northern New England area including Maine, New Hampshire, and Vermont for a full-line of food and beverage items.

[REDACTED] The guaranteed minimum dollar value is [REDACTED] \$200,000.00. The maximum total dollar value, [REDACTED] is \$3,000,000.00. The proposed action will result in the award of a bridge contract with Sysco Northern New England effective November 19, 2022 through December 16, 2023. The current Indefinite- Delivery Indefinite-Quantity long term contract, SPE300-18-D-3201 for the Northern New England area was awarded on August 19, 2018 and will expire on November 18, 2022.

4. The applicable statutory authority permitting other than full and open competition is 10 U.S.C. 3204(a)(1), as implemented by FAR Part 6.302-1 – Only One Responsible Source and No Other Supplies or Services Will Satisfy Agency Requirements.
5. The solicitation for the follow-on competitive acquisition was issued May 21, 2021 with an initial closing date of June 28, 2021 which was amended to July 30, 2021. [REDACTED]

Sysco Northern New England is able to meet DLA requirements starting on November 19, 2022. [REDACTED]

[REDACTED] Award to any other potential food supplier would cause an unacceptable break in supply.

Failure to make award to Sysco Northern New England will result in a break in Prime Vendor support. The military customers rely on the DLA Prime Vendor contract for all of their foodservice needs. [REDACTED]

[REDACTED] Should a competitively awarded contract be put into place ahead of the projected timeframe and the guaranteed minimum has been met under this bridge contract, no further orders will be placed against the bridge contract.

In addition, this justification will be made available for public inspection, after award, in accordance with FAR 6.305.

8. [REDACTED] With the exception of synthesizing this requirement, no additional market research will be conducted, and no other firms will be solicited since the Government is unaware of any other firm in the region with the existing capability, [REDACTED] to perform in the timeframe required.
