Section B

3. Page 2, Section B.1.1 Definitions. The following definitions here hereby amended:
 - “Annual production amount” means the annual production amount shown in Table 5—Electricity Production. The annual production amount for a year shall include energy that the Contractor can demonstrate could have been produced and delivered but for excusable delays or reduction caused by the Government in the minimum required Government demand.
4. Page 9, Section B.1.2 Acronyms is hereby amended to the following:
 - “Mlbs.” Means mass per pounds.

Section C

5. Page 17, Section C.3.3.1 Minimum Production is hereby amended to the following:
 - Minimum Production. The Contractor shall operate and maintain the EPF whereby the system performance shall result in production of no less than the minimum annual production amount per year, as indicated in Table 5—Electricity Production, provided that the Contractor agrees to maximize its production to the greatest extent possible consistent with applicable laws and the requirements of the contract.
6. Page 25, Section C.16.7 Billing Meter is hereby amended to the following:
 - The Contractor’s billing meter shall be on the high voltage side of the EPF step-up transformer for electricity, and at the point of interconnection for steam.
7. Page 37, Section C.36.7 Access to Government Buildings is hereby amended to the following:
 - It shall be the Contractor’s responsibility to obtain access, through the Contracting Officer Representative, to Government buildings on the premises.

Section I

8. Page 79, Section I.1.4 (3) DFARS CLAUSES INCORPORATED BY REFERENCE, is hereby amended to delete the following clauses:
 - DFARS 252.225-7017, Photovoltaic Devices (DEC 2018)
 - DFARS 252.225-7018, Photovoltaic Devices – Certificate (DEC 2018)

If this is a first-time joint venture, each party to the arrangement shall provide a list of project(s) summaries as identified in paragraph L.7.2.2 below.

11. Page 83, Section L.4.2.3 Proposed Organizational/Limits is hereby amended to increase the maximum page limit for Volume II Past Performance to 15 pages.
12. Page 84, Section L.4.2.4 Pages and Typing is hereby amended to exclude CAD drawings and exceptions in the maximum page limit as follows:
 - Each page shall be counted except for the following: cover pages, table of contents, cross-reference matrix, tabs, glossaries, CAD drawings and exceptions.
13. Page 88, Section L.7.1.2 is hereby amended to the following language:
 - L.7.1.2 For required CLIN 0001 and CLIN 0002, the technical capability requirements include the Production, Implementation Plan, and a Conceptual Design. The risk evaluation shall be addressed in the Mitigation Plan.

Section M

14. Page 96, Section M.1.4.1 – Factor 1 – Technical Capability, is hereby by amended to the following language:
 - Evaluation of Technical Capability will include review and assessment of an Offeror's production capability, Implementation Plan and Conceptual Design including the feasibility of the proposed solution in meeting the Government's requirements.
