PART I - SUPPLIES OR SERVICES AND PRICES/COSTS

1.0 GENERAL

The Contractor shall provide all management, personnel, materials, labor, equipment and facilities, and shall do all that is necessary to satisfy the requirement described in Part II: Statement of Work (SOW). The NAICS Code for this requirement is 326199 – All Other Plastic Products Manufacturing with a size standard of 750 employees. This is a total small business set-aside.

The Government intends to award a firm fixed price single purchase order with a drawdown of Not To Exceed (NTE) Quantity over the life of the contract.

1.1 CONTRACT LINE ITEM NUMBERS (CLINs)

The Quoter shall provide firm-fixed unit pricing in accordance with the Contract Line Item Number (CLIN) structure identified in the Standard Form 1449 Sections 19 and 20.

PART II – STATEMENT OF WORK

2.0 SCOPE OF WORK

Description:

The Office of Security (OS), as part of the Office of the Comptroller (OCC) Credential Update Project, is offering employees, who placed a request, the opportunity to have their old OCC badges placed in a Lucite memento.

Requirement:

OS is seeking a company to provide services that would take a badge and cast it in a Lucite encasing for the OCC to provide as a memento to employees.

Deliverables:

- Must be able to receive bulk shipment of OCC badges
- Receive on a quarterly basis a list of employee names to be displayed onto the gold¹ plate of the Lucite memento
- Engrave employee and organization name onto gold plate,
- Encase the badge and gold plate in Lucite
- Lucite memento shall have a blue background
- Produce the Lucite memento
- Ship Lucite mementos to OCC/OS for later distribution
- Must complete process within 45 days after receipt of the list of employee names

Gold Plate Requirements and Description:

- Gold plate shall be between the size of 1"x2" – 2"x3"
- Font shall be 12 – 14 in Times New Roman or equivalent
- Format below:

Employee Name
Office of the Comptroller of the Currency

- Gold plate shall be placed on the front of Lucite memento under the badge

Lucite Encasing Measurements and Description:

- Shall be no smaller 5" tall x 3.5" wide and no larger than 6" tall x 4" wide
- Stand on its own
- Employee's name and Comptroller of the Currency will be on the front of Lucite memento displayed on a gold plate.
- Embedment of OCC badge on a blue background for Lucite memento

Quantity of Requirement:

- Estimated quantity: 3,000 with drawdown of estimated quantity per year.

¹ The gold plate shall be gold in color and not 10k, 14k, 18k, 24k gold

2.1 PERIOD OF PERFORMANCE

The period of performance is from 09/30/2023 through 09/29/2024.

2.2 GOVERNMENT INSPECTION AND ACCEPTANCE PERIOD

The Government will have 10 days to conduct inspection and acceptance of shipped products. The Government may require repair or replacement of nonconforming supplies at no increase in contract price to include shipping. If repair/replacement will not correct the defects or is not possible, the Government may seek an equitable price reduction or adequate consideration for acceptance of nonconforming supplies. Replacements require expedited shipment within a 15 day period.

- (10) PSC 9630, Additive Metal Materials.

Place of manufacture means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

Predecessor means an entity that is replaced by a successor and includes any predecessors of the predecessor.

Reasonable inquiry has the meaning provided in the clause [52.204-25](#), Prohibition on Contracting for Certain Telecommunications and Video Surveillance Services or Equipment.

The Quote shall conform to these instructions and be prepared in accordance with this section. To aid in the evaluation, the quote shall be clearly and concisely written as well as neat, indexed (cross-indexed as appropriate), and logically assembled.

The Quoter shall ensure that the following items and information are submitted with its quote:

- Propose firm-fixed price for items listed on Standard Form 1449, Sections 19 and 20.
- Provide a sample picture of the Quoter's proposed Lucite memento.
- Complete FAR Provision 52.204-24
- Complete FAR Provision 52.209-11
- Complete FAR Provision 52.222-22
- Complete FAR 52.212-3; **NOTE:** Offerors shall complete only paragraph (b) of the provision if the Offeror has completed the annual representations and certification electronically in the System for Award Management (SAM) accessed through <https://www.sam.gov>. If the Offeror has not completed the annual representations and certifications electronically, the Offeror shall complete only paragraphs (c) through (u) of this provision.
- Past Performance – The Quoter's past performance shall be assessed. Quoter shall describe its experience on at least three contracts directly related to or currently in progress or held by the Quoter within the last three years. The contracts shall be similar in scope, size, and complexity to the requirements in the SOW. The Quoter must have been the prime contractor for the reference. Past performance contract references shall include at a minimum: contractor

name, type of contract and dollar value, and general description of the project including aspects relevant to this effort.

Provide at least one reference for each past performance project:

For each reference, the Quoter shall also submit the Past Performance Questionnaire (Attachment 1). The completed forms shall be emailed directly by the reference to Karen.green@occ.treas.gov. The forms are due by the specified deadline for submitting quotes in response to this RFQ. The OCC reserves the right to contact other entities not specifically identified by the Quoter in its quote or other resources (published articles) and past performance databases to obtain past performance information.

The OCC reserves the right to award without discussions.

4.5 Quote Preparation Costs

This RFQ does not commit the Government to pay any cost for the preparation and submission of the quote in response to this RFQ. The CO is the only individual who can legally commit the Government to the expenditure of public funds in connection with this procurement.

4.6 Integrity of Quote

In responding to this RFQ, it is the offeror's responsibility to provide current, complete and accurate information in its quotation. If in reviewing the quote the Government identifies or otherwise learns that the provided quotation information is not accurate or misrepresents the offeror's status or capabilities, that information may be used by the CO as part of the offeror's responsibility determination and could result in the offeror not being eligible for award.

4.7 Contractor Registration

Before award is made, the offeror must be registered in the System for Award Management (SAM). If the offeror does not become registered in the SAM database before time of award, the Contracting Officer will proceed to award to the next otherwise successful registered offeror. Offerors may obtain information on registration at <https://www.acquisition.gov>.

4.8 Alternate Quotes

Alternate quotes will not be considered.

PART V - EVALUATION OF QUOTATIONS

5.1. 52.212-2 EVALUATION – COMMERCIAL PRODUCTS AND COMMERCIAL SERVICES (NOV 2021)

The Government will award a contract resulting from this solicitation to the Lowest Price Technically Acceptable Quoter. The following factors shall be used to evaluate offers in descending order of importance:

(1) Price – The price will be evaluated to determine whether it is the lowest evaluated price. The total evaluated price will be the sum of the base and one option period. For evaluation purposes, FAR 52.217-8 will be evaluated by dividing the price of Option Year 1 in half. Price is not a scored evaluation factor.

(2) Past Performance - Evaluation of past performance will be a subjective assessment based on OCC's experience, if any, with the Quoter; the experience of references submitted by the Quoter; and a consideration of other relevant facts and circumstances that are obtained by OCC from any source. Past performance will be evaluated on a Pass or Fail basis. To receive Pass, past performance must have an average rating of "good" on all Past Performance Questionnaires. If a Quoter does not have a history of relevant contract experience, the Quoter will receive a neutral past performance rating.

Past Performance is significantly less important than price.

5.2. EVALUATION OF OPTIONS – FAR 52.217-5

Except when it is determined in accordance with FAR [17.206\(b\)](#) not to be in the Government's best interests, the Government will evaluate offers for award purposes by adding the total price for all options to the total price for the basic requirement. Evaluation of options will not obligate the Government to exercise the option(s).

5.3. BASIS OF AWARD

Award will be made on the basis of the lowest evaluated price of quotes meeting or exceeding the acceptability standards for non-cost factors.
