**\*\*ALERT:** All contractors must be registered in the System for Award Management ([www.SAM.gov](http://www.SAM.gov)) prior to contractors submission. All proposed contractors are highly encouraged to review FAR Clause 52.232-33 Payments by Electronic Funds Transfer – System for Award Management, which indicates “All payments by the Government under this contract shall be made by electronic funds transfer (EFT).” Those not currently registered can obtain registration by going to the website <http://www.SAM.gov>. Effective June 29, 2018 vendors creating or updating their registration can have their registration activated prior to the approval of the required notarized letter.
