It is the responsibility of the contractor to check SAM.gov for any changes prior the site visit due to inclement weather.

Attendees are instructed to meet at the Visitor Center located at 20 Patriot Avenue, Westover ARB, Chicopee, MA, 01022-1507 (Westover Road Gate). You might be directed to park elsewhere at Government discretion.

Site visits may be limited to small groups; size will be determined by Contracting Officer to comply with Base recommendations. Additional site visit times may be scheduled to accommodate all requests.

Bids shall be submitted so that they will be received in the office designated in the invitation for bids not later than the exact time set for opening of bids.

The Government also reserves the right to make no award. Any contractor (and/or subcontractor) having a conflict of interest as defined under FAR Part 9.5 must identify the conflict as soon as it is known and provide a recommended mitigation plan. Mitigation plans are required whenever a competing contractor has had unequal access to nonpublic information regarding the requirement or has assisted the Government in defining the requirements or evaluation criteria. Each offeror's proposal shall consist of the completed and signed IFB with a cover letter delineating any exceptions taken to the IFB terms and conditions.
