

## COMBINED SYNOPSIS/SOLICITATION

This is a COMBINED SYNOPSIS/SOLICITATION for commercial items prepared in accordance with the policies and procedures using FAR subpart 12.6, Streamlined Procedures for Evaluation and Solicitation for Commercial Items, and FAR Part 13, Simplified Acquisition Procedures, as supplemented with additional information included in this notice. This announcement constitutes the only solicitation; quotes are being requested and a written formal solicitation will not be issued.

Solicitation H92240-23-Q-2030 is issued as a Request for Quotation (RFQ) **Only for authorized distributors as this is a Brand Name only requirement for Multi-Purpose Canine Climate-Controlled Kennels.**

**Quotes are due no later than 8 September 2023 at 9:00 AM Eastern Standard Time (EST).**

Quotes shall be submitted electronically [shelly.pollock@socom.mil](mailto:shelly.pollock@socom.mil). No facsimile quotes will be accepted. All quotes must be emailed with the RFQ Number in the subject line. Contractors are responsible for verifying receipt of their quotation to this office before offer due date and time. Quotations must be valid for 60 days. Email is the only acceptable method of submission. Offerors are responsible for ensuring the successful delivery of proposals to the Government office identified in the previous paragraph by the due date/time. Offerors are encouraged to submit the proposal with sufficient lead time to ensure all documents are successfully received by the contracting team prior to the closing date and time. The contracting team will confirm receipt of your proposal. If you do not receive a confirmation, you can assume your proposal was NOT received. Please be advised that timelines are determined by the date and time an Offeror's proposal is received, not when an Offeror attempts transmission.

Any quote received at the Government office designated in the solicitation after the exact time specified for receipt of offers is "late" and will not be considered unless it is (1) received before award is made, (2) the Contracting Officer determines that accepting the late offer would not unduly delay the acquisition; and (3) there is acceptable evidence to establish that it was received at the Government installation designated for receipt of offers and was under the Government's control prior to the time set for receipt of offers.

#### **52.209-11 REPRESENTATION BY CORPORATIONS REGARDING DELINQUENT TAX LIABILITY OR A FELONY CONVICTION UNDER ANY FEDERAL LAW (FEB 2016)**

(a) As required by sections 744 and 745 of Division E of the Consolidated and Further Continuing Appropriations Act, 2015 (Pub. L. 113-235), and similar provisions, if contained in subsequent appropriations acts, the Government will not enter into a contract with any corporation that--

(m) Quote Preparation and Submission Instructions.

(1) The Government intends to issue an award to the offeror whose quote represents lowest price technically acceptable (LPTA). LPTA is defined as submission of a quote that complies with all terms and conditions contained within the Request for Quote (RFQ) AND that is lowest priced and complies with all terms and conditions contained within the RFQ and Attachment 1 - Product Description.

(2) The Quoter may submit written questions during the quote preparation period. All questions must be received no later than **9:00 am EST on 1 September 2023** to allow adequate time to prepare and issue responses prior to the date and time set for receipt of quotes. Only written questions will receive a response. It is required that each question should include the document name, document date, specific page, paragraph, clause or other definitive citation requiring clarification. (3) Comprehensive responses to the requirements of this Request for Quote (RFQ) are required to enable the Government to evaluate the Quoter's capability and understanding to accomplish the stated requirements.

(4) Quoters must clearly identify any exception to the solicitation terms and conditions and provide complete accompanying rationale in their quote.

Quotes shall be submitted in accordance with the instructions herein. The quote shall be valid for no less than 60 days from the date of RFQ closing, a statement affirming this fact shall be included in the quote. The quote shall be a complete response to the requirements of this RFQ, inclusive of any applicable attachments, taking into consideration required quantities and delivery schedules specified in this solicitation.

Quoters shall include delivery lead time stated as calendar days after receipt of order (ARO).

It is the quoters responsibility to ensure that the entire proposal is received to this office prior to the closing time and date. Individual emails shall not exceed 10MB. Any files over 10MB may be rejected.

**ADMINISTRATIVE INFORMATION:** Complete business address of the Offeror, the corporate name to be used on any resultant contract, and the remittance address if different from that above. If this name does not identify a "parent company" or sponsoring "corporation" name, also provide such identity, as appropriate.

- The Offeror's Commercial and Government Entity (CAGE) Code and Unique Entity ID (UEI).
- Name, telephone numbers and e-mail address of person(s) to be contacted for clarification or questions to the quote.

– **Fill-In Clauses:** Provide all fill-ins or certifications required by the solicitation for inclusion in any resulting contract. The Quoter must be registered in the System for Award Management (SAM) to be eligible for award; Quotes received without the completed copy of the provision at FAR 52.212-3 or completed SAM representation may be considered non-compliant.

**FACTOR 1 – Technical/Quality:** The technical factor shall describe quoted items in sufficient detail to allow the Government to properly evaluate the items conformance to Attachment 1 - Product Description

for the required Brand Name items. A product brochure, catalogue, or website product description can be utilized to meet the above requirement. The technical factor is limited to 5 pages.

The Offeror will include the following statements in its technical submission.

- i) The Offeror shall make the affirmative statement that it has the ability to provide all items listed on the Attachment 1 – Product Description within the required delivery timeline.
- ii) The Offeror shall make the affirmative statement that the items that will be provided are Brand Name compliant and not third party.

**FACTOR 2 – Price:** The offeror shall complete pricing within Attachment 2 - ELIN Pricing Spreadsheet for ALL items to include options and delivery. The Government may require additional “other than cost and pricing data” prior to award. There is no page limit to this volume.

## **52.212-2 EVALUATION – COMMERCIAL PRODUCTS AND COMMERCIAL SERVICES (NOV 2021)**

(a) The Government will award a contract resulting from this solicitation to the responsible offeror whose offer conforming to the solicitation will be most advantageous to the Government, price and other factors considered. Award will be made to the lowest price technically acceptable offeror. LPTA is defined as submission of a quote that complies with all terms and conditions contained within the Request for Quote (RFQ) AND that is lowest priced. Lowest price is determined by the Total Evaluated Price of all items. All quotes received from eligible Offerors will be initially evaluated for completeness and conformance with the RFQ instructions. Incomplete and nonconforming quotes will not be further evaluated.

The following factors will be evaluated (factors are considered to be equal in importance):

1. Technical/Quality (ability to meet the brand name and quantities as specified in Attachment 1 – Product Description and Attachment 2 – Pricing Spreadsheet). Quotes identifying alternate brands may be considered technically unacceptable and ineligible for award.
2. Price - All prices will be evaluated for price reasonableness in accordance with FAR 13.106-3. The Government will determine each offeror's Total Evaluated Price (TEP). This analysis will be based on a sum of the base items to execute the requirements of Attachment 1 – Product Description. The proposed price to execute the Optional items noted in Attachment 2 – Pricing Spreadsheet will be a separate determination from the TEP and will not interfere with the award decision. The Government reserves the right to award optional items budget permitting. Note: evaluation of Optional items should not be deemed as a guaranteed commitment by the Government.

A finding of Unacceptable in Factor 1 will result in the entire quote being determined unacceptable and, therefore, ineligible for award. The Government will evaluate the Technical Factor using the following adjectival ratings

Prior to award, the Government may request additional information/data to support price reasonableness such as copies of paid invoices for the same/similar items, sales history for the same or similar items, price list with effective date and or copies of catalogue pages along with any applicable discounts. The Government may evaluate any and all information submitted by the vendor to support the reasonableness of prices quoted. The method of evaluation is solely within the discretion of the Contracting Officer.

(b) A written notice of award or acceptance of an offer, mailed or otherwise furnished to the successful offeror within the time for acceptance specified in the offer, shall result in a binding contract without further action by either party. Before the offer's specified expiration time, the Government may accept an offer (or part of an offer), whether or not there are negotiations after its receipt, unless a written notice of withdrawal is received before award.

### **52.212-3 OFFEROR REPRESENTATIONS AND CERTIFICATIONS-- COMMERCIAL PRODUCTS AND COMMERCIAL SERVICES (DEC 2022)**

The Offeror shall complete only paragraph (b) of this provision if the Offeror has completed the annual representations and certification electronically in the System for Award Management (SAM) accessed through <https://www.sam.gov>. If the Offeror has not completed the annual representations and certifications electronically, the Offeror shall complete only paragraphs (c) through (v) of this provision.

(a) Definitions. As used in this provision.

"Covered telecommunications equipment or services" has the meaning provided in the clause 52.204-25, Prohibition on Contracting for Certain Telecommunications and Video Surveillance Services or Equipment.

"Highest-level owner" means the entity that owns or controls an immediate owner of the offeror, or that owns or controls one or more entities that control an immediate owner of the offeror. No entity owns or exercises control of the highest level owner.

"Immediate owner" means an entity, other than the offeror, that has direct control of the offeror. Indicators of control include, but are not limited to, one or more of the following: Ownership or interlocking management, identity of interests among family members, shared facilities and equipment, and the common use of employees.

"Inverted domestic corporation" means a foreign incorporated entity that meets the definition of an inverted domestic corporation under 6 U.S.C. 395(b), applied in accordance with the rules and definitions of 6 U.S.C. 395(c).

"Manufactured end product" means any end product in product and service codes (PSCs) 1000-9999, except—

- (1) PSC 5510, Lumber and Related Basic Wood Materials;
- (2) Product or Service Group (PSG) 87, Agricultural Supplies;
- (3) PSG 88, Live Animals;
- (4) PSG 89, Subsistence;

- (5) PSC 9410, Crude Grades of Plant Materials;
- (6) PSC 9430, Miscellaneous Crude Animal Products, Inedible;
- (7) PSC 9440, Miscellaneous Crude Agricultural and Forestry Products;
- (8) PSC 9610, Ores;
- (9) PSC 9620, Minerals, Natural and Synthetic; and
- (10) PSC 9630, Additive Metal Materials.

"Place of manufacture" means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

"Predecessor" means an entity that is replaced by a successor and includes any predecessors of the predecessor.

"Reasonable inquiry" has the meaning provided in the clause 52.204-25, Prohibition on Contracting for Certain Telecommunications and Video Surveillance Services or Equipment.

"Restricted business operations" means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate--

- (1) Are conducted under contract directly and exclusively with the regional government of southern Sudan;

- (i) To restrict the free flow of unbiased information in Iran; or
- (ii) To disrupt, monitor, or otherwise restrict speech of the people of Iran; and

(2) Does not include information or informational materials the export of which the President does not have the authority to regulate or prohibit pursuant to section 203(b)(3) of the International Emergency Economic Powers Act (50 U.S.C. 1702(b)(3)).

"Service-disabled veteran-owned small business concern"—

(1) Means a small business concern--

(i) Not less than 51 percent of which is owned by one or more service-disabled veterans or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more service-disabled veterans; and

(ii) The management and daily business operations of which are controlled by one or more service-disabled veterans or, in the case of a service-disabled veteran with permanent and severe disability, the spouse or permanent caregiver of such veteran.

(2) Service-disabled veteran means a veteran, as defined in 38 U.S.C. 101(2), with a disability that is service-connected, as defined in 38 U.S.C. 101(16).

"Small business concern"--

(1) Means a concern, including its affiliates, that is independently owned and operated, not dominant in its field of operation, and qualified as a small business under the criteria in 13 CFR part 121 and size standards in this solicitation.

(2) Affiliates, as used in this definition, means business concerns, one of whom directly or indirectly controls or has the power to control the others, or a third party or parties control or have the power to control the others. In determining whether affiliation exists, consideration is given to all appropriate factors including common ownership, common management, and contractual relationships. SBA determines affiliation based on the factors set forth at 13 CFR 121.103.

"Small disadvantaged business concern, consistent with 13 CFR 124.1002", means a small business concern under the size standard applicable to the acquisition, that--

(1) Is at least 51 percent unconditionally and directly owned (as defined at 13 CFR 124.105) by--

"Successor" means an entity that has replaced a predecessor by acquiring the assets and carrying out the affairs of the predecessor under a new name (often through acquisition or merger). The term "successor" does not include new offices/divisions of the same company or a company that only changes its name. The extent of the responsibility of the successor for the liabilities of the predecessor may vary, depending on State law and specific circumstances.
