**REQUEST FOR INFORMATION (RFI)  
FOR UNITED STATES TRANSPORTATION COMMAND (USTRANSCOM)  
CAMPAIGN PLAN AND CAPABILITIES DEVELOPMENT (CP&CD)  
TRANSCOM23D007**

**1. Purpose.** This RFI is being issued for informational and planning purposes. THIS IS NOT A REQUEST FOR PROPOSAL/QUOTE nor is it to be construed as a commitment by the Government. The information requested will be used within USTRANSCOM as market research to facilitate decision making (i.e., determining acquisition strategy, small business concerns, etc.) and will not be disclosed outside the Government. Proprietary information submitted shall be appropriately marked. Please note that USTRANSCOM will NOT be responsible for any costs incurred by interested parties in responding to this RFI or Virtual Meetings.

**2. Description.** USTRANSCOM Strategic Plans, Policy, and Logistics Directorate (TCJ5/4) is seeking sources that possess the availability and capability to provide strategic functional expertise enabling the USTRANSCOM TCJ5/J4 to enhance the Joint Deployment and Distribution Enterprise (JDDE) and enhance capabilities in support of the warfighter. This support includes multimodal deployment, distribution (sealift/airlift/ground movements), and supply chain operations; development, staffing and implementation of global campaign, functional campaign, and distribution plans across the JDDE.

A draft Performance Work Statement (PWS) is attached for your reference and includes additional details. The Government seeks comments from industry regarding the draft PWS to clarify any ambiguities. These comments are excluded from the White Paper page limitation.

**Place of Performance.** The primary place of performance for all services will be performed at the Government site on Scott Air Force Base, IL.

Include designated point of contact's (POC) name, phone number, and email address. Again, this information will support market research activities within USTRANSCOM. USTRANSCOM is seeking tailored responses.

3. Knowledge and expertise in the development of Integrated Priority List (IPL) requirements which identify deployment and distribution capability issues, shortfalls, and gaps.

In order to participate in a one-on-one meeting, interested parties shall submit a white paper response outlining their specific capability pertaining to the scope and magnitude of the CP&CD requirements identified herein and include a meeting request in their white paper submission.

Upon review of all RFI Responses, a Microsoft TEAMS meeting invitation will be provided via email to all interested parties the Government determines to have capability relevant to the scope and magnitude of the CP&CD requirement. Due to scheduling constraints, allocated meeting times are firm. Requests for alternate meeting dates/times cannot be guaranteed. Time slots will be for 20 minutes (5 minutes to resolve any potential connectivity issues and no more than 15 minutes for discussion). Discussions will end promptly after 15 minutes.

**NOTE: Generic capability statements received in response to this RFI will not be reviewed and will not be considered for a one-on-one meeting.**
