Contractor Question: For the convoluted foam in CLINS 008 and 0015, can you provide a mil-spec or equal spec for the material? Also, can you confirm the overall thickness and peak/valley as the listed values do not appear to match thickness to peak/valley?

Government Response: The Mil-Prf reference for GREY POLYURETHANE foam is MIL\_PRF-26514, Type 1 Class 2. As far as confirming thickness, we need to know the application. We use (primarily) 8 inch thick, with 2 inch peaks and valleys and 6 inch thick with 1 inch peaks and valleys.

Contractor Question: We wanted to know about how many months in a year is expected. I understand that this is an IDIQ but we wanted to get a ballpark for pricing reasons.

Government response: 12 months a year. The estimates are monthly estimates. An additional column was added to the schedule of supplies for a yearly price for each CLIN.

Contractor Question: Will Solicitation SP3300-22-Q-0007 use DLA VSM for shipping?

Government Response: Solicitation SP3300-22-Q-0007 will not utilize VSM for shipping.
