4. Authority Cited:

(a) **FAR 13.106-1(b)(1)(i):** Only one source reasonably available (e.g., urgency, exclusive licensing agreement, brand name or industrial mobilization); OR

5. Reason for Authority Cited: This is a sole source requirement for an Ophthalmology Microscope is support of BACH. The equipment currently owned by BACH is past its life expectancy. The Original Equipment Manufacturer (OEM), Konan Medical provided an authorization letter dated 01 March 2023 allowing Corps Medical Supply, LLC to fulfill this requirement. Corps Medical is an exclusive reseller. The requested microscope is considered the gold standard for endothelial cell density determination, which is used for Refractive, Cataract, Intraocular Lens (IOL) Surgeries and general corneal health assessments. It is Digital Imaging and Communications in Medicine (DICOM) compatible. This equipment is also used to track and recommend treatment for cornea diseases. This device is used as the gold standard for corneal endothelial cell counting (specular microscopy) for remote endothelial cell counting by eye banks. The test indicates the quantity (its number per square millimeter), shape and size. Additionally, it can read 100-800 microns of the corneal. Corps Medical as a reseller for Konan is the only company that can provide these capabilities. If this equipment is not purchased active-duty patients serviced by BACH will not be able to get the needed treatment which will decrease mission readiness.

6. Actions to Increase Competition: There are no practical alternatives available to increase competition for this requirement, based on the reasons stated in paragraph 5 above. This action will be posted on the Government Point of Entry (GPE) website at SAM.gov.

7. Market Survey: Market research was conducted using Google, GSA and SAM. The requirement was not available through GSA. A Google search identified that this requirement is widely available. The suggested vendor is registered in SAM as a Small Business under NAICS code 334510. The suggested vendor is the sole distributor for the desired Ophthalmology Microscope which has required characteristics that are propriety to one manufacturer. Based on this the government will award a sole source contract to Corps Medical Supply LLC.
