Proposed project will be a firm fixed-price construction project. In accordance with DFARS 236.204, construction magnitude is estimated to be in the range of \$25,000,000 and \$100,000,000. 100 percent payment and performance bonds will be required.

The North American Industry Classification System (NAICS) code for this project is 562910, Remediation Services, and the associate small business size standard is \$22M.

This sources-sought announcement is a tool to identify businesses with the capability to accomplish the work and is for information/market research purposes only.

THIS IS NOT A REQUEST FOR PROPOSALS, QUOTATIONS OR BIDS, NOR A SYNOPSIS OF A PROPOSED CONTRACT ACTION UNDER FAR SUBPART 5.2. NO SOLICITATION IS CURRENTLY AVAILABLE. The type of solicitation to be issued will depend upon information received in response to this sources sought notice. No reimbursement will be made for any costs associated with providing information in response to this sources sought notice or any follow up information. Responses to this sources sought announcement will be used by the Government to make appropriate acquisition decisions. All interested firms should respond to this notice no matter what business size under NAICS 562910.

Unsolicited proposals will not be accepted. Further, proprietary information is not being requested at this time, and respondents shall refrain from providing proprietary information in response to this sources sought notice. No award will be made from this sources sought notice. This is not a request to be placed on a solicitation mailing list and is not to be construed as a commitment by the Government.

SUMMARY DESCRIPTION OF PROPOSED PROJECT:

Site location is currently releasing mine waste outside the mine that is leaching metals into the surface and groundwater, causing unacceptable risks to aquatic receptors. This requirement is to provide removal, and containment of mine materials, to reduces migration of cadmium, copper, and zinc to adjacent surface waters to acceptable levels for aquatic receptors. The consolidation and containment of mine materials will result in isolation of these materials from precipitation and surface water, reducing leaching of metals and discharging of MIW into surface water and groundwater. The duties required for this work are: cover mine materials not in proximity to headwaters near the site and current stable slopes; maintain submergence of tailings stored within former water, storage pond and containment under a new cover; construct repository within and outside of the primary mine disturbance area (PMDA); consolidate and placement of excavated mine materials; reclamation of excavated areas, and areas disturbed during construction; removal of mine waste materials on roads and implementation of additional drainage controls to prevent water infiltration through the roadbed; Stabilizing encapsulation mound (EM) slopes; grading and consolidate mine materials in a non-primary mine disturbance area (PMDA) repository, cover construction on the EM; excavation of mine materials from roads and reconstruct roads within the project limits.
