16. REMARKS Block 4: All submissions shall be sent electronically using Microsoft word. Block 10/12: The Initial submission of the Maintenance Task Analysis (MTA) (A003) shall be submitted thirty (30)calendar days after government acceptance of the Level of Repair Analysis (LORA) (A004). See Statement of Work for specific requirements. All submissions shall be sent via DoD Secure Access File Exchange (SAFE), accessed at https://safe.apps.mil/ . An In Process Review with the government and the contractor shall be conducted no more than fifteen (15) calendar days after government receipt of the initial submission of the MTA. Block 10/13: The Final submission of the MTA shall be submitted concurrently with the Final submission of the Technical Manual (TM) (A006), Failure Mode, Effects, and Criticality Analysis (FMECA)(A002), and Level of Repair Analysis (LORA) (A004) . The Final submission shall be refined to include all changes/updates and be consistent with the Maintenance Allocation Chart (MAC) (A005). The government shall determine acceptance or rejection of materiel and notify the contractor within thirty (30) calendar cays of receipt of each submission. If rejected, the contractor shall have fifteen (15)calendar days from receipt of rejection to make necessary corrections/changes and return to the government for subsequent review. The contractor shall maintain the MTA for the life of the contract and shall make additional deliveries as requested by the government. - Item A.** Self-explanatory.
- Item B.** Self-explanatory.
- Item C.** Mark (X) appropriate category: TDP - Technical Data Package; TM - Technical Manual; Other - other category of data, such as "Provisioning," "Configuration Management," etc.
- Item D.** Enter name of system/item being acquired that data will support.
- Item E.** Self-explanatory (to be filled in after contract award).
- Item F.** Self-explanatory (to be filled in after contract award).
- Item G.** Signature of preparer of CDRL.
- Item H.** Date CDRL was prepared.
- Item I.** Signature of CDRL approval authority.
- Item J.** Date CDRL was approved.
- Item 1.** See DoD FAR Supplement Subpart 4.71 for proper numbering.
- Item 2.** Enter title as it appears on data acquisition document cited in Item 4.

FOR THE CONTRACTOR

Item 17. Specify appropriate price group from one of the following groups of effort in developing estimated prices for each data item listed on the DD Form 1423.

a. Group I. Definition - Data which is not otherwise essential to the contractor's performance of the primary contracted effort (production, development, testing, and administration) but which is required by DD Form 1423.

Estimated Price - Costs to be included under Group I are those applicable to preparing and assembling the data item in conformance with Government requirements, and the administration and other expenses related to reproducing and delivering such data items to the Government.

b. Group II. Definition - Data which is essential to the performance of the primary contracted effort but the contractor is required to perform additional work to conform to Government requirements with regard to depth of content, format, frequency of submittal, preparation, control, or quality of the data item.

Estimated Price - Costs to be included under Group II are those incurred over and above the cost of the essential data item without conforming to Government requirements, and the administrative and other expenses related to reproducing and delivering such data item to the Government.

c. Group III. Definition - Data which the contractor must develop for his internal use in performance of the primary contracted effort and does not require any substantial change to conform to Government requirements with regard to depth of content, format, frequency of submittal, preparation, control, and quality of the data item.

Estimated Price - Costs to be included under Group III are the administrative and other expenses related to reproducing and delivering such data item to the Government.

d. Group IV. Definition - Data which is developed by the contractor as part of his normal operating procedures and his effort in supplying these data to the Government is minimal.

Estimated Price - Group IV items should normally be shown on the DD Form 1423 at no cost.

Item 18. For each data item, enter an amount equal to that portion of the total price which is estimated to be attributable to the production or development for the Government of that item of data. These estimated data prices shall be developed only from those costs which will be incurred as a direct result of the requirement to supply the data, over and above those costs which would otherwise be incurred in performance of the contract if no data were required. The estimated data prices shall not include any amount for rights in data. The Government's right to use the data shall be governed by the pertinent provisions of the contract.
