

This is a combined synopsis/solicitation for commercial services prepared in accordance with the format in FAR Subpart 12.6, as supplemented with additional information included in this notice. The solicitation document and incorporated provisions and clauses are those in effect through Federal Acquisition Circular 2023-04 dated 02 June 2023. This requirement is being solicited as full and open competition. The North American Industry Classification System Code (NAICS) is 332311, Prefabricated Metal Building and Component Manufacturing with a Small Business Size Standard of 750 employees. The basis of award will be Lowest Priced Technically Acceptable Offerer. Additionally, offerers must quote on all items to be eligible for award. The Government will award a contract resulting from this solicitation to the responsible offerer whose offer conforming to the solicitation.
