SUBJECT: EAST COAST SUBMARINE RESCUE VESSEL

1. THIS IS A SOURCES SOUGHT CONDUCTED BY THE PM42 PROGRAM OFFICE OF MSC. IT IS A REQUEST FOR INFORMATION ONLY, AND YOUR RESPONSE WILL NOT BE CONSIDERED AN OFFER. THIS REQUEST FOR INFORMATION DOES NOT COMMIT THE GOVERNMENT TO PAY ANY COSTS INCURRED IN THE PREPARATION OR SUBMISSION TO THIS SOURCES SOUGHT NOTICE OR TO CONTRACT FOR SERVICES.

2. MSC REQUESTS INFORMATION ABOUT THE PRICE AND AVAILABILITY OF U.S. FLAG, SELF-SUSTAINING, VESSELS OF OPPORTUNITY (VOO) TO PROVIDE SUPPORT FOR SUBMARINE SEA TRIALS, GENERAL-PURPOSE DIVING AND SALVAGE OPERATIONS IN COASTAL AND DEEP OCEAN AREAS INCLUDING NAVY UNIQUE DEEP OCEAN SALVAGE OPERATIONS. VESSEL MUST BE CAPABLE OF INSTALLING THE NATO SUBMARINE RESCUE SYSTEM (NSRS) AND SUBMARINE RESCUE DIVING RECOMPRESSION SYSTEM WITH TRANSFER UNDER PRESSURE (SRDRS-TUP) SYSTEM IN SUPPORT OF SUBMARINE RESCUE. \*\*NOTE: ONLY ONE SYSTEM WILL BE INSTALLED AT A TIME, BUT VESSEL MUST BE ABLE TO INSTALL EITHER BASED ON AVAILABILITY. THE VESSEL WILL OPERATE ALONG THE EAST COAST OF THE U.S. AND ATLANTIC OCEAN. VESSEL SHALL BE CREWED WITH U.S. CITIZENS.

3. SCOPE OF WORK: THE SHIP SHOULD BE CAPABLE OF SUPPORTING SUBMARINE SEA TRIALS, GENERAL-PURPOSE DIVING AND SALVAGE OPERATIONS IN COASTAL AND DEEP OCEAN AREAS INCLUDING NAVY UNIQUE DEEP OCEAN SALVAGE OPERATIONS. THIS WOULD INCLUDE THINGS LIKE:

- CONDUCT MANNED AND REMOTELY OPERATED VEHICLE DIVING OPERATIONS INCLUDING SATURATION DIVING
- CONDUCT SALVAGE/SURVEY ASSESSMENT
- SALVAGE GROUNDED/STRANDED VESSELS AND CRAFT
- LIFT SUNKEN OBJECTS
- CONDUCT UNDERWATER REPAIRS

4. VESSEL REQUIREMENTS:

- JONES ACT QUALIFIED AND U.S. FLAG VESSEL.
- CRANE: AN INSTALLED AND CERTIFIED CRANE IS DESIRED (PLEASE PROVIDE SPECIFICATIONS IF VESSEL IS EQUIPPED)
- DECK SPACE: MINIMUM 6,000 SQUARE FEET (THE AFT WORKING DECK SHOULD BE OPEN, CONTINUOUS, RECTANGULAR AREA WITH A MINIMUM LENGTH OF 35 METERS AND A MINIMUM WIDTH OF 12.8 METERS WITH A CLEAR OPENING ON THE STERN OF 11 METERS AT THE DECK LEVEL. THE AFT WORKING DECK SHALL BE CLEAR OF ALL EQUIPMENT AND DECK PROTRUSIONS TALLER THAN 50.8 MM (2 IN)
- STATION KEEPING: DP-2 OR EQUIVALENT (INDUSTRY STANDARD)
- FIRE FIGHTING: FiFi-1

- **ACCOMMODATIONS:** PERMANENT ACCOMMODATIONS FOR UP TO 20 MISSION SUPPORT PERSONNEL
- **COMMUNICATIONS:** BROADBAND INTERNET (MINIMUM OF 1MB BI-DIRECTIONAL), TELEPHONE AND TYPICAL COMMERCIAL MARITIME COMMUNICATIONS.

5. **AREA OF OPERATIONS:** VESSEL WILL BE HOME PORTED IN NORFOLK, VIRGINIA. BERTH WILL BE PROVIDED BY THE GOVERNMENT. OPERATIONS WILL OCCUR ALONG THE EAST / GULF COAST OF THE UNITED STATES AND NORTH ATLANTIC OCEAN.

6. **THE PERIOD OF PERFORMANCE, INCLUDING OPTION PERIODS:** ONE YEAR WITH ONE 4-MONTH OPTION

7. **LAYDAYS:** COMMENCING AND CANCELLING 15 AUGUST 2022.
