Questions and Responses

Q1: I was in the process of reviewing the building materials list. However the supplies list has numerous *"retail" building materials items re: fire extinguishers, shower curtains, kitchen and bath caulking, etc.* that our firm does not provide to our customers. As a wholesaler, we provide bulk quantities of items. We can quote only the plywood items if that is acceptable?

Governments' Response: No. The quote must list all items from the building materials list.

Q2: Do they ever use rebar rebar chairs dobie concrete wire or snap ties and wedges we are a manufacturer of those items?

Government's Response: No. The end-user does not have a need for rebar chairs dobie concrete wire or snap ties and wedges.
