SECTION A NARRATIVE

This is a combined synopsis/solicitation for a Contract to provide Army Substance Abuse Prevention (ASAP) Services at Rock Island Arsenal (RIA) Rock Island, IL. This solicitation is prepared in accordance with the format in Subpart 12.6, as supplemented with additional information included in this notice and in accordance with the simplified acquisition procedures authorized in FAR Part 13.

1. The U.S. Army Contracting Command - Rock Island (ACC-RI) hereby Requests a Proposal (RFP) W519TC-23-R-2046 for the procurement of ASAP Services for all personnel, supervision, access to prevention resources and non-personal services for the U.S. Army Garrison-Rock Island Arsenal (USAG-RIA), in accordance with (IAW) Attachment 0001 - PWS ASAP Services, dated 14 January 2022.

2. This solicitation is issued as a 100% Small Business Set-Aside. The RFP will be Firm Fixed Price (FFP) and IAW the provisions and clauses included in this solicitation. The resultant award will be a FFP Contract.

3. The U.S. Government intends to make a single award to the Lowest Price Technically Acceptable (LPTA) Offeror with acceptable Past Performance as outlined in FAR Clause 52.212-2 Evaluation Commercial Items. The Government reserves the right to award no contract at all, depending on the quality of the quotes, prices submitted, and the availability of funds.

4. Offerors proposal submittal shall include a completed Attachment 0002 Pricing Matrix to include the base and all option periods. The Technical and Past Performance submittals as outlined in FAR 52.212-2 in the solicitation, page 19. Please confirm that you do not take any exceptions to the RFP.

52.204-8 ANNUAL REPRESENTATIONS AND CERTIFICATIONS (MAR 2023)

(a)(1) The North American Industry Classification System (NAICS) code for this acquisition is 621420.

(2) The small business size standard is \$19,000,000.

(3) The small business size standard for a concern that submits an offer, other than on a construction or service acquisition, but proposes to furnish an end item that it did not itself manufacture, process, or produce is 500 employees, or 150 employees for information technology value-added resellers under NAICS code 541519, if the acquisition--

- (3) Telecommunications or video surveillance services provided by such entities or using such equipment; or
- (4) Telecommunications or video surveillance equipment or services produced or provided by an entity that the Secretary of Defense, in consultation with the Director of National Intelligence or the Director of the Federal Bureau of Investigation, reasonably believes to be an entity owned or controlled by, or otherwise connected to, the government of a covered foreign country.

Critical technology means--

- (1) Defense articles or defense services included on the United States Munitions List set forth in the International Traffic in Arms Regulations under subchapter M of chapter I of title 22, Code of Federal Regulations;
- (2) Items included on the Commerce Control List set forth in Supplement No. 1 to part 774 of the Export Administration Regulations under subchapter C of chapter VII of title 15, Code of Federal Regulations, and controlled--
 - (i) Pursuant to multilateral regimes, including for reasons relating to national security, chemical and biological weapons proliferation, nuclear nonproliferation, or missile technology; or
 - (ii) For reasons relating to regional stability or surreptitious listening;

Interconnection arrangements means arrangements governing the physical connection of two or more networks to allow the use of another's network to hand off traffic where it is ultimately delivered (e.g., connection of a customer of telephone provider A to a customer of telephone company B) or sharing data and other information resources.

Reasonable inquiry means an inquiry designed to uncover any information in the entity's possession about the identity of the producer or provider of covered telecommunications equipment or services used by the entity that excludes the need to include an internal or third-party audit.
