The Government may determine that an offer is unacceptable if the price is significantly unbalanced. Evaluation of price will be completed by looking at the total of CLINs 0001 and 0002.
3. Past Performance. The offeror's past performance on related contracts will be evaluated to determine, as appropriate, successful performance of contract requirements, quality and timeliness of delivery of goods and services, cost management, communications between contracting parties, proactive management and customer satisfaction.

**NDBC STANDARD SPECIFICATION FOR FABRICATION OF BUOY BRIDLE  
USED IN THE TROPICAL ATMOSPHERE OCEAN (TAO) ARRAY**

**1.0 SCOPE**

1.1 General. This specification describes the requirements for the fabrication of the buoy bridle used in the Tropical Atmosphere Ocean (TAO) array. The contractor shall provide all the necessary labor, material, equipment, facilities and services to fabricate and deliver the buoy bridles to the National Data Buoy Center (NDBC).

1.2 Precedence. Any ambiguity or conflict between this specification and other applicable documents shall be resolved by the following order of precedence:

- a) The issued contract with any amendments or modifications
- b) This specification
- c) The drawings listed in paragraph 2.4
- d) Other applicable documents listed in paragraph 2.0

**2.0 APPLICABLE DOCUMENTS**

2.1 General. The documents listed in this section are referenced in sections 3 and 4 of this specification. This section does not include documents cited in other sections of this specification, which are recommended for additional information or used as examples. While every effort has been made to ensure the completeness of this list, document users are cautioned that they must meet all specified requirements cited in sections 3 and 4 of this specification, whether or not the referenced documents are listed here.

### **3.0 REQUIREMENTS**

The bridle's upper structure shall be fabricated from 316 Stainless Steel and only the lower pad eye weldment shall be fabricated from steel that has been hot dip galvanized per ASTM A123. All stainless steel welding shall be in accordance with AWS D1.6. All steel welding shall be in accordance with AWS D1.1/D1.1M.

### **4.0 QUALITY ASSURANCE**

4.1 Welding Procedures and Qualifications. The contractor shall submit welding procedures and welder qualifications that conform with AWS D1.1/D1.1M and AWS D1.6 prior to fabrication of the bridle.

4.2 Material Certifications. The contractor shall provide vendor supplied material certifications for all materials used in the construction of the bridle.

4.3 First Article. The contractor shall produce and deliver a first article of the bridle for inspection prior to commencing fabrication of the remainder of the articles. This requirement may be waived at the contracting officer's discretion if the contractor has successfully completed



a TAO buoy bridle contract in the past.

However, direct access to the AGO Ombudsman may be sought when an interested party questions the objectivity or equity of a contracting officer's decision, or when there is a bona fide reason to believe that reasonable, responsible, and objective consideration will not be received from an assigned contracting officer.

(d) There are several constraints to the scope of the AGO Ombudsman's authority, for instance:

(1) Consulting with the AGO Ombudsman does not alter or postpone the timelines of any formal process (e.g., protests, claims, debriefings, employee employer actions, activities involving A76 competition performance decisions, judicial or congressional hearings, or proposal, amendment, modification or deliverable due dates, etc.).

(2) The AGO Ombudsman cannot participate in the evaluation of proposals, source selection processes, or the adjudication of protests or formal contract disputes.

(3) The AGO Ombudsman is not authorized to generate or alter laws, judicial decisions, rules, policies, or formal guidance.

(4) The AGO Ombudsman is not authorized to develop or alter opportunity announcements, solicitations, contracts, or their terms or conditions.

(5) The AGO Ombudsman cannot overrule the authorized decisions or determinations of the contracting officer.

(6) The AGO Ombudsman has no authority to render a decision that binds AGO, NOAA, the Department of Commerce, or the U.S. Government.

(7) The AGO Ombudsman is not NOAA's agent relative to the service of magistrate or judicial process and cannot be used to extend service of process to another party (whether federal, public, or a private entity).

(e) After review and analysis of a filed concern or recommendation, the AGO Ombudsman may refer the interested party to another more suitable federal official for consideration. Moreover, concerns, disagreements, and/or recommendations that cannot be resolved by the AGO Ombudsman will need to be pursued through more formal venues.

(f) The AGO Ombudsman is not to be contacted to request copies of forms and/or documents under the purview of a contracting officer. Such documents include Requests for Information, solicitations, amendments, contracts, modifications, or conference materials.

The contractor shall prepare and submit an invoice to the designated official for approval with a copy to the contracting officer for information. All invoices shall be submitted by the 10th day of the subsequent month.

THE DESIGNATED GOVERNMENT OFFICIAL RESPONSIBLE FOR ACCEPTANCE AND APPROVAL OF INVOICES SHALL BE AS SHOWN ON PAGE 3 OF THE PURCHASE ORDER.

To constitute a proper invoice, the contractor's invoice shall be prepared in accordance with, and contain all elements specified in FAR 52.212-4, paragraph (g), entitled, "Invoice."

If the invoice does not comply with FAR 52.212-4(g), the designated government official shall return the invoice to the contractor within seven days after the date the invoice was received with a statement as to the reasons why it is not a proper invoice.
