1. OVERVIEW

This is a “Best Value-Tradeoff” Unrestricted Request for Proposal. The Government will evaluate proposals in accordance with the criteria herein and award a firm-fixed-price contract to the responsible offeror whose proposal conforms to all the terms and conditions of the solicitation and whose proposal is determined to represent the overall best value to the Government.

2. PROPOSAL SUBMITTAL INSTRUCTIONS

Written materials: 8.5” x 11” page size; font no smaller than 10-point size. The requirements specified in the solicitation are considered minimum requirements. A proposal that fails to comply with the minimum technical requirements will not be eligible for award. 5. BASIS OF AWARD

The Contracting Officer will award a firm-fixed-price contract to the responsible offeror whose proposal conforms to the RFP, is fair and reasonable, and offers the best overall value to the Government considering all non-price factors described herein, and price. **Technical factors 1 and 2 when combined are significantly more important than cost or price.** After the Government individually evaluates and rates each proposal, the Contracting Officer/Source Selection Authority will compare proposals to determine which proposal represents the best value. The Government reserves the right to accept *other than* the lowest priced offer or to reject all offers. The Government will not award a contract to an offeror whose proposal contains a deficiency, as defined in FAR 15.001. If there is a lower priced, conforming offer(s), the Contracting Officer/Source Selection Authority must determine if that the added value of a more expensive proposal would justify award to that offeror.

8. TECHNICAL (VOLUME 1) FACTOR 1: PROJECT MANAGEMENT PLAN (PMP)

Submission Requirements:

The offeror shall provide a comprehensive Project Management Plan (PMP) developed specifically for construction of this project, which will become an integral part of the resultant contract. **The PMP package including the progress chart shall not exceed 20 pages.**

The PMP shall include a well thought out work plan for accomplishing the work, along with, but not limited to discussing the contractor’s method and equipment to be used on the project, safety equipment, quality assurance testing, and as-built drawings. The work plan shall include a comprehensive schedule, in progress chart format, showing a planned schedule to complete the project by the specified contract completion date. A non-binding, arbitrary NTP date of September 30, 2022 shall be assumed with a contract duration of 547 days. Contractor shall be aware of and incorporate any work hour or operational limitations (Federal Holidays, non-work periods, normal work hours, crane operations, etc.as discussed in Section 01 12 00) along with the **“No Work” period- from 06 MARCH 2023 – 19 MAY 2023 and 1 March 2024 – 30 May 2024, when the the facility MUST have a fully operational crane.**

The progress chart shall be in 11" x 17" format.

A schedule that proposes a contract duration less than 547 days and is evaluated favorably on that basis may

be accepted and incorporated as a contract requirement.

The progress chart should be accompanied with a narrative addressing production rates, weather days, periods of non-work, planned outages and address methods to be utilized to keep the project on schedule. All major work tasks shall be included. The schedule and narrative shall address power line, unit and crane outages including, but not limited to, coordination of outages with the USACE, timeframes and time periods of the outages and how the contractor will mitigate delays should they occur during outages. The schedule and narrative should address any period during which portions of the generator floor will not be able to be fully utilized due to the rail replacement and identify other features of work they will be performing concurrently during this downtime. The project schedule shall not include any funding or pricing data.

The contractor shall include an organization chart as part of this Factor to illustrate the management approach and lines of communication. The PMP shall also include the method of management of all subcontractors, preparation and submission of As-Built documents upon construction completion, and contract close-out. The information in the plan should make it clear that the offeror has the ability to deliver a quality product and effectively manage all subcontractors on the team, as well as the ability to coordinate all work throughout the construction phase. As a minimum, the PMP shall address all of the following:

- Work Plan, including schedule in progress chart format and descriptive literature for all equipment
- Management Approach, including any special work restrictions or phasing identified in the solicitation documents
- Organizational Chart
- Sub-Contractor Management
- Preparation and submission of As-Built documents
- Contract close-out

Evaluation Method:

Strengths or Significant Strengths may be given for the following criteria:

- A PMP which addresses all items requested in a thorough and comprehensive manner, and that demonstrates an effective plan for construction and close-out of the project.
- A PMP that demonstrates the Offeror's competence in executing projects that are similar to this solicitation
- A PMP that minimizes outages and the time the Project Office is without a functioning crane.
- An organizational structure that thoroughly explains and clearly delineates roles and responsibilities and flows of communications between the Contractor, subcontractor, and the Government.
- A PMP which shows a thorough understanding of the requirements in the RFP and incorporates those requirements into the plan.

Weaknesses or Significant Weaknesses may be given for the following criteria:

- A PMP that does not cover all phases of work and/or demonstrates that the offeror does not understand the complexity of the project or has not considered all logistical steps in the work plan.
- A PMP that reflects an organizational structure that does not thoroughly explain or clearly identify the roles, responsibilities, hierarchies, or flows of communication both internally and with USACE.
- A proposed contract duration that is longer than the required contract duration will be viewed as a significant weakness.
- Omission of any item requested above will result in lower evaluation ratings for this tab.

9. TECHNICAL (VOLUME 1) FACTOR 2: PAST PERFORMANCE

Submission Requirements:

The Government will evaluate how the projects submitted by the offeror demonstrate similar work experience that is relevant to this solicitation. The Contractor shall submit two (2) projects of similar scope completed within the last 8 years (from the proposal due date). Similar scope is defined as installation of bridge, overhead, or industrial crane rails and rail appurtenances in accordance with CMAA 70.

Each project submitted shall include the following content:

1. Contract number and Offeror's and/or major subcontractor's specific role in the project.
2. Project name and location.
3. Name of customer, agency, or firm.
4. Point of contact (POC) information for the customer, agency, or firm, including name, title, email, and telephone number.
5. Scope of project (designed, built, and/or installed, describe major features, components, etc.); focus on the installation of similar crane rails, anchors, and installation within a similar environment and similar aspects of the project. Provide a minimum of one inspection demonstrating work was in conformance with CMAA 70.
6. Total Dollar Amount.
7. Start and completion dates, or anticipated date of completion and percent complete.
8. Role of Offeror (Prime or Subcontractor) Address type of work performed and percentage of work, as applicable. Also indicate whether proposed team members were directly involved in the project, describing work performed, roles, and responsibilities.
9. If the offeror is a joint venture combining two or more companies, state whether each project was performed by the same joint venture. Each member of the joint venture shall demonstrate experience commensurate with its proposed role on this project.
10. If the experience of a subcontractor is being used to meet the experience requirement, a letter of commitment from the subcontractor to complete the work in this solicitation must be included with the Contractor's proposal.

Contractor must provide all finalized CPARS for each project submitted or a Past Performance Questionnaire if no finalized CPARS has not been completed for the submitted project. Previously completed PPOs are acceptable.

See **Attachment A**, Past Performance Questionnaire, for a form that shall be used to fulfill this requirement.

- If there is not a completed CPARS evaluation, the offeror shall submit a Past Performance Questionnaire (PPQ) for the project. **Do not submit a PPQ when a completed CPARS is available.**
 - If the offeror is unable to obtain a completed PPQ from a client for a project(s) before the closing date, the offeror shall complete and submit with the proposal the first page of the PPQ, which will provide contract and client information for the respective project(s).
 - Offerors should follow up with clients/references to ensure timely submittal of questionnaires. If the client requests, questionnaires may be submitted directly to the Government's point of contact, via email at Brianna.Boehne@usace.army.mil prior to the closing date. Otherwise, the PPQs shall be submitted with the proposal. The offerors shall instruct the clients to refer to the solicitation number in the subject line.
 - PPQs are source selection materials. All successfully submitted PPQs will receive an email confirmation upon receipt. If the offeror does not receive the confirmation, it is the offeror's responsibility to follow up to ensure the government has received the information.
 - In addition to the above, the Government may review other sources of information for evaluating past performance. Other sources may include, but are not limited to, past performance information retrieved through the (Contractor Performance Assessment and Reporting System) CPARS, using all CAGE/UEID (Commercial and Government Entity Code/Unique Entity Identification) numbers of team members (partnership, joint venture, teaming arrangement, or parent company/subsidiary/affiliate) identified in the offeror's quote,

inquiries of owner representative(s), FAPIIS (Federal Awardee Performance and Integrity Information System), Electronic Subcontract Reporting System (eSRS), or other databases, telephone interviews with organizations familiar with the offeror's performance, Government personnel with personal knowledge of the offeror's performance capability, and any other known sources not provided by the offeror.

While the Government may elect to consider data from other sources, the burden of providing detailed, current, accurate, and complete past performance information rests with the offeror.

Evaluation Method:

Only two (2) projects will be evaluated. If an offeror submits more than two (2) projects, only the first two (2) projects will be evaluated. Offerors shall describe each project with enough detail to ensure that the Government can meaningfully assess how well the projects submitted meet the evaluation criteria outlined below.

In determining strengths and weaknesses, the Government will consider the following when evaluating the offeror's Experience:

- Projects that are more similar in size, scope, and complexity to the scope of work in this RFP shall be evaluated more favorably.
- The past performance on projects that are more similar will be considered more heavily than for past performance on projects that are less similar.
- Any other aspect of the project that the evaluators could determine enhances the merit of the quote or increases the probability of successful performance of the contract.

The past performance evaluation results in an assessment of the Offeror's probability of meeting the solicitation requirements. There are two aspects of the past performance evaluation. The first aspect is relevancy. The past performance evaluation considers each Offeror's demonstrated recent and relevant record of performance in supplying products and services that meet the contract's requirements. The Offeror's past performance will be evaluated to determine how relevant a recent effort accomplished by the Offeror is to the effort to be acquired through the source selection. Consideration shall be given to those aspects of an Offeror's contract history that would give the greatest ability to measure whether the Offeror will satisfy the current procurement. Common aspects of relevancy include similarity of service/support, complexity; dollar value, contract type, and degree of subcontract/teaming. There are four levels of relevancy as shown below. With respect to relevancy, more relevant past performance will typically be a stronger predictor of future success and have more influence on the past performance confidence assessment than past performance of lesser relevance. The following ratings will be used to evaluate Factor 2:

The second aspect of the past performance evaluation is to determine how well the contractor performed on the contracts and give a performance confidence assessment. The past performance evaluation process gathers information from customers on how well the Offeror performed those past contracts. Past performance information may be provided by the Offeror, as solicited. Past performance information may also be obtained from questionnaires. Past performance information shall be obtained from any other sources available to the Government, to include, but not limited to, the Contractor Performance Assessment Reporting System (CPARS), Federal Awardee Performance and

Integrity Information System (FAPIS), Electronic Subcontract Reporting System (eSRS), or other databases; interviews with Program Managers and Contracting Officers. In conducting a performance confidence assessment, each Offeror shall be assigned one of the ratings as indicated below.

10. VOLUME 2, FACTOR 3: PRICE

Submission Requirements:

The pricing proposal shall be submitted as a separate file IAW paragraph 2 above and shall contain the following information:

- (1) **Section 00 10 00, Solicitation/Contract Form and Pricing Schedule:** Submit the properly filled out pricing schedule, containing proposed line item and total pricing, as well as the proposed performance duration.
- (2) **Financial:** Name, address, and fax number of Financial Institution including the Name and phone number of finance individual (primary and alternate) to be contacted for information.
- (3) **Bonding Information:** Submit information showing Offeror's bondability in the amount of the proposal. Provide the name, address, regular phone number of your Surety Company.

Evaluation Method:

Price will not be rated or scored, but will be evaluated for fairness and reasonableness through the use of a price analysis. The price evaluators will also check for appearance of unbalanced line-item prices. Offerors are cautioned to distribute direct costs, such as material, labor, equipment, subcontracts, etc. and to evenly distribute indirect costs, such as job overhead, home office overhead, bond, etc., to the appropriate contract line items. If deemed necessary, supplemental price breakdown information may be requested to assist the Government in performing the price evaluations described above.

Financial and Bonding information will be used by the Contracting Officer to determine offeror responsibility in accordance with FAR Part 9.

CLAUSES INCORPORATED BY FULL TEXT

52.211-10 COMMENCEMENT, PROSECUTION, AND COMPLETION OF WORK (APR 1984)

The Contractor shall be required to (a) commence work under this contract within 10 calendar days after the date the Contractor receives the notice to proceed, (b) prosecute the work diligently, and (c) complete the entire work ready for use **within 547 calendar days from Notice to Proceed. This must include a “No Work” period - from 06 MARCH 2023 – 19 MAY 2023 and 1 March 2024 – 30 May 2024, when the the facility MUST have a fully operational crane.** The time stated for completion shall include final cleanup of the premises.

52.211-12 LIQUIDATED DAMAGES--CONSTRUCTION (SEP 2000)

(a) If the Contractor fails to complete the work within the time specified in the contract, the Contractor shall pay liquidated damages to the Government in the amount of **\$627 for each calendar day** of delay until the work is completed or accepted.

(b) If the Government terminates the Contractor's right to proceed, liquidated damages will continue to accrue until the work is completed. These liquidated damages are in addition to excess costs of repurchase under the Termination clause.

The Contractor shall make a good faith effort to employ

minorities and women evenly on each of its projects. The transfer of minority or female employees or trainees from Contractor to Contractor, or from project to project, for the sole purpose of meeting the Contractor's goals shall be a violation of the contract, Executive Order 11246, as amended, and the regulations in 41 CFR 60-4. Compliance with the goals will be measured against the total work hours performed.

(d) The Contractor shall provide written notification to the Deputy Assistant Secretary for Federal Contract Compliance, U.S. Department of Labor, within 10 working days following award of any construction subcontract in excess of \$10,000 at any tier for construction work under the contract resulting from this solicitation. The notification shall list the --

- (1) Name, address, and telephone number of the subcontractor;
- (2) Employer's identification number of the subcontractor;
- (3) Estimated dollar amount of the subcontract;
- (4) Estimated starting and completion dates of the subcontract; and
- (5) Geographical area in which the subcontract is to be performed.

(e) As used in this Notice, and in any contract resulting from this solicitation, the "covered area" is **Fort Peck Dam, Montana (McCone County)**.

52.225-9 BUY AMERICAN—CONSTRUCTION MATERIALS (NOV 2021)

(a) Definitions. As used in this clause--

Commercially available off-the-shelf (COTS) item—

(1) Means any item of supply (including construction material) that is--

(i) A commercial product (as defined in paragraph (1) of the definition of "commercial product" at Federal Acquisition Regulation (FAR) 2.101);

(ii) Sold in substantial quantities in the commercial marketplace; and

(iii) Offered to the Government, under a contract or subcontract at any tier, without modification, in the same form in which it is sold in the commercial marketplace; and

(2) Does not include bulk cargo, as defined in 46 U.S.C. 40102(4) such as agricultural products and petroleum products.

Component means an article, material, or supply incorporated directly into a construction material.

Construction material means an article, material, or supply brought to the construction site by the Contractor or a subcontractor for incorporation into the building or work. The term also includes an item brought to the site preassembled from articles, materials, or supplies. However, emergency life safety systems, such as emergency lighting, fire alarm, and audio evacuation systems, that are discrete systems incorporated into a public building or work and that are produced as complete systems, are evaluated as a single and distinct construction material regardless of when or how the individual parts or components of those systems are delivered to the construction site. Materials purchased directly by the Government are supplies, not construction material.

Cost of components means--

(1) For components purchased by the Contractor, the acquisition cost, including transportation costs to the place of incorporation into the construction material (whether or not such costs are paid to a domestic firm), and any applicable duty (whether or not a duty-free entry certificate is issued); or

(2) For components manufactured by the Contractor, all costs associated with the manufacture of the component, including transportation costs as described in paragraph (1) of this definition, plus allocable overhead costs, but excluding profit. Cost of components does not include any costs associated with the manufacture of the construction material.

Domestic construction material means--

(1) For construction material that does not consist wholly or predominantly of iron or steel or a combination of both-

(i) An unmanufactured construction material mined or produced in the United States; or

(ii) A construction material manufactured in the United States, if--

(A) The cost of its components mined, produced, or manufactured in the United States exceeds 55 percent of the cost of all its components. Components of foreign origin of the same class or kind for which nonavailability determinations have been made are treated as domestic. Components of unknown origin are treated as foreign; or

(B) The construction material is a COTS item; or

(2) For construction material that consists wholly or predominantly of iron or steel or a combination of both, a construction material manufactured in the United States if the cost of foreign iron and steel constitutes less than 5 percent of the cost of all components used in such construction material. The cost of foreign iron and steel includes but is not limited to the cost of foreign iron or steel mill products (such as bar, billet, slab, wire, plate, or sheet), castings, or forgings utilized in the manufacture of the construction material and a good faith estimate of the cost of all foreign iron or steel components excluding COTS fasteners. Iron or steel components of unknown origin are treated as foreign. If the construction material contains multiple components, the cost of all the materials used in such construction material is calculated in accordance with the definition of "cost of components".

Fastener means a hardware device that mechanically joins or affixes two or more objects together. Examples of fasteners are nuts, bolts, pins, rivets, nails, clips, and screws.

Foreign construction material means a construction material other than a domestic construction material.

Foreign iron and steel means iron or steel products not produced in the United States. Produced in the United States means that all manufacturing processes of the iron or steel must take place in the United States, from the initial melting stage through the application of coatings, except metallurgical processes involving refinement of steel additives. The origin of the elements of the iron or steel is not relevant to the determination of whether it is domestic or foreign.

Predominantly of iron or steel or a combination of both means that the cost of the iron and steel content exceeds 50 percent of the total cost of all its components. The cost of iron and steel is the cost of the iron or steel mill products (such as bar, billet, slab, wire, plate, or sheet), castings, or forgings utilized in the manufacture of the product and a good faith estimate of the cost of iron or steel components excluding COTS fasteners.

Steel means an alloy that includes at least 50 percent iron, between 0.02 and 2 percent carbon, and may include other elements.

United States means the 50 States, the District of Columbia, and outlying areas.

(b) Domestic preference.

(1) This clause implements 41 U.S.C. chapter 83, Buy American, by providing a preference for domestic construction material. In accordance with 41 U.S.C. 1907, the domestic content test of the Buy American statute is waived for construction material that is a COTS item, except that for construction material that consists wholly or predominantly of iron or steel or a combination of both, the domestic content test is applied only to the iron and steel content of the construction materials, excluding COTS fasteners. (See FAR 12.505(a)(2)). The Contractor shall use only domestic construction material in performing this contract, except as provided in paragraphs (b)(2) and (b)(3) of this clause.

(2) This requirement does not apply to information technology that is a commercial product or to the construction materials or components listed by the Government as follows:

(3) The Contracting Officer may add other foreign construction material to the list in paragraph (b)(2) of this clause if the Government determines that

(i) The cost of domestic construction material would be unreasonable. The cost of a particular domestic construction material subject to the requirements of the Buy American Act is unreasonable when the cost of such material exceeds the cost of foreign material by more than 20 percent;

(ii) The application of the restriction of the Buy American Act to a particular construction material would be impracticable or inconsistent with the public interest; or

(iii) The construction material is not mined, produced, or manufactured in the United States in sufficient and reasonably available commercial quantities of a satisfactory quality.

(c) Request for determination of inapplicability of the Buy American Act. (1)(i) Any Contractor request to use foreign construction material in accordance with paragraph (b)(3) of this clause shall include adequate information for Government evaluation of the request, including--

(A) A description of the foreign and domestic construction materials;

(B) Unit of measure;

(C) Quantity;

(D) Price;

(E) Time of delivery or availability;

(F) Location of the construction project;

(G) Name and address of the proposed supplier; and

(H) A detailed justification of the reason for use of foreign construction materials cited in accordance with paragraph (b)(3) of this clause.

(ii) A request based on unreasonable cost shall include a reasonable survey of the market and a completed price comparison table in the format in paragraph (d) of this clause.

(iii) The price of construction material shall include all delivery costs to the construction site and any applicable duty (whether or not a duty-free certificate may be issued).

(iv) Any Contractor request for a determination submitted after contract award shall explain why the Contractor could not reasonably foresee the need for such determination and could not have requested the determination before contract award. If the Contractor does not submit a satisfactory explanation, the Contracting Officer need not make a determination.

(2) If the Government determines after contract award that an exception to the Buy American statute applies and the Contracting Officer and the Contractor negotiate adequate consideration, the Contracting Officer will modify the contract to allow use of the foreign construction material. However, when the basis for the exception is the unreasonable price of a domestic construction material, adequate consideration is not less than the differential established in paragraph (b)(3)(i) of this clause.

(3) Unless the Government determines that an exception to the Buy American statute applies, use of foreign construction material is noncompliant with the Buy American statute.

(d) Data. To permit evaluation of requests under paragraph (c) of this clause based on unreasonable cost, the Contractor shall include the following information and any applicable supporting data based on the survey of suppliers:

52.228-14 IRREVOCABLE LETTER OF CREDIT (NOV 2014)

(a) "Irrevocable letter of credit" (ILC), as used in this clause, means a written commitment by a federally insured financial institution to pay all or part of a stated amount of money, until the expiration date of the letter, upon presentation by the Government (the beneficiary) of a written demand therefor. Neither the financial institution nor the offeror/Contractor can revoke or condition the letter of credit.

(b) If the offeror intends to use an ILC in lieu of a bid bond, or to secure other types of bonds such as performance and payment bonds, the letter of credit and letter of confirmation formats in paragraphs (e) and (f) of this clause shall be used.

The classifications are listed in alphabetical order of ""identifiers"" that indicate whether the particular rate is a union rate (current union negotiated rate for local), a survey rate (weighted average rate) or a union average rate (weighted union average rate).

Union Rate Identifiers

A four letter classification abbreviation identifier enclosed in dotted lines beginning with characters other than ""SU"" or ""UAVG"" denotes that the union classification and rate were prevailing for that classification in the survey. Example: PLUM0198-005 07/01/2014. PLUM is an abbreviation identifier of the union which prevailed in the survey for this classification, which in this example would be Plumbers. 0198 indicates the local union number or district council number where applicable, i.e., Plumbers Local 0198. The next number, 005 in the example, is an internal number used in processing the wage determination. 07/01/2014 is the effective date of the most current negotiated rate, which in this example is July 1, 2014.

Union prevailing wage rates are updated to reflect all rate changes in the collective bargaining agreement (CBA) governing this classification and rate.

Survey Rate Identifiers

Classifications listed under the ""SU"" identifier indicate that no one rate prevailed for this classification in the survey and the published rate is derived by computing a weighted average rate based on all the rates reported in the survey for that classification. As this weighted average rate includes all rates reported in the survey, it may include both union and non-union rates. Example: SULA2012-007 5/13/2014. SU indicates the rates are survey rates based on a weighted average calculation of rates and are not majority rates. LA indicates the State of Louisiana. 2012 is the year of survey on which these classifications and rates are based. The next number, 007 in the example, is an internal number used in producing the wage determination. 5/13/2014 indicates the survey completion date for the classifications and rates under that identifier.

Survey wage rates are not updated and remain in effect until a new survey is conducted.

Union Average Rate Identifiers

Classification(s) listed under the UAVG identifier indicate that no single majority rate prevailed for those classifications; however, 100% of the data reported for the classifications was union data. EXAMPLE: UAVG-OH-0010 08/29/2014. UAVG indicates that the rate is a weighted union average rate. OH indicates the state. The next number, 0010 in the example, is an internal number used in producing the wage determination. 08/29/2014 indicates the survey completion date for the classifications and rates under that identifier.

A UAVG rate will be updated once a year, usually in January of each year, to reflect a weighted average of the current negotiated/CBA rate of the union locals from which the rate is based.

WAGE DETERMINATION APPEALS PROCESS

1.) Has there been an initial decision in the matter? This can be:

- * an existing published wage determination
- * a survey underlying a wage determination
- * a Wage and Hour Division letter setting forth a position on a wage determination matter
- * a conformance (additional classification and rate) ruling

On survey related matters, initial contact, including requests for summaries of surveys, should be with the Wage and Hour National Office because National Office has responsibility for the Davis-Bacon survey program. If the response from this initial contact is not satisfactory, then the process described in 2.) and 3.) should be followed.

With regard to any other matter not yet ripe for the formal process described here, initial contact should be with the Branch of Construction Wage Determinations. Write to:
