TECHNICAL SPECIFICATIONS

1.0 INTENT

The following specifications pertain to the purchase of construction materials to install a new roof on an outbuilding at the Dworshak Project.

2.0 SCOPE

The successful Offeror shall be required to provide the materials described in Section 3.0 below and ship the materials to Dworshak Project as required in Section 6.0, Shipment and Delivery. All items delivered under this contract must be new and in original packaging if applicable.

3.0 CONSTRUCTION MATERIAL SPECIFICATION

3.1 Construction Materials and Equipment

3.1.1 2 inch x 4 inch x 20 feet Douglas Fir Lumber (Quantity 95): The Contractor shall deliver 2 inch x 4 inch x 20 feet Douglas Fir No. 2 and better boards. The boards shall be free of any substantial defects such as crowns and cracks.

3.1.2 4 feet x 8 feet x 1.5 inch Thick Rigid Foam Board Insulation (Quantity 80): The contractor shall deliver 4 feet x 8 feet x 1.5 inch rigid foam board panels. The rigid insulation panels must have a minimum R-Value rating of 7.5 and have a minimum compressive strength of 15 psi.

3.1.3 29 Gauge Galvanized Steel Roof Panel (Quantity 42): The contractor shall deliver 29 Gauge galvanized steel roof panels with tuff rib configuration. The roof panels must be "Copper Penny" in color and be constructed of Grade 80 steel. Roof Panels must have ¾ inch rib height with 36 inch of coverage and an overall length of 21 feet. The product selected must be UL approved for class 4 hail. All panels must be new, undamaged, and arrive bundled together in standard packaging units designed for movement via a forklift.

3.1.4 4 feet x 8 feet x 19/32 inch Oriented Strand Board (Quantity 80): The contractor shall deliver 4 feet x 8 feet x 19/32 inch oriented strand board panels. The panels must meet APA ratings for safety and quality.

3.1.5 Synthetic Metal Roof Underlayment 4 feet x 250 feet (Quantity 4): The contractor shall deliver rolls of metal roof underlayment that are 4 feet in width and 250 feet in length. The synthetic underlayment must have a minimum thickness of 25 mils. The underlayment must protect against UV exposure for up to 6 months and have a slip resistant finish.

3.1.6 Heavy Duty Hammer Tacker (Quantity 2): The contractor shall deliver hammer tackers, the hammer tackers must accept and be able to use 1/2 in T50 staples and must be housed within a chromed steel body with a rubber or synthetic grip. All internal components must be constructed of steel.

3.1.7 T50 Stainless Steel Staples 1,000 per package (Quantity 3): The contractor shall deliver three packages, 1000 quantity each, of ½ inch width by ½ inch leg length T50 staples. The staples are to be constructed of corrosion resistant stainless steel.

3.1.8 #12 Wood to Metal Screws, 200 per package (Quantity 6): The contractor shall deliver #12 2 ¾ inch long self-drilling wood to metal screws. The screws must be self-drilling and self-tapping into metal. The screws must possess a countersunk type screw head that is capable of seating flush to the wood surface and use a torque style (T25 or T30) bit. The screws must possess a corrosion resistant coating. The contractor shall provide 10 impact duty screwdriver bits that fit the screws provided and that fit a ¼ inch impact driver as a part of this proposal.

3.1.9 #12 External Hex Head Washer Roofing Screws 1 inch Length, 360 per package (Quantity 9): The contractor shall deliver #12 self-drilling external hex head drill point screws. The screws must be 1 in. in length and possess a self-sealing neoprene washer. The screws must have a corrosion resistant coating and utilize a 5/16 inch hex head drive. The screws must match the color of the 29-gauge steel roofing panels. The contractor shall provide 10 impact duty screwdriver bits that fit the screws provided and that fit a ¼ inch impact driver as a part of this proposal.

3.1.10 Pneumatic Framing Nail Gun (Quantity 1): The contractor shall provide a pneumatic 21-degree framing nail gun as a part of the contract. The nail gun shall be capable of accepting 2 inch to 3 ½ inch nails ranging in diameter from .113 inch to .148 inch. The nail gun must possess a sequential firing safety system.

3.1.11 2 inch Ring Shank Exterior Galvanized Nails (Quantity 5,000): The contractor shall provide 2 inch x .113-Gauge ring shank nails. The nails shall be 21-degree plastic collation and possess a galvanized finish. The nails must be able to be used in the pneumatic framing nail gun listed above.

3.1.12 29 Gauge Galvanized Steel Ridge Cap Flashing (Quantity 7): The contractor shall provide 10 feet sections of 29-gauge galvanized steel ridge cap flashing. The flashing must be compatible for use with the tuff rib configuration roofing panels and be constructed of grade 50 steel. Ridge cap flashing color must match that of the 29-gauge galvanized steel roofing panels listed above.

3.1.13 Self-Adhering Ridge Cap Venting Material 20 foot roll (Quantity 8): The contractor shall provide 20 foot rolls of self-adhering ridge cap venting material that is 1.5 inch by 3 inch. The venting material must not absorb moisture and be flame resistant. The venting material must possess a minimum tensile strength of 16 psi. The venting material must possess a 40-year limited warranty.

3.1.14 Metal Roof Sealant Cartridges (Quantity 20): The contractor shall provide 9.5 ounce cartridges of translucent exterior metal roof sealant. The sealant must establish a permanent and flexible watertight seal. The sealant must be capable of adhering to Kynar coated metals. The sealant must be UV resistant, and it must also contain no solvents or isocyanates. The sealant must be 100 percent solids and have a full cure time no longer than 24 hours.

3.1.15 #12 External Hex Head Washer Roofing Screws 1.5 inch. Length (150 QTY): The contractor shall deliver #12 self-drilling external hex head drill point screws. The screws must be 1.5 inches in length and possess a self-sealing neoprene washer. The screws must have a corrosion resistant coating and utilize a 5/16 inch hex head drive. The screws must match the color of the 29-gauge steel roofing panels.

3.1.16 29 Gauge Eave Flashing 10 Foot Length (Quantity 15): The contractor shall provide 10ft. sections of 29-gauge eave flashing. The flashing must have a minimum nail edge width of 3.75 inch and a minimum drip edge width of 3.75 inch. The flashing must match the color of the 29-gauge steel roofing panels. The flashing must be constructed of grade 50 steel.

3.1.17 29 Gauge Gable Flashing 10.5 Foot Length (Quantity 12): The contractor shall provide 10.5 foot sections of 29-gauge galvanized steel gable flashing. The flashing must be compatible for use with the tuff rib configuration roofing panels and be constructed of grade 50 steel. The gable flashing color must match that of the 29-gauge galvanized steel roofing panels listed above.

3.1.18 Inside Closure Strip Foam (Quantity 50): The contractor shall provide pieces of inside closure strip foam intended to seal the lowermost eave panel of the 29-gauge steel roofing panels. The foam strips shall be constructed of a dense type polyethylene foam be compatible with the tuff rib metal configuration. The foam strips must be 3 feet in length to be compatible with the standard 3 foot coverage steel roofing panel. The foam strips shall be self-adhering.

3.1.19 #12 Roofing Nails 1 inch (2 pounds): The contractor shall provide #12 1inch electro-galvanized roofing nails. The nails must be a of steel construction, possess a diamond point, and have an oversize head.

4.0 SUBMITTALS

4.1 PRE-AWARD SUBMITTALS

5.0 WARRANTY

Each item shall be covered by the manufacturer's standard warranty.

6.0 SHIPMENT AND DELIVERY

All items shall be delivered FOB to Dworshak Project within eight weeks of contract award. The Contractor shall be responsible for packing and shipping the components in a manner that will preserve seal integrity and ensure undamaged and complete arrival to Dworshak Dam. Materials must be delivered in a manner that they can be offloaded with the use of load handling equipment such as a forklift. Deliveries shall only be made during normal Dworshak Project business hours, Monday–Thursday 6:30AM–4:00PM, excluding federal holidays. The contractor shall coordinate delivery with the Contract Performance Specialist as to the actual location of delivery.
