**PERFORMANCE WORK STATEMENT
COORDINATOR OF RELIGIOUS EDUCATION ROMAN CATHOLIC-MCB HAWAII
KANEOHE BAY DUTIES AND RESPONSIBILITIES**

1. COORDINATOR OF RELIGIOUS EDUCATION ROMAN CATHOLIC (CRE)

The Catholic Coordinator of Religious Education (CRE) works under the Roman Catholic Director of Religious Education (Catholic DRE) who is the Roman Catholic Chaplain, or contracted priest approved through the Archdiocese for the Military Services (AMS). The Catholic CRE shall plan, execute and supervise a comprehensive program for Catholic Religious Education for MCB Hawaii, Kaneohe Bay. This contract is primarily to support the Roman Catholic Religious Education Program. It also includes working with other CRE's and DRE's on interdenominational and interfaith religious education events as directed by the Catholic DRE. The base contracts Period of Performance will be March 2023 through March 2024. There are various events to plan and execute through out the year that include First Communion, Confirmation, First Reconciliation programs, a retreat for Confirmandi, vacation Bible school during the month of May, with instruction to parishioners commencing in August of 2023. The total term of this contract is 18 months, which consists of the 12 month base period followed by the 6 month option period.

Qualifications

The Coordinator shall:

- Be able to show a strong working knowledge of the tenants of faith of the Roman Catholic community and understand the requirements for support of children, youth and adults onboard military installations;
- Be an active member of a Catholic Community and have working knowledge in the Roman Catholic Faith, and must have experience in working with the Catholic community. This determination is made by the Catholic DRE. The CRE must be a practicing and confirmed Catholic, who is in good standing with the Catholic Church.
- Possess a Bachelor's Degree in education or have experience with Catholic children's religious education programs. The CRE shall have at least two years of experience as a Catholic Religious Education Coordinator or related field within the past 5 years.
- The Candidate must possess a valid and current Catechist Certification issued through the Archdiocese for the Military Services, USA.

Requirements

The Coordinator (CRE) shall:

1. Recruit, train, assign, and supervise volunteer teachers and helpers in the Catholic Religious Education Program for children, youth and adults as directed by the Catholic DRE, and assist catechists to become trained and certified by the AMS as required,
2. Must furnish a resume as part of proposal showing education, experience and personal and professional References (3). The resume or cover letter must address all areas of the Performance Work Statement (PWS).

3. Provide timely submission and follow up on necessary paperwork for the procurement of supplies, literature and curriculum needed for the program;
4. Schedule class rooms and other spaces with enlisted chapel personnel to support Religious Education and other related programs;
5. Arrange through the DRE for audio visual and other equipment as needed;
6. Ensure accurate records of attendance are maintained and in accordance with the GSA Rules of Behavior for Handling Personally Identifiable Information (PII).
7. Maintain communication and information flow with parents and families of the students, to include a family handbook with a calendar of events, periodic Catholic bulletin announcements, and Parent Preparation Meetings for parents of children receiving Sacraments, and other activities as assigned by the Catholic DRE;
8. Coordinate all programs under the direction of the Catholic DRE, including possible Vacation Bible School program (01 MAY-30 MAY), keeping the Catholic DRE informed of the status of programs, future scheduling and any problems that may arise
9. Attend regularly scheduled chapel council meetings and other meetings as required by the Catholic DRE;
10. Estimate time to complete required responsibilities to be approximately fifteen (15) hours/units per week. At minimum 12 of those hours at the chapel during working hours Monday through Thursday 0830-1530. The CRE will submit a log sheet each week to the DRE in order to keep accountability.
11. Coordinate with the DRE and the Archdiocese for the Military Services, USA regarding the Curriculum to be used.
12. Plan and execute the formation of First Communion, Confirmation, First Reconciliation programs and retreat for Confirmandi.
13. Coordinate with the Chapel staff in initiating annual background checks on all teachers and assistants over 18 years of age.
14. Provide initial and annual orientation and training for program volunteers.
15. Shall be present at the Chapel when classes are in session, to provide for administrative needs of students, teachers and parents.
16. Coordinate a Catholic religious educational program that can be offered digitally and remotely in the event that in-person RE program may need to be suspended.
17. Monitor all RE equipment and report missing or broke equipment to the DRE.
18. Prepare correspondence relating to RE for DRE and submit for typing and mailing as directed by DRE
19. Ensure sacramental records are submitted to the AMS, USA.

20. Ensure preparation of certificates, awards and presentations for students and staff
21. Maintain a continuity file of significant events and operation procedures.
22. Maintain RE enrollment and attendance records using prescribed forms and submit to DRE
23. Maintain a professional, courteous relationship with Chaplain Corps Staff, other contractors, volunteers and other military and civilian agencies.
24. Provide for teacher training sessions and other staff meetings as needed.
25. Ensure one trained catechist per classroom and one parent present at all time during class.
26. Be able to work with the Protestant RE coordinator on any ecumenical projects deemed appropriate by the DRE.
27. A federal background check shall be performed as the contractor will have contact with individuals under the age of 18. This is directed by NoDI 1402.5, *Criminal History Background Checks on Individuals in Child Care Services*.
28. Knowledge and experience as an Administrative Assistant is required.
29. Submit purchase requests to the LPO at least 15 days ahead of the event to ensure timely completion.

Contractor shall make arrangements, and:

- Must provide personal transportation to and from the work center to meet the requirements of the agreement.
- Maintain duty hours as coordinated with the DRE, 15 hours/units, and at least 12 of these hours/units be in the office hours (Monday-Thursday 0730-1530)
- Attend meetings during office duty hours as coordinated with the DRE is required. Meeting attendance hours is part of the 15 hours.
- Attend other meetings or special activities outside the normal office duty hours may be required as scheduled by the DRE such as Vacation Bible School and other special activities.
- The CRE is not required to attend Catholic Mass on base on Sundays, although, if they do choose to attend Mass on Base on Sundays, those hours will be considered billable, but the CRE must be present for religious education sessions at their regularly scheduled time. The CRE is welcome to participate in social and fellowship events associated with the chapel, but these hours are not billable, unless the CRE participation in these events directly supports the Catholic RE program.
- The CRE shall fulfill the requirement for a Catechist and Religious Education Coordinator set forth by the Archdiocese for the Military Services, USA.

The Government (Catholic DRE) shall:

Reserve the right to make final decisions on matters affecting the religious education program such as the selection of curriculum, selection of volunteer teachers, and the cessation or implementation of programs and activities.

Provide direction, advice, guidance, and support to the Catholic Coordinator of Religious Education in the performance of his/her duties.

Review performance of the contractor and submit to Contracting Officer (COR) via the Command Chaplain.

2. SUPPLIES/MATERIALS

The Government will provide all necessary supplies and materials to the Contractor. Nevertheless, the Contractor may submit requests for service-related material that he/she feels will enhance the service. Such requests will be submitted to the appropriate chaplain/(COR), who will be solely responsible for approving or disapproving them. All requests are subject to availability of Government funds and thus may not be approved. Failure on the part of the Government to approve any such request does not relieve the Contractor from performing duties stipulated in this contract unless the supplies needed are necessary to run the specific program.

- Items purchased with Government funds at the request of the Contractor remain the property of the Government.

3. LEAVE AND TEMPORARY ABSENCE

- The Contractor shall notify the Catholic DRE at least ten (10) working days in advance for planned absences. In the event of illness or emergency leave, the Contractor shall inform the Catholic DRE as soon as the situation becomes known.
- Regardless of the reason for absence, the Contractor shall remain solely responsible for ensuring the performance of all work required by this contract is accomplished. Therefore, the Contractor shall ensure that a qualified and suitable replacement is provided in a timely manner. Additionally, the Contractor shall be responsible for ensuring the replacement is knowledgeable of the requirements of this contract. Finally, the Contractor shall be personally responsible for paying the replacement for services provided.
- The Government will not be responsible for ensuring that a replacement for the Contractor is obtained or if that person is financially compensated for services rendered. No one other than the Contractor shall be paid directly from MCB Hawaii Kaneohe Bay's appropriated funds. Any replacement provided by the Contractor shall not be authorized to submit invoices for services rendered.

4. PAYMENT

The Contractor shall submit an invoice electronically through the Wide Area Workflow system for certification of services rendered during the first (1st) week of the next month following end of the month in which the services were rendered.

5. BASE PASSES

The Contractor shall submit a request for base pass to MCB Hawaii Contracting Office for approval by the Contracting Officer. Upon approval, the Contractor shall hand-carry the request to the Pass and Identification Section. The contractor shall be responsible for all passes issued to him under this contract. The Contractor shall return all applicable base passes upon termination of employment or completion of this contract to the Pass and Identification Section and certification or receipt shall be obtained. The contractor shall submit letter of termination to the Contracting Office within seven (7) days of the effective date.

52.204-24 REPRESENTATION REGARDING CERTAIN TELECOMMUNICATIONS AND VIDEO SURVEILLANCE SERVICES OR EQUIPMENT (NOV 2021)

The Offeror shall not complete the representation at paragraph (d)(1) of this provision if the Offeror has represented that it "does not provide covered telecommunications equipment or services as a part of its offered products or services to the Government in the performance of any contract, subcontract, or other contractual instrument" in paragraph (c)(1) in the provision at 52.204-26, Covered Telecommunications Equipment or Services-- Representation, or in paragraph (v)(2)(i) of the provision at 52.212-3, Offeror Representations and Certifications- Commercial Products and Commercial Services. The Offeror shall not complete the representation in paragraph (d)(2) of this provision if the Offeror has represented that it "does not use covered telecommunications equipment or services, or any equipment, system, or service that uses covered telecommunications equipment or services" in paragraph (c)(2) of the provision at 52.204-26, or in paragraph (v)(2)(ii) of the provision at 52.212-3.

(a) Definitions. As used in this provision-

Backhaul, covered telecommunications equipment or services, critical technology, interconnection arrangements, reasonable inquiry, roaming, and substantial or essential component have the meanings provided in the clause 52.204-25, Prohibition on Contracting for Certain Telecommunications and Video Surveillance Services or Equipment.

The Offeror shall provide the additional disclosure information required at paragraph (e)(2) of this section if the Offeror responds "does" in paragraph (d)(2) of this section.

(e) Disclosures.

(1) Disclosure for the representation in paragraph (d)(1) of this provision. If the Offeror has responded "will" in the representation in paragraph (d)(1) of this provision, the Offeror shall provide the following information as part of the offer:

(i) For covered equipment--

(A) The entity that produced the covered telecommunications equipment (include entity name, unique entity identifier, CAGE code, and whether the entity was the original equipment manufacturer (OEM) or a distributor, if known);

(B) A description of all covered telecommunications equipment offered (include brand; model number, such as OEM number, manufacturer part number, or wholesaler number; and item description, as applicable); and

(C) Explanation of the proposed use of covered telecommunications equipment and any factors relevant to determining if such use would be permissible under the prohibition in paragraph (b)(1) of this provision.

(ii) For covered services--

(A) If the service is related to item maintenance: A description of all covered telecommunications services offered (include on the item being maintained: Brand; model number, such as OEM number, manufacturer part number, or wholesaler number; and item description, as applicable); or

(A) If the service is related to item maintenance: A description of all covered telecommunications services offered (include on the item being maintained: Brand; model number, such as OEM number, manufacturer part number, or wholesaler number; and item description, as applicable); or

(B) If not associated with maintenance, the PSC of the service being provided; and explanation of the proposed use of covered telecommunications services and any factors relevant to determining if such use would be permissible under the prohibition in paragraph (b)(2) of this provision.

(End of provision)

52.212-1 INSTRUCTIONS TO OFFERORS--COMMERCIAL PRODUCTS AND COMMERCIAL SERVICES (NOV 2021)

(a) North American Industry Classification System (NAICS) code and small business size standard. The NAICS code(s) and small business size standard(s) for this acquisition appear elsewhere in the solicitation. However, the small business size standard for a concern that submits an offer, other than on a construction or service acquisition, but proposes to furnish an end item that it did not itself manufacture, process, or produce is 500 employees if the acquisition--

(1) Is set aside for small business and has a value above the simplified acquisition threshold;

(2) Uses the HUBZone price evaluation preference regardless of dollar value, unless the offeror waives the price evaluation preference; or

- Letter of recommendation from a Chaplain or Priest
- A narrative supporting professional knowledge of the tenants of faith of the Catholic community and understands the requirements for religious support of children, youth and adults of the different Catholic denominations onboard military installations.

Past Performance. The Government may use past performance information from sources other than those provided by the quoter, such as The Robotic Process Automation (RPA) “bot” for prospective contractor responsibility or non-responsibility which will be accessed to determine that the prospective contractor is a responsible contractor for an award.

Price. - (1) PSC 5510, Lumber and Related Basic Wood Materials;
- (2) Product or Service Group (PSG) 87, Agricultural Supplies;
- (3) PSG 88, Live Animals;
- (4) PSG 89, Subsistence;
- (5) PSC 9410, Crude Grades of Plant Materials;
- (6) PSC 9430, Miscellaneous Crude Animal Products, Inedible;
- (7) PSC 9440, Miscellaneous Crude Agricultural and Forestry Products;
- (8) PSC 9610, Ores;
- (9) PSC 9620, Minerals, Natural and Synthetic; and
- (10) PSC 9630, Additive Metal Materials.

“Place of manufacture” means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

“Predecessor” means an entity that is replaced by a successor and includes any predecessors of the predecessor.

“Reasonable inquiry” has the meaning provided in the clause 52.204-25, Prohibition on Contracting for Certain Telecommunications and Video Surveillance Services or Equipment.

“Restricted business operations” means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate--

"Small business concern"--

(1) Means a concern, including its affiliates, that is independently owned and operated, not dominant in its field of operation, and qualified as a small business under the criteria in 13 CFR part 121 and size standards in this solicitation.

(2) Affiliates, as used in this definition, means business concerns, one of whom directly or indirectly controls or has the power to control the others, or a third party or parties control or have the power to control the others.
