## B.3 STATEMENT OF WORK

### Clean & Clear Central Texas Veterans Buildings

This statement of work (SOW) defines the actions for the contractor to provide parts, perimeter barriers, labor, material, manpower, haul off services for the cleaning removing, sweeping the following buildings at the VA Waco, TX Campus, Building 1,8, 17, 226, with trash removal at the Bryan-College Station and Austin Clinics. #### 1. Scope of Work

#### 2. Period of Performance: 15 Days.

#### 3. Contracting Tasking/Requirements

- A. The Contractor shall designate an on-site supervisor, who will require a cell phone or other means of communication. The designated supervisor will coordinate each moving service activity with the Contracting Officer's Representative (COR) and designated station

staff. The designated supervisor will be responsible for directing the activity of crew members.

- B. The Contractor shall provide sufficient personnel/crews, based on workload. The Contractor shall ensure all crew members are physically able to perform all duties required by this contract.
- C. The work shall be performed as scheduled to minimize disruption of patient care.

#### 4. Risk Control, Infection Control and Safety Measures

- A. Personnel Protective Equipment (PPE), i.e., safety boots, gloves, etc. for contractors are to be worn when completing task identified
- B. All Personnel are also expected to be educated on safe laborer and moving practices prior to the start of a job.
- C. Removal of waste and/or excess materials is the responsibility of the contractor. Contractor will be required to clean up after installation when dust and/ or debris from drilling is created. This includes vacuuming surrounding area and wiping down furniture.
- D. CTVHCS properties are professional medical facilities. Contractors must follow CTVHCS policies. This includes the nonsmoking mandate on each property.
- E. Contractor may be required to coordinate with partner services such Facilities Management, Information Technology, Environment Management, and Supply Chain Management. Contractor will consult with COR/POC for direction relating to coordination efforts and for events not resolvable on site.

- (9) PSC 9620, Minerals, Natural and Synthetic; and
- (10) PSC 9630, Additive Metal Materials.

*Place of manufacture* means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

*Predecessor* means an entity that is replaced by a successor and includes any predecessors of the predecessor.

*Reasonable inquiry* has the meaning provided in the clause 52.204–25, Prohibition on Contracting for Certain Telecommunications and Video Surveillance Services or Equipment.

*Restricted business operations* means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of

By submission of its offer, the Offeror represents that it will not require its employees or subcontractors to sign or comply with internal confidentiality agreements or statements prohibiting or otherwise restricting such employees or subcontractors from lawfully reporting waste, fraud, or abuse related to the performance of a Government contract to a designated investigative or law enforcement representative of a Federal department or agency authorized to receive such information (e.g., agency Office of the Inspector General).

(v) *Covered Telecommunications Equipment or Services—Representation.* Section 889(a)(1)(A) and section 889(a)(1)(B) of [Public Law 115-232](#).

(1) The Offeror shall review the list of excluded parties in the System for Award Management (SAM) (<https://www.sam.gov>) for entities excluded from receiving federal awards for “covered telecommunications equipment or services”.

(2) The Offeror represents that—

(i) It  does,  does not provide covered telecommunications equipment or services as a part of its offered products or services to the Government in the performance of any contract, subcontract, or other contractual instrument.

(ii) After conducting a reasonable inquiry for purposes of this representation, that it  does,  does not use covered telecommunications equipment or services, or any equipment, system, or service that uses covered telecommunications equipment or services.
