Purchase of HP Proactive 24x7 Care and Defective Media Retention (DMR) Service which includes support of hardware systems, parts and materials necessary to maintain the product in good operating condition. The operating systems software and integrated software (e.g. firmware) are in the AFLOA server room located on Maxwell Air Force Base.

HPE Post Warranty support is required to maintain AFLOA's existing HPE equipment. No other brand name post warranty support can provide the maintenance, replacement, and on-site support provided by HP Proactive 24x7 Care and Defective Media Retention (DMR) Service. Further, since 2016 AFLOA has invested [REDACTED] in HPE hardware to include servers, blade servers systems, network storage arrays and backup storage systems and this money cannot be recouped. To replace this HPE equipment with another brand name at today's pricing would cost an estimated [REDACTED] It is therefore most cost effective to the Government to purchase HPE Post Warranty support for this equipment.
