PURCHASE DESCRIPTION

1.0 INTRODUCTION

The room has been having issues latching and locking. When an individual attempts to arm the alarm, issues have been happening on the lining up the IDS.

2.0 BACKGROUND

NAVSEA Washington Navy Yard (WNY) Building 22, 3rd floor and 4th floor, will need the current existing doors replaced will shall be in accordance with DoD5200.01 Vol 3, Enclosure 2. The door and frame will be built in accordance with the Intelligence Community Directive (ICD) 705. The standard lock shall meet Federal Specification FF-L-2740B. All entrance shall be in accordance with the Americans with Disabilities Act Accessibility Guidelines (ADA-AG) and built to code of the Authority with Jurisdiction.

3.0 SCOPE

Acquire contract services for design and construction to modify entry to the rooms on both floors. This project must meet the required regulations mentioned in Paragraph 2.0 of this Performance Work Statement (PWS).

5.0 REQUIREMENTS

5.1 General

Acquire contract services for design and construction for the entrances on the 3rd and 4th floor of Building 22 at the NAVSEA Washington Navy Yard.

5.2 Door

The Contractor shall provide and install a door shall be made of metal with door dimensions measuring 3' (L) x 7' (H) x 1 3/4" (W).

The door shall be at least 18 gauge and reinforced to 10 gauge where the lock will be located.

The door rating shall meet ANSI/SDI A250.08 or ANSI/SDI A250.04 for physical performance and be at least Level 2, and Physical Performance Level B (see PWS, Paragraph 4.0, ODNI, for further guidance).

5.3 Hard Ware

The Contractor shall ensure each of doors' hardware comply and follow the standards of FF-L-2890B (see PWS, Paragraph 4.0, PGSA, for further guidance).

The door assembly shall meet Builders Hardware Manufacture Association (BHMA) Grade 1 (see PWS, Paragraph 4.0, ODNI, for further guidance).

The door hardware should match the general building hardware to the best extent practical; this includes butt hinges style, closer type and style, stops, lock and set lever style trim style.

5.4 Door Frame

Frames styles that are authorized may include all readily available welded types such as wrap around (masonry or drywall) figure or install new components to the fire alarm and or suppression systems as required for proper distribution.

The frame shall not be a "knocked down type" and shall be installed prior to stud installation.

5.5 Wall

The wall shall be built from permanent construction material; plaster, gypsum wallboard, metal panels, hardboard, wood, plywood or other material offering resistance to and evidence of unauthorized entry into the area.

The wall must extend from true floor to true ceiling.

The wall shall be painted to match the current existing wall color.
